- 2. <u>ORAL COMMUNICATIONS PUBLIC:</u> (To be held simultaneously with Agency and Sanitary District Oral Communications.)
 - 2.a. Daniel Flores addressed the City Council, requesting a waiver of a \$5,000 fee for a public hearing to request approval of a permit for an addition to his two-bedroom home on Emerson Street. (F: 53.3) (XR: 35.1)

<u>ACTION</u>: Staff to investigate and report back to the City Council about this situation; and contact Mr. Flores relative to the procedures.

- 2.b. Beatrice Jones addressed the City Council concerning Black History Month, noting that this year the theme is The Niagara Movement, Black Protest Reborn. She shared information concerning the historical background of this event and invited everyone to attend the Citizens of Distinction Awards banquet on February 26. (F: 53.3)
- 2.c. Verla Lambert addressed the City Council concerning an automobile accident she was involved in on January 26, expressing concern that the police will come to the scene of an accident only if someone is injured. (F: 53.3) (XR: 82.1)

<u>ACTION</u>: Mayor Dalton indicated that most cities no longer take accident reports at scenes of non-injury automobile accidents.

2.d. Ana Meyer addressed the City Council, requesting a waiver of fees for use of the Showmobile and waiver of additional personal property insurance fees for the use of the Showmobile and parade in conjunction with the West Garden Grove Little League Opening Ceremonies on March 5. <u>ACTION</u>: Discussed. Direction given to discuss use of the Pacific Electric Right-of-Way, Measure M funds, and Turn Back funds at the Study Session on March 29. Also, invite an OCTA representative to attend.

- 9.e. Suggestion by Council Member Leyes to look at the volunteer base in the city relative to park maintenance, along with an Adopt a Park program, to augment the existing park maintenance contractor. He noted that George Brietigam came up with a proposal to figure out some of the capital needs at any City facility and develop that list and post it perhaps on the City web site so any group, such as the Eagle Scouts, that wants to do a service project on a volunteer basis can adopt a project. - 9.f. Council Member Leyes volunteered for a High Technology subcommittee of the City Council that could work with staff and brainstorm ideas on how to take advantage of some of the emerging technologies and even coordinate with neighboring cities on this. - 9.g. Council Member Leyes spoke about the Cypress Americana Awards event on February 26, congratulating his wife Wanda as a past recipient of this award. (F: 53.1)
