Lastly, he suggested that the issue of improving Main Street be discussed at a future date, suggesting perhaps the focus be changed to encourage office professional uses there. He also wished his wife Wanda a Happy Anniversary and a Happy Birthday. (F: 53.1)
- 10.b. Council Member Rosen wished his wife Sandy a Happy Anniversary. He asked that he be provided with reports concerning the following matters: (1) Legal issues concerning Coastkeepers; (2) Breakdown of personnel items in the proposed City budget dealing with salaries, medical insurance, and contributions to pension plans; (3) OCTA Access program and the possibility of using the Senior Center as a drop-off point; and (4) Noise from cars on Main Street on Friday nights that interferes with the Shakespeare Theater productions.
