4.b. Janet Williams and Ngoc Lam addressed the City Council concerning prostitution and drug problems in their neighborhood on Quatro in the Harbor Boulevard area. (F: 53.3) (XR: 82.1)

He also commented on the annual Korean Festival that takes place next weekend, further commenting that because of development here, this may be the last festival to be held here. Lastly, he reminisced about the 1992 riots that took place in Los Angeles and how he diffused a very anxious situation involving our Korean business people who were fearful that they would be attacked here. - 11.b. Council Member Rosen requested a report on how the City would spend \$100,000 given by OCTA to connect the Metrolink. He also requested a report concerning the maintenance of the soccer rink north of the new gymnasium. (F: 53.1) (XR: 23.18F) (XR: 24.1)
- 11.c. Council Member Nguyen commented that she hopes the Korean Festival does not leave Garden Grove. She spoke about Michael Monsoor, a Garden Grove High School graduate who lost his life in Iraq fighting for our country. (F: 53.1) (XR: 42.7A) (XR: 46.9)
- 11.d. Council Member Krebs commented on a seminar, "Suicide by Cops," held last Wednesday about suicidal people who try to provoke police into killing them. (F: 53.1)
- 11.e. Mayor Dalton spoke about Michael Monsoor and spoke briefly about his short life here in Garden Grove. He also announced the passing of John Passanisi, previously involved in the Historical Society; and long-time resident Tony Bergin. (F: 53.1) (XR: 46.9)
