INVOCATION AND PLEDGE

Public Works Director, Keith Jones, gave the Invocation. Council Member Rosen led the Pledge of Allegiance to the Flag of the United States of America.

PRESENTATIONS (F: 62.2)

Dave Simpson, Manager, Local Government Relations, Orange County Transportation Authority, provided an update on the status of the SR 22 and the Renewed Measure M.

ORAL COMMUNICATIONS - PUBLIC

Rob Gleason addressed the City Council, expressing appreciation that the City Council will allow non-profit organizations to continue to sell safe and sane fireworks as a fundraiser. (F: 53.3) (XR: 61.6)

Reese Nguyen, representing Assemblyman Jose Solorio, addressed the City Council, conveying the appreciation of Assemblyman Solorio for listing AB 823 on the City Council agenda for an expression of support. (F: 53.3) (XR: 67.5)

Ray Littrell addressed the City Council, congratulating Janet Nguyen for her successful campaign for County Supervisor. He spoke about the appointment of a new Council Member to fill her vacancy. (F: 53.3)

David Vill addressed the City Council concerning the fireworks issue, commenting that there are not enough public safety officers to enforce the fireworks ordinance, and more street lights are needed to enable the officers to better see the illegal activities that are occurring. He also asked for further dialog on the issue. (F: 53.3) (XR: 61.6)

Charles Mitchell addressed the City Council, asking that the meeting be adjourned in memory of a long-time American Legion member, Betsy Ross Pigg. He congratulated Janet Nguyen on her victory, and he thanked staff for putting City Commission material on the website. Lastly, he urged the City Council to consider those individuals who ran for City Council in the November election in the selection of an individual to fill the City Council vacancy created by former Council Member Janet Nguyen's victory to the seat of County Supervisor of the First District. Tony Flores addressed the City Council, expressing appreciation for the City Council's action to continue to allow the sale of safe and sane fireworks. He asked that former City Council Member Harry Krebs be appointed to fill the City Council vacancy, referencing the 1990 Advisory Ballot Measure, noting that if Mr. Krebs is not appointed, he would ask the City Council to appoint him, Tony Flores. David Lautherboren addressed the City Council urging support of the U.S. Veterans. He also noted that he hopes OCTA institutes the modification of the diamond lane on the 22 Freeway. (F: 53.3)

Russ McDonald addressed the City Council, urging that safe and sane fireworks be abolished in the city. (F: 53.3) (XR: 61.6)

<u>SP-418-07</u>, initiated by Hung The Quach, M.D., requesting to construct an 18-unit condominium development on a 47,619 square foot lot located at 14051 and 14061 Hope Street.

On March 1, 2007, the City Planning Commission adopted a Negative Declaration and approved SP-418-07, V-154-07 for a reduced setback request, and Tentative Tract Map No. TT-17130. A condition was included that required the applicant to create the Code-required guest parking on site. Additionally, staff was directed to work with the applicant on the upper floor window locations.

Pursuant to Legal Notice published March 15, 2007, public hearing on the case was ordered by the City Council to be held this date.

Staff report dated March 27, 2007, was introduced, and staff reviewed the background information concerning this project.

Mayor Pro Tem Rosen reviewed AB 823 and suggested the City Council take a position of support for this bill.

It was moved by Council Member Broadwater, seconded by Council Member Nguyen, and carried by unanimous vote, that the City Council go on record as taking a position of support for AB 823.

CONSIDERATION OF APPOINTMENT TO FILL THE VACANCY ON THE CITY COUNCIL (F: 46.1)

Staff report dated March 27, 2007, was introduced, providing a summary of the applicable procedures and legal rules for filling the City Council vacancy.

Mayor Pro Tem Rosen commented on the process recently followed by the City of Aliso Viejo to fill a City Council vacancy.

He indicated that anyone interested in applying for the position and is willing to campaign for it next year should contact a Council Member. He noted that four or five people have already contacted him indicating their interest.

Mayor Dalton noted that several people have also contacted him, and he will be adjourning this meeting to March 29 to discuss the matter.

Council Member Nguyen commented that the People should elect their representative. She would have been in favor of holding a Special Election; however, she will go along with the appointment process.

Those interested in applying for the position should contact the City Council by March 29 and attend the City Council meeting on that date.

MATTERS FROM THE MAYOR AND CITY COUNCIL MEMBERS
