### GARDEN GROVE CITY COUNCIL

A Regular Meeting of the City Council of the City of Garden Grove was called to order in the Council Chamber of the Community Meeting Center, 11300 Stanford Avenue, on Tuesday, November 28, 2006, at 7:13 p.m.

## INVOCATION AND PLEDGE

Assistant City Manager Les Jones gave the Invocation. Council Member Leyes led the Pledge of Allegiance to the Flag of the United States of America.

## ORAL COMMUNICATIONS - PUBLIC

Steve Larson, President of the Sister City Association, thanked the City Council for its support over the last 20 years and announced that students from Anyang, Korea, will be visiting the first part of January; Mr. Larson provided information on the upcoming fundraising luncheon. Leland Sisk addressed the City Council urging the City to adopt the County's policy relative to animal complaints, such as barking dogs, giving that authority to the Animal Control officers who can work with people with barking dogs. In response to Council Member Rosen's inquiry, the City Attorney indicated that if the City wants to participate with the County on this policy a corollary ordinance would need to be adopted.

(F: 116.PUD-113-06)

<u>Planned Unit Development No. PUD-113-06, Development Agreement, and Adoption of a Negative Declaration, initiated by Olson Urban Housing, LLC, is requesting to rezone the 3.8-acre site to Residential Planned Unit Development. Also requested is approval of a Development Agreement and a Negative Declaration for the project.</u>

On August 3, 2006, pursuant to Resolution No. 5564, the City Planning Commission recommended approval of Planned Unit Development PUD-113-06 and a Development Agreement. Pursuant to Legal Notice published November 16, 2006, public hearing on the case was ordered by the City Council to be held this date.

Staff indicated the applicant has withdrawn his application.

It was moved by Council Member Leyes, seconded by Council Member Krebs, and carried by unanimous vote, that All American Asphalt, be and hereby is determined to be the lowest acceptable bidder in connection with the 2006-07 and 2007-08 Street Rehabilitation Overlay, and that contract for said project be and hereby is awarded to said company in the sum of \$944,449.40 for fiscal year 2006-07, and \$829,664.76 for fiscal year 2007-08, for a total of \$1,774,114.16, in accordance with the terms of the City's plans and specifications and the bid submitted by said company;

It was moved by Council Member Krebs, seconded by Council Member Krebs, and carried by unanimous vote, that JMA Construction Company be and hereby is determined to be the lowest acceptable bidder in connection with Project No. 7264-D, Garden Grove Boulevard Median Improvements from Harbor Boulevard to Haster Street, and contract for said project be and hereby is awarded to said company in the sum of \$857,900, in accordance with the terms of the City's plans and specifications and the bid submitted by said company; that all other bids be and hereby are rejected; and the City Manager and City Clerk are authorized to execute said contract.

AWARD OF CONTRACT TO JMA CONSTRUCTION COMPANY FOR GARDEN GROVE BOULEVARD MEDIAN IMPROVEMENTS FROM FERN STREET TO MAGNOLIA STREET, PROJECT NO. 7264-C (F: 96.proj.7264C)

Staff report dated November 28, 2006, was introduced and reviewed by staff.

Council Member Rosen raised concerns about limiting the number of accesses to the parking lot and the danger of increasing the number of U-turns needed.

Council Member Leyes praised staff on the engineer estimates, commenting that the estimate was within 1 percent of the lowest bidder.

Council Member Leyes moved, seconded by Council Member Krebs, that JMA Construction Company be and hereby is determined to be the lowest acceptable bidder in connection with Project No. 7264-C, Garden Grove Boulevard Median Improvements from Harbor Boulevard to Haster Street, and contract for said project be and hereby is awarded to said company in the sum of \$857,900, in accordance with the terms of the City's plans and specifications and the bid submitted by said company; that all other bids be and hereby are rejected; and the City Manager and City Clerk are
