Ray Littrell addressed the Agency concerning Site B-2, Palm Court, inquiring whether that is considered "responsible redevelopment." (F: A-53.3)

Tony Flores addressed the Agency, suggesting that a multi-cultural center be considered instead of a Vietnamese Cultural Center, noting that residents are living in fear of acquisition by eminent domain. He commented that the City's current ratio for park acreage to population is below its goal. And lastly, that there is a meeting of the West Garden Grove Residents Association tomorrow to talk about the flooding that occurred in west Garden Grove last month.
