- 2.a. Jim Shriver commented that he was not in favor of putting the trash bill on the property taxes. (F: S-53.3) (XR: S-60.1)
- 2.b. Bob Owens commented that he did not understand the letter that was sent regarding the sewer fees. (F: S-53.3) (XR: S-60.1)
- 2.c. Dawn Nielsen commented that the city has a very large number of senior citizens. It is very difficult for them to come up with that much money at Christmas time. She noted that although the letter stated there would be no fee increase, the trash bill went up this month. (F: S-53.3) (XR: S-60.1)
- 2.d. Nancy O'Shaughnessy commented that she was not in favor of the trash bill on the property tax bill. (F: S-53.3) (XR: S-60.1)
- 2.e. Sam Henson commented that he was against adding the trash bill to the property tax bill, noting that at Christmas it is very hard to come up with money to pay property taxes. It is easier to pay monthly. He noted that other cities include trash, water, and electricity on one bill. It is not logical to give the money to the County and then the City has to wait to get reimbursed. (F: S-53.3) (XR: S-60.1)
- 2.f. Peter Vuong commented that he is not in favor of adding the trash bill to the property taxes because his tenant pays the trash bill. Combining the bills would create more paperwork for him. (F: S-53.3) (XR: S-60.1)
- 2.g. Judith Swenson commented that she lives in the unincorporated area in Anaheim and pays her trash bill to Garden Grove. She was not in favor of adding the fees to the property taxes. She urged the City Council to consider the senior citizens on low income. (F: S-53.3) (XR: S-60.1)
- 2.h. David Ramsey commented that he does not want any more fees on his property tax bill. (F: S-53.3) (XR: S-60.1)
- 2.i. Barton Harlan commented that even though the trash bill is not a large amount of money, it is when added to the property taxes and collected in one payment. He questioned whether the trash bill would go down with the \$70,000 savings. If the savings reduces the trash bill, people would be more in favor of placing it on the property tax

- bill. He also commented that they were told that recycling would keep costs down. (F: S-53.3) (XR: S-60.1)
- 2.j. Charles Mitchell commented that no one likes to have taxes raised. The State will fine the District if a certain percentage of recycling is not met. He toured the recycling center and was amazed at how much is sorted out. He was not in favor of adding the trash bill to the tax bill. (F: S-53.3) (XR: S-60.1)
