AGREEMENT WITH THE ORANGE COUNTY SANITATION DISTRICT FOR GRANT FUNDING FOR A COOPERATIVE PROJECT FOR THE SEWER SYSTEM (F: S-55.9) (XR: S-97.1) (XR: 24.1)

Staff report dated December 12, 2006, was introduced.

It was moved by Member Rosen, seconded by Member Broadwater, and carried by unanimous vote, that Agreement #0602 by and between the Garden Grove Sanitary District (GGSD) and the Orange County Sanitation District (OCSD) for grant funding for a Cooperative Project for the GGSD sewer collection system, be and hereby is approved, in order to receive reimbursement in the amount of \$300,000 from OCSD; and the President and Secretary are authorized to execute the agreement.

PAYMENT TO THE MIDWAY CITY SANITATION DISTRICT FOR SHARED COST OF DESIGN SERVICES FOR JOINT USE SEWERAGE FACILITIES (F: 89.5) (XR: 92.1) (XR: 24.1)

Staff report dated December 12, 2006, was introduced and reviewed by staff.

It was moved by Member Janet Nguyen, seconded by Member Rosen, and carried by unanimous vote, that a payment of \$119,900 to the Midway City Sanitation District for shared cost of design services for joint use sewerage facilities, be and hereby is approved.
