## **NEW BUSINESS**

### **ADULT CROSSING GUARD REQUEST**

#### **Lampson Ave./Pleasant Pl.**

The staff report was introduced to consider a request to assign an adult crossing guard to the intersection of Lampson Avenue and Pleasant Place. It is recommended that the Traffic Commission receive public input and not approve assigning an adult crossing guard to the intersection of Lampson Avenue and Pleasant Place.

### **ORANGEWOOD AVENUE RE-STRIPING**

The staff report was introduced to propose re-striping Oranewood Avenue from Brookhurst Street to Euclid Street from two lanes in each direction to one lane and also to provide bike lanes and a two-way left turn lane.

#### **Concerns & Suggestions:**

- Traveling westbound on Oranewood at Euclid is two lanes and when motorists merge past the intersection it will become only one lane and make for a hazardous situation.
- Have a right turn only lane westbound at Euclid on Oranewood.

Zella Honeyford, 10421 Oranewood spoke in favor of the re-striping.

**RED CURB  
12011 WINTON STREET**

The staff report was introduced to paint red curb at 12011 Winton Street. It is recommended that the Traffic Commission receive public input and approve staff's recommendation to paint approximately 56 feet on Winton Street fronting 12011 Winton Street.

Chris Markley, 12011 Winton Street, spoke against painting red curb in front of his home.

**Concerns & Suggestions:**

- Sight visibility
- Code Enforcement has been out to speak to the resident about the issue
- Red curb will only front 12011 Winton Street and will not encroach into neighboring property.
- Install a stop sign at the 3 way stop of Winton and Chapman
