It was moved by Council Member Nguyen, seconded by Council Member Beard, and carried by unanimous that the City of Garden Grove's 2012 Investment Policy, be and hereby is approved; that John D.R. Clark be reappointed as City Treasurer, and Kingsley Okereke be reappointed as the Deputy City Treasurer; and the City Treasurer and Deputy City Treasurer are delegated the responsibility to invest or to reinvest City funds.

Staff report dated January 24, 2012, was introduced and reviewed by staff.

It was moved by Council Member Beard, seconded by Council Member Jones, and carried by unanimous vote that the contract for on-call traffic signal and street lighting maintenance and repair services, in the amount not to exceed \$300,000, be and hereby is awarded to Republic ITS; and the City Manager is authorized to execute the Agreement and make minor modifications as necessary on behalf of the City.

RESOLUTION APPROVING AN AFFORDABLE HOUSING AGREEMENT WITH TAMERLANE ASSOCIATES, LLC FOR THE PURCHASE AND REHABILITATION OF FOUR UNITS LOCATED AT 12142 TAMERLANE DRIVE, GARDEN GROVE, AND OPTION AGREEMENTS FOR THE OPTION TO PURCHASE MULTI-FAMILY APARTMENT BUILDINGS LOCATED AT 12162 AND 12172 TAMERLANE DRIVE, GARDEN GROVE (F: 117.16Z) (F: 117.16W)

PURCHASE AGREEMENT WITH MANUEL AND MARIA RUIZ FOR THE ACQUISITION OF REAL PROPERTY AT 12235 CHOISSER ROAD, GARDEN GROVE (F: 84.1)

Staff report dated January 24, 2012, was introduced and reviewed by staff.

It was moved by Council Member Nguyen, seconded by Council Member Jones, and carried by unanimous vote that the Agreement by and between the City of Garden Grove and Manuel R. and Maria Ruiz to acquire and lease the property at 12235 Choisser Road, Garden Grove, be and hereby is approved; that the City Manager is authorized to execute the Purchase and Sale Agreement, Lease Agreement, and related pertinent documents and make modifications as needed on behalf of the City; that the City Clerk is authorized to accept the Grant Deed on behalf of the City; and the Finance Director is authorized to draw a warrant in the amount of \$445,000, and funds necessary for closing costs, from available proceeds of sale of other City assets/properties in City funds.

<u>SECOND READING OF ORDINANCE NO. 2808 - AMENDMENT TO THE GARDEN</u> <u>GROVE MUNICIPAL CODE: GENERAL UPDATE OF TITLE 5</u> (F: 50.2)

It was moved by Council Member Nguyen, seconded by Council Member Beard, and carried by unanimous vote that full reading of all Ordinances listed for consideration of adoption be waived.

ORDINANCE NO. 2808 was presented for second reading and adoption and the title read in full, being AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE AMENDING TITLE 5 OF THE GARDEN GROVE MUNICIPAL CODE TO REMOVE OBSOLETE REFERENCES, TO CONFORM REFERENCES TO CURRENT CITY ORGANIZATION AND PRACTICES, TO MAKE CONSISTENT WITH RECENT CHANGES IN STATE AND FEDERAL LAWS, AND TO MAKE OTHER NON-SUBSTANTIVE CHANGES

Following the reading of the Ordinance title, it was moved by Council Member Broadwater, seconded by Council Member Nguyen, and carried by unanimous vote that Ordinance No. 2808 be and hereby is declared adopted.

MATTERS FROM THE MAYOR, CITY COUNCIL MEMBERS, AND CITY MANAGER

Council Member Nguyen encouraged all to buy in Garden Grove, and buy USA made products. She encouraged residents to be on the alert for the scam about loan modifications.

Council Member Jones encouraged participation in the Tet New Year celebration in Little Saigon.

Council Member Beard complimented the Mayor on his presentation at the State of the City Luncheon.

Mayor Dalton commented on the difficult budget decisions facing the City Council.
