OBJECTIVE

To request City Council approval for the acceptance of a street deed FOR an easement for public street and highway purposes in accordance with Precise Grading Plan G-1288 (the "Project"), for a portion of the real property located at 11422 Acacia Parkway, Garden Grove, owned by Khoa Duc Tran ("Owner").

BACKGROUND/DISCUSSION

On November 18, 2013, the Owner submitted grading plans for the proposed two residential units on the property currently improved with a single-family home at 11422 Acacia Parkway, Garden Grove, and to dedicate 10 feet of right-of-way along Eighth Street and a corner cut-off to the City of Garden Grove for future widening improvements.
