

ORDINANCE NO. 2758

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE  
APPROVING CODE AMENDMENT NO. A-150-09, FOR THE RE-ORGANIZATION OF  
TITLE 9 (ZONING ORDINANCE) OF THE MUNICIPAL CODE, ADD NEW DEFINITIONS,  
AND CORRECT TYPOGRAPHICAL ERRORS

WHEREAS, the case, initiated by City of Garden Grove, proposes amending Title 9 (Zoning Ordinance) of the Municipal Code to include re-organization of the Code, adding new definitions, and correct typographical errors;

WHEREAS, the Planning Commission, at a Public Hearing held on October 15, 2009, determined that this project is exempt pursuant to Section 15601(b)(3), of the California Environmental Quality Act (CEQA);

WHEREAS, pursuant to Resolution No. 5695, the Planning Commission, at a Public Hearing held on October 15, 2009, recommended approval of Amendment No. A-150-09;

WHEREAS, pursuant to a legal notice, a Public Hearing was held by the City Council on November 10, 2009, and all interested persons were given an opportunity to be heard; and

WHEREAS, the City Council of the City of Garden Grove in regular session assembled on November 10, 2009, does hereby determine that this project is exempt pursuant to Section 15601(b)(3), of the CEQA.

THE CITY COUNCIL OF THE CITY OF GARDEN GROVE DOES ORDAIN AS FOLLOWS:

Section 1. The City Council of the City of Garden Grove has considered the proposed Code Amendment together with comments received during the public review process. The record of proceedings on which the City Council of the City of Garden Grove decision is based is located at the City of Garden Grove, 11222 Acacia Parkway, Garden Grove, California. The custodian of record of proceedings is the Director of Community Development. The City Council of the City of Garden Grove finds on the basis of the whole record before it, including comments received, that the project is exempt pursuant to Section 15601(b)(3), of the CEQA.

Section 2. Amendment No. A-150-09 is hereby approved, pursuant to the facts and reasons stated in Planning Commission Resolution No. 5695, a copy of which is on file in the Office of the City Clerk and incorporated herein by reference with the same force and effect as if set forth in full.

Section 3. This Ordinance shall take effect thirty (30) days after adoption and shall within fifteen (15) days of adoption be published with the names of Council Members voting for and against the same in a newspaper adjudicated and circulated in the City of Garden Grove.
