OBJECTIVE

To request that the City Council approve the addition of Pascal & Ludwig Constructors and 4-Con Engineering, Inc. to the list of pre-qualified bidders for the construction of the Westhaven Booster Pump Station, Natural Gas Engine Driven Pump Conversion Project No. 7391.

BACKGROUND

On March 23, 2010, the City Council approved the list of pre-qualified bidders for the construction of Westhaven Booster Pump Station, Natural Gas Engine Driven Pump Conversion Project No. 7391. Nine out of eleven contractors who submitted the pre-qualification package were pre-qualified and placed on the list of pre-qualified bidders. Pascal & Ludwig Constructors and 4-Con Engineering, Inc. were excluded at that time due to the lack of supporting documents regarding their license, insurance or other qualification requirements. Since then, both of these contractors have sent in their formal protests and the supporting documents within the proper time for the City to reconsider its decision.

DISCUSSION

Staff reviewed the submitted protests and supporting documents in conjunction with the City Attorney's office. After the review, it was found that Pascal & Ludwig Constructors and 4-Con Engineering, Inc. meet the requirements to be pre-qualified to bid on this project.

FINANCIAL IMPACT

This project will be financed with water funds and will have no impact on the General Fund.


