AGREEMENT WITH CLEANSTREET FOR STREET SWEEPING AND CATCH BASIN

CLEANING SERVICES

OBJECTIVE

To obtain City Council approval to amend the City's current service agreement for street sweeping and catch basin cleaning with CleanStreet, extending the agreement for one (1) year, to November 29, 2014.

BACKGROUND

Street sweeping is an integral element in keeping the City in compliance with its National Pollutant Discharge Elimination Systems (NPDES) permit. Our current sweeping program removes approximately 280 tons of debris from our City's storm drain system monthly. The cost of our service agreement is \$793,614.60 per year.

In November 2007, the City entered into an agreement with CleanStreet for street sweeping services and catch basin cleaning. The contract was written as a twoyear initial term with two, two-year renewal options, for a total term of 6 years. The expiration date of the contract is November 30, 2013.

DISCUSSION

Currently, the Department is operating with two vacancies in the part time Parking Control Specialist (PCS) position. It is not advisable to bring in a new street sweeping contractor at the same time new PCS's are learning their job. expected that the new PCS's will be hired and trained within the next fiscal year (2013-14).

Staff is currently in the process of preparing information and gathering documents to proceed with a Request for Proposals (RFP) for a new agreement. Management has reviewed this issue and all its impacts and has concluded it would be in the City's best interest to seek a one-year agreement extension.

FINANCIAL IMPACT

The one-year contract extension will be in an amount not to exceed \$793,614.60. Funding is available in the Public Works Department budget.

RECOMMENDATION

It is recommended that the City Council:

- Approve the extension to the contract with CleanStreet until November 29, 2014, in an amount not to exceed \$793,614.60; and
- Authorize the City Manager to execute the amendment to the agreement on behalf of the City, and make minor modifications as appropriate thereto.

WHEREAS, Contractor and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1.0 Term and Termination, shall be revised as follows:

The CITY hereby extends the performance period from **November 30, 2013** to **November 29, 2014.**

Section 3.1 COMPENSATION - shall be revised as follows:

The contract Price is hereby increased from \$4,611,687.00 to a new Firm Fixed Price of \$5,405,301.60. This is an increase of \$793,614.60 to extend the contract for one additional year per Attachment A.

Except as expressly amended hereby, the Existing Contract remains in full force and effect as originally executed.
