FIRE
RESIDENTIAL

GE7 RESPONDED TO A RESIDENTIAL BEDROOM FIRE. ON ARRIVAL, GE7 ENCOUNTERED A SINGLE STORY RESIDENTIAL WITH SMOKE PRESENT OUT THE FRONT DOOR. GE7 DEPLOYED HANDLINES AND ATTACKED THE FIRE. THE FIRE WAS LOCATED IN THE REAR BEDROOM OF THE HOUSE. ENTRY WAS MADE BY GE7 CREW AND A KNOCKDOWN OF FIRE WAS ACHIEVED. ADDITIONAL RESOURCES WERE USED ON SCENE TO EXTINGUISH AND VENTILATE THE FIRE. TWO ELDERLY LADIES LIVES IN THE HOUSE. BOTH WERE EVACUATED PRIOR TO GE7 ARRIVAL BY NEIGHBORS. BOTH WERE TREATED ON SCENE AND TRANSPORTED TO GPMC FOR SMOKE INHALATION. CE66 WAS THE MEDICAL UNIT TREATING PT'S.

ON FURTHER INVESTIGATION AND QUESTION OF HOMEOWNERS, IT WAS DETERMINED THAT THE FIRE WAS STARTED BY A UNATTENDED CANDLE IN THE REAR BEDROOM OF THE HOUSE WHERE THE FIRE WAS CONCENTRATED. THIS FACT WAS CONFIRMED BY ONE OF THE HOME RESIDENTS. BUSTOS, SOCORRO STATED THAT SHE HAD LEFT A CANDLE IN THE FIRE ROOM ON TOP OF A DRESSER BY A WINDOW AND LATER HEARD A NOICE AS LIKE SOMETHING HAD FALLEN. SHORTLY AFTER THAT THERE HAS SMOKE THRUUGHT THE HOUSE. SHE WENT TO SEE WHAT THE NOICE WAS AND SAW FIRE ON THE DRESSER IN THE INVOLVED ROOM.
