Dear City Clerk:

Pursuant to the California Public Records Act (Government Code § 6250 et seq.), I write to request public records of the Successor Agency to the Garden Grove Agency for Community Development ("Successor Agency") related to the Recognized Obligation Payment Schedule for the period of January 1 through June 30, 2016 (ROPS 15-16B).

Specifically, I am requesting documents related to Item No. 50, the Limón Lawsuit Settlement/Judgment, on ROPS 15-16B:

- (1) copies of any documents related to the Item No. 50 on ROPS 15-16B, including but not limited to the inclusion of Item No. 50 on the ROPS, the meet and confer request to the Department of Finance ("DOF"), and all subsequent communications with DOF;
- (2) copies of any communications related to Item No. 50 on ROPS 15-16B between the City of Garden Grove, as Successor Agency to the Garden Grove Agency for Community Development, or its agents, and DOF; and
- (3) copies of any communications related to Item No. 50 on ROPS 15-16B between the Garden Grove Housing Authority, as Housing Successor, or its agents, and DOF.

Public Counsel is a nonprofit organization that provides free legal services to low-income people in Southern California. Accordingly, we request that the City waive any costs related to this Public Records Act request and provide all documents in electronic form, if possible. For documents that do not exist electronically, please allow Public Counsel to arrange for inspection or copying to reduce any costs.
