SMOKE REMOVAL

GE 3 RESPONDED TO A FOOD ON THE STOVE FIRE. UPON ARRIVAL THE FIRE WAS DETERMINED TO HAVE ORIGINATED IN ROOM 211. THE FIRE ALARM WAS ACTIVE AND THE FIRE DOORS HAD SHUT AND ELEVATORS HAD RECALLED TO THE FIRST FLOOR. WE OBSERVED MODERATE WHITE SMOKE IN THE 2 ND FLOOR HALLWAY AND CALLED FOR GT 1 TO USE THE BLOWERS TO RAPIDLY REMOVE THE SMOKE. WHEN COMPLETE WE RESET THE FIRE ALARM HOWEVER THE NUMBER 1 ELEVATOR WOULD NOT RESET. WE TAPED OFF THE SCEN WITH CAUTION TAPE AND DTERMINED THAT ELEVATOR 2 WAS WORKING. WE HAD METRO NET CALL OTIS TO FIX THE ELEVATOR AND THEY STATED THEY WOULD BE THERE IN THE MORNING.
