# STRUCTURE FIRE RESIDENTIAL

GE7 RESPONDED WITH GB1, CE66, CE64, CT64, GT1 AND GM1 TO A HOUSE WITH A BEDROOM FIRE. CE66 ARRIVED AND ESTABLISHED COMMAND, AND GE7 WAS ASSIGNED INTERIOR WITH CE66 CREW AS WELL AS GM1. GE7 MADE A QUICK ATTACK ON THE BEDROOM FIRE AND CONDUCTED A PRIMARY AND SECONDARY SEARCH OF THE HOUSE. THE FIRE WAS EXTINGUISHED AND NO OCCUPANTS WERE INSIDE. FIRE WAS OVERHAULED BY GT1 AND GE7, AND RED CROSS WAS DISPATCHED FOR THE FAMILY. GE7 AND GT1 COULD NOT DETERMINE THE EXACT CAUSE OF THE FIRE DUE TO EXTENSIVE DAMAGE OF THE FIRE ROOM. A PROPERTY RELEASE WAS FILLED OUT WITH THE PROPERTY OWNER, AND ALL CREWS WERE CLEAR OF THE CALL.
