## ORDINANCE NO. 2295

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE ADDING SECTION 10.40.060, ENTITLED "REMOVAL OF PARKED VEHICLE WHEN PRIMARY PURPOSE IS ADVERTISING" TO CHAPTER 10.40 OF TITLE 10 OF THE MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF GARDEN GROVE DOES ORDAIN AS FOLLOWS:

## SECTION 1: Findings and Intent

The City Council hereby finds:

- It is in the public interest to establish regulations governing on-street parking in order to reduce traffic hazards and to provide parking for local residents and business customers.
- 2. That Vehicle Code Section 22651.9 allows local jurisdictions, after adoption of an ordinance, to tow vehicles displayed for sale after complying with the provisions of the section.

## SECTION 2: Code Amendment

Municipal Code Section 10.40.060 entitled "Removal of Parked Vehicle when primary purpose is advertising" is hereby added to Chapter 10.40 of Title 10 of the Municipal Code to read as follows:

"Section 10.40.060. Removal of Parked Vehicle when primary purpose is advertising.

(a) Parking of Vehicles to advertise for sale on City streets prohibited.

No person shall park a vehicle upon a public or private street, parking lot or any public or private property for the purpose of displaying such vehicle thereon for sale, hire or rental, unless the property is duly zoned and licensed by the City to transact that type of business at that location, except that this section shall not prohibit persons from parking vehicles displayed for sale on private residential property belonging to or resided in by the registered owner of the vehicle, nor on the public street immediately adjacent to said private residential property.

(b) Removal of Vehicle.

Any vehicle in violation of this section may be removed from the pubic street pursuant to Vehicle Code Section 22651.9 provided a notice of parking violation has been issued within the previous thirty (30) days.

## CTION 3:

This ordinance shall take effect (30) days after adoption and shall ithin fifteen (15) days of adoption be published with the names of buncilmembers voting for and against the same in the Orange County News, a ewspaper of general circulation, published and circulated in the City of arden Grove.

The foregoing Ordinance was passed by the City Council of the City of Garden Grove on the 3rd day of May, 1994.
