



The CAUSE Leadership Academy (CLA), which was formerly the California Asian American Student Internship Coalition (CASIC), was founded in 1991 in order to develop a pipeline of leadership for the Asian Pacific American (APA) community. Despite APAs being the fastest growing community in the United States, representation and leadership has not kept pace with the growing and changing demographics.

CLA teaches students the importance of civic engagement and political participation and prepares its participants to be leaders at the forefront of the democratic process. Through exposure to decision-makers, policy makers, and the issues of the day, students gain a deeper awareness of the political issues facing the APA community in California and the nation. Graduates of this program have gone on to run for political office and have even become leaders in politics, business, and nonprofits.

The CAUSE Leadership Academy - Los Angeles, CA Program offers opportunities for students to gain firsthand experience in politics through constituent services, community organizing, community relations, legislative research, etc. Program participants intern at the district offices of various elected officials' offices at the state and federal level.

The CAUSE Leadership Academy - Washington, DC Program offers opportunities for students to gain firsthand experience in politics through legislative work, attending various legislative briefings and hearings, conducting policy research, etc. Program participants intern in the highest levels of the federal government including, but not limited to: congressional capitol offices or federal agencies.

**Duration:** June 13, 2016 – August 12, 2016 (9 weeks)


The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Tier 2 volume for MWDOC, and selected water supply information.

- Fig. 1 OC Water Usage, Monthly by Supply OCWD Groundwater water was the main supply in November.
- Fig. 2 OC Water Usage, Monthly, Comparison to Previous Years Water usage in November 2015 was below average compared to past three years. Lower usage is primarily due to strong conservation efforts and mandatory restrictions set by the governor.
- Fig. 3 Historical OC Water Consumption OC water consumption was 571,000 AF in FY 2014-15. This is about 50,000 AF less than FY 2013-14 but is about 16,000 AF higher than FY 2010-11 (Fiscal year with lowest usage). Water usage per person was the lowest it has been for Orange County at 164 gallons per day. Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts. High Temperature, precipitation and the economy all remain indicators to O.C. water consumption.
- Fig. 4 MWDOC "Firm" Water Purchases, 2015 "Firm" water above the Tier 1 limit will be charged at the higher Tier 2 rate. Our current projection of Tier 2 purchases is zero in 2015.

<u>Water Supply Information</u> Includes data on: Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the


magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1<sup>st</sup> through Sept. 30<sup>th</sup>.

- Orange County's accumulated rainfall through December was below average for this period. This continues the impact of the previous three hydrologic years' belownormal rainfall in reducing those local supplies that are derived from local runoff. El Nino conditions are present and 2015-16 winter is developing into a very strong El Nino event.
- Northern California accumulated precipitation in December was around 94% of normal for this period. The Northern California snowpack is 105% of normal. This follows three below-average hydrologic years. The State of California has been in a declared Drought Emergency since January 2014. The State Water Project Contractors Table A Allocation is only 10% as of the end of December.
- Colorado River Basin accumulated precipitation in November was 104% average for this period. The Upper Colorado Basin snowpack was 107% of average as of April 15<sup>th</sup>. However, this follows two below-average hydrologic years, and this watershed is in a long-term drought. Lake Mead and Lake Powell combined have about 60% of their average storage volume for this time of year. If Lake Mead's level falls below a "trigger" limit at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries for the Lower Basin states. As of Late July Lake Mead Levels were hovering around the "trigger" limit but fortunately levels are expecting to increase from the large amounts of precipitation that hit the Colorado River Basin this summer and spring. The USBR predicts that the "trigger" level will not be hit by the end of 2015.










Projection of FY 15-16 water use estimated by MWDOC based on partial-year data.

BPP pertains to Basin agencies only. For example, if a Basin agency's total demand is 10,000 AF/yr and OCWD sets the BPP at 72%, then the agency is limited to 7,200 AF of groundwater that year. # Garden Grove Planning Commissioner's Residency in Question

Garden Grove Planning Commissioner Vu Mai appears to be a resident of San Clemente, according to a review of public records.

Mai, a dentist with an office in Garden Grove, is registered to vote at a home he owns in San Clemente. He also claims a \$7,000 homeowner's property tax exemption at that home, an exemption that can only be claimed at an individual's primary place of residence.

In order to serve on the city's planning commission, an individual must be a resident and registered voter in Garden Grove, according to City Manager Scott Stiles.

The Garden Grove condominium listed on Mai's planning commission application is owned by two individuals Dat T. Luong and Le Nhu Ly, according to records at the county Assessor's Office.

Mai says he used to live in San Clemente full-time, but travels often because he is a U.S. Army reserve officer. He said he stays at the condominium with his aunt and uncle. He also owns another Garden Grove home, which he uses for rental income.

"I have a dental practice and my military base is in Garden Grove. I stay here most of the time for the convenience of work," Mai wrote in an email to a Voice of OC reporter. "I also have a home in Garden Grove but I don't like to live by myself. The home in San Clemente is for my family to live."

"That's why it's not feasible and economically advantageous for me to live by myself," he said.

Planning Commissioner Linda Zamora said she has lived in the same 11-unit condominium complex for 13 years, but has never seen Mai there.

"I know people are busy and work, but I thought it was weird that I've never seen him," Zamora said.

According to City Clerk Kathy Bailor, applications for the Planning Commission operate on an "honor system." City staff does not do additional research to verify residency, aside from checking the address listed on applications, Bailor said.

Stiles said he has not heard complaints about Mai's residency and said he would bring the issue to the City Council.

"I think we have an obligation to report back to the City Council since they make the appointments to commissioners, and go from there," Stiles said.

Mai was appointed to the commission in Jan. 2014 by council member Phat Bui, who Mai endorsed for City Council. Prior to that appointment, Mai had never served on a city commission.

There is currently one vacancy on the commission still awaiting an appointment by mayor Bao Nguyen. Nguyen's first appointee, Julie Vo, failed to get the support of his colleagues, who were concerned that the nonprofit sector professional has never served on a city commission.

## **GGMC 2.21.015 Qualifications for Members**

Members of all commissions or boards created by ordinance or resolution shall be and remain residents of the City, who are eligible by reason of age, citizenship, and otherwise to register to vote, with the exceptions hereinafter provided.

- A. Minors who are and remain City residents are eligible to serve on any commission the City Council may create by ordinance providing for eligibility of minors to serve as commissioners.
- B. Nonresidents may serve on the Main Street Commission and such other commissions as the City Council may create for specialized limited functions, if the City Council finds that the commission is intended to represent and further the interests of a specialized industry, trade, or profession, and that the representation and furtherance will ultimately serve the public interest, as provided in Title 2, California Code of Regulations Section 18707.4. (2813 § 1, 2012; 2085 § 1, 1989)

# 1. What is the Homeowners' Exemption?

The California Constitution provides for the exemption of \$7,000 (maximum) in assessed value from the property tax assessment of any property owned and occupied as the owner's principal place of residence. The exemption reduces the annual property tax bill for a qualified homeowner by up to \$70. (Article XIII Section 3 of the California Constitution, Rev & Tax 218).

# 2. How do I qualify for the Homeowners' Exemption?

To obtain the exemption for a property, you must be its owner or co-owner (or a purchaser named in a contract of sale), and you must live in the property as your **principal** place of residence. You must also file the appropriate exemption claim form with the Assessor.

There are two, basic, alternative ways that persons qualify for this exemption:

# Alternative 1 - Ownership & Occupancy on the Lien Date:

The exemption is available to the eligible owner of a dwelling which is occupied as their principal place of residence at 12:01 a.m. on January 1 (the lien date) of each year.

# Alternative 2 – Ownership & Occupancy or Intent to Occupy within 90 days of a change in ownership or completion of new construction:

The exemption is available to the eligible owner of a dwelling that is subject to a supplemental assessment resulting from a change in ownership or completion of new construction on or after January 1, provided that:

A. The owner occupies or intends to occupy the property as their principal place of residence within 90 days after the date of change in ownership or the date of completion of new construction. and

B. The property is not already receiving the homeowners' exemption or another exemption of greater value. If the property received an exemption of lesser value on the current assessment roll, the difference in amount between the two exemptions shall be applied to the supplemental assessment.

C. The claim is filed by 5 p.m. on or before the **30th day** following the date printed on the "Notice of Supplemental Assessment" issued for the change in ownership or new construction.

Under **Option 2**, whatever exemption is granted will be applied to the supplemental assessment or assessments, if any, and the full exemption will take effect during the next fiscal year, provided the claim is timely filed (i.e., within 30 days of the date of Notice of Supplemental Assessment).

If you **do not own the property**, you should not file a Homeowners' Exemption claim. If you do not occupy, or intend to occupy property you own, you should not file a Homeowners' Exemption claim.

- (ii) After receiving the elected or appointed official's written demand, the person, business, or association shall not transfer the appointed or elected official's <a href="https://example.com/home/address">home/address</a> or telephone number to any other person, business, or association through any other medium.
- (iii) Clause (ii) shall not be deemed to prohibit a telephone corporation, as defined in Section 234 of the Public Utilities Code, or its affiliate, from transferring the elected or appointed official's home address or telephone number to any person, business, or association, if the transfer is authorized by federal or state law, regulation, order, or tariff, or necessary in the event of an emergency, or to collect a debt owed by the elected or appointed official to the telephone corporation or its affiliate.
- (E) For purposes of this paragraph, "publicly post" or "publicly display" means to intentionally communicate or otherwise make available to the general public.
- (2) An official whose <u>home address</u> or telephone number is made public as a result of a violation of paragraph (1) may bring an action seeking injunctive or declarative relief in any court of competent jurisdiction. If a court finds that a violation has occurred, it may grant injunctive or declarative relief and shall award

the official court costs and reasonable attorney's fees. A fine not exceeding one thousand dollars (\$1,000) may be imposed for a violation of the court's order for an injunction or declarative relief obtained pursuant to this paragraph.

In the case of an appointed official who is a peace officer, as defined in Sections 830 to 830.65, inclusive, of the Penal Code, a District Attorney, or a Deputy District Attorney, that official may also designate his or her recognized collective bargaining representative to make a written demand on his or her behalf pursuant to this section. A written demand made by an agent pursuant to this paragraph shall include a statement describing a threat or fear for the safety of that official or of any person residing at the official's home address.
- (d) (1) No person, business, or association shall solicit, sell, or trade on the Internet the home address or telephone number of an elected or appointed official with the intent to cause imminent great bodily harm to the official or to any person residing at the official's home address.
- (2) Notwithstanding any other law, an official whose <u>home address</u> or telephone number is solicited, sold, or traded in violation of paragraph (1) may bring an action in any court of competent jurisdiction. If a jury or court finds that a violation has occurred, it shall award damages to that official in an amount up to a maximum



Subject: Redistricting Garden Grove

On behalf of Community Involvement for a Vital and Inclusive City Garden Grove (C.I.V.I.C.GG) a group comprised of residents and concerned community members interested in empowering the community to be engaged, and involved in the city of Garden Grove. We are writing this letter supporting for continued progress to have district elections in the City of Garden Grove starting this year, 2016. District elections are generally understood as giving underrepresented communities a greater opportunity to have a voice and play a greater role in local government. Furthermore, districts allow for lower cost campaigns, thus enabling would-be council members without access to large amount of capital opportunities to compete with others that have greater access to campaign funds.

We support the actions our city has taken the last couple of months to begin the process of having a series of discussion with the community regarding the development of district maps.

We want to remind the Council they voted last year to approve district elections as part of the settlement agreement to replace the City's "At-Large" method for selecting Council members that violates the California Voting Rights Act. We simply want District Elections in our city to move smoothly and have ample time for a system to be in place prior to the 2016 elections.

We urge the Mayor and Council members to continue and support progress for the city of Garden Grove to have district elections in 2016.

Mr. Stiles,

By now you and our council-members should have had a chance to review attachments 1 & 2 and attachment 3 is a follow up article dated 1/13/2016 from the Voice of OC regarding this matter. I call your attention to the quote made by Mr. Vu Mai at the recent city council meeting of 1/12/2016:

"When it comes to my home, the way I look at it, I'm going to get the most tax write off, that's why I put in for San Clemente...the home here is not worth as much as San Clemente," Mai said.

In order for one to make the claim of a homeowners tax exemption on one's property tax bill/assessment, the following residency requirement shall be met:

The California Constitution provides for the exemption of \$7,000 (maximum) in assessed value from the property tax assessment of any property owned and occupied as the owner's principal place of residence. The exemption reduces the annual property tax bill for a qualified homeowner by up to \$70. (Article XIII Section 3 of the California Constitution, Rev & Tax 218).

Since Mr. Mai does not deny that he actually lives in San Clemente then he would not be in violation of Revenue & Tax Code 218 and/or California Constitution Article XIII, Section 3. However, if he's going to claim coverage under California Government Code 6254.21 for his property in San Clemente because he's an "appointed official" in Garden Grove, then he appears to be in violation of California Government Code 6254.21 or at the very least misusing this particular code. At this point Mr. Mai clearly does not meet the requirement(s) of GGMC 2.21.015 and he needs to either resign his position on our planning commission or he needs to be removed by the authority set forth in our municipal code(s).

Please take the appropriate action and in the interest of transparency, please let the People of Garden Grove know which action you will be taking.

# Garden Grove Planning Commissioner's Residency in Question

Garden Grove Planning Commissioner Vu Mai appears to be a resident of San Clemente, according to a review of public records.

Mai, a dentist with an office in Garden Grove, is registered to vote at a home he owns in San Clemente. He also claims a \$7,000 homeowner's property tax exemption at that home, an exemption that can only be claimed at an individual's primary place of residence.

In order to serve on the city's planning commission, an individual must be a resident and registered voter in Garden Grove, according to City Manager Scott Stiles.

The Garden Grove condominium listed on Mai's planning commission application is owned by two individuals Dat T. Luong and Le Nhu Ly, according to records at the county Assessor's Office.

Mai says he used to live in San Clemente full-time, but travels often because he is a U.S. Army reserve officer. He said he stays at the condominium with his aunt and uncle. He also owns another Garden Grove home, which he uses for rental income.

"I have a dental practice and my military base is in Garden Grove. I stay here most of the time for the convenience of work," Mai wrote in an email to a Voice of OC reporter. "I also have a home in Garden Grove but I don't like to live by myself. The home in San Clemente is for my family to live."

"That's why it's not feasible and economically advantageous for me to live by myself," he said.

Planning Commissioner Linda Zamora said she has lived in the same 11-unit condominium complex for 13 years, but has never seen Mai there.

"I know people are busy and work, but I thought it was weird that I've never seen him," Zamora said.

According to City Clerk Kathy Bailor, applications for the Planning Commission operate on an "honor system." City staff does not do additional research to verify residency, aside from checking the address listed on applications, Bailor said.

Stiles said he has not heard complaints about Mai's residency and said he would bring the issue to the City Council.

"I think we have an obligation to report back to the City Council since they make the appointments to commissioners, and go from there," Stiles said.

Mai was appointed to the commission in Jan. 2014 by council member Phat Bui, who Mai endorsed for City Council. Prior to that appointment, Mai had never served on a city commission.

There is currently one vacancy on the commission still awaiting an appointment by mayor Bao Nguyen. Nguyen's first appointee, Julie Vo, failed to get the support of his colleagues, who were concerned that the nonprofit sector professional has never served on a city commission.

### **GGMC 2.21.015 Qualifications for Members**

Members of all commissions or boards created by ordinance or resolution shall be and remain residents of the City, who are eligible by reason of age, citizenship, and otherwise to register to vote, with the exceptions hereinafter provided.

- A. Minors who are and remain City residents are eligible to serve on any commission the City Council may create by ordinance providing for eligibility of minors to serve as commissioners.
- B. Nonresidents may serve on the Main Street Commission and such other commissions as the City Council may create for specialized limited functions, if the City Council finds that the commission is intended to represent and further the interests of a specialized industry, trade, or profession, and that the representation and furtherance will ultimately serve the public interest, as provided in Title 2, California Code of Regulations Section 18707.4. (2813 § 1, 2012; 2085 § 1, 1989)

### 1. What is the Homeowners' Exemption?

The California Constitution provides for the exemption of \$7,000 (maximum) in assessed value from the property tax assessment of any property owned and occupied as the owner's principal place of residence. The exemption reduces the annual property tax bill for a qualified homeowner by up to \$70. (Article XIII Section 3 of the California Constitution, Rev & Tax 218).

### 2. How do I qualify for the Homeowners' Exemption?

To obtain the exemption for a property, you must be its owner or co-owner (or a purchaser named in a contract of sale), and you must live in the property as your **principal** place of residence. You must also file the appropriate exemption claim form with the Assessor.

There are two, basic, alternative ways that persons qualify for this exemption:

# Alternative 1 – Ownership & Occupancy on the Lien Date:

The exemption is available to the eligible owner of a dwelling which is occupied as their principal place of residence at 12:01 a.m. on January 1 (the lien date) of each year.

# Alternative 2 – Ownership & Occupancy or Intent to Occupy within 90 days of a change in ownership or completion of new construction:

The exemption is available to the eligible owner of a dwelling that is subject to a supplemental assessment resulting from a change in ownership or completion of new construction on or after January 1, provided that:

A. The owner occupies or intends to occupy the property as their principal place of residence within 90 days after the date of change in ownership or the date of completion of new construction. and

B. The property is not already receiving the homeowners' exemption or another exemption of greater value. If the property received an exemption of lesser value on the current assessment roll, the difference in amount between the two exemptions shall be applied to the supplemental assessment.

C. The claim is filed by 5 p.m. on or before the **30th day** following the date printed on the "Notice of Supplemental Assessment" issued for the change in ownership or new construction.

Under **Option 2**, whatever exemption is granted will be applied to the supplemental assessment or assessments, if any, and the full exemption will take effect during the next fiscal year, provided the claim is timely filed (i.e., within 30 days of the date of Notice of Supplemental Assessment).

If you **do not own the property**, you should not file a Homeowners' Exemption claim. If you do not occupy, or intend to occupy property you own, you should not file a Homeowners' Exemption claim.







(C) A written demand made under this paragraph by an elected official shall be effective for four years, regardless of whether or not the official's term has

expired prior to the end of the four-year period.

- (D) (i) A person, business, or association that receives the written demand of an elected or appointed official pursuant to this paragraph shall remove the official's home address or telephone number from public display on the Internet, including information provided to cellular telephone applications, within 48 hours of delivery of the written demand, and shall continue to ensure that this information is not reposted on the same Internet Web site, subsidiary site, or any other Internet Web site maintained by the recipient of the written demand.
- (ii) After receiving the elected or appointed official's written demand, the person, business, or association shall not transfer the appointed or elected official's <a href="https://example.com/home/address">home/address</a> or telephone number to any other person, business, or association through any other medium.
- (iii) Clause (ii) shall not be deemed to prohibit a telephone corporation, as defined in Section 234 of the Public Utilities Code, or its affiliate, from transferring the elected or appointed official's home address or telephone number to any person, business, or association, if the transfer is authorized by federal or state law, regulation, order, or tariff, or necessary in the event of an emergency, or to collect a debt owed by the elected or appointed official to the telephone corporation or its affiliate.
- (E) For purposes of this paragraph, "publicly post" or "publicly display" means to intentionally communicate or otherwise make available to the general public.
- (2) An official whose <u>home address</u> or telephone number is made public as a result of a violation of paragraph (1) may bring an action seeking injunctive or declarative relief in any court of competent jurisdiction. If a court finds that a violation has occurred, it may grant injunctive or declarative relief and shall award

the official court costs and reasonable attorney's fees. A fine not exceeding one thousand dollars (\$1,000) may be imposed for a violation of the court's order for an injunction or declarative relief obtained pursuant to this paragraph.

- (3) An elected or appointed official may designate in writing the official's employer, a related governmental entity, or any voluntary professional association of similar officials to act, on behalf of that official, as that official's agent with regard to making a written demand pursuant to this section. In the case of an appointed official who is a peace officer, as defined in Sections 830 to 830.65, inclusive, of the Penal Code, a District Attorney, or a Deputy District Attorney, that official may also designate his or her recognized collective bargaining representative to make a written demand on his or her behalf pursuant to this section. A written demand made by an agent pursuant to this paragraph shall include a statement describing a threat or fear for the safety of that official or of any person residing at the official's home address.

### Garden Grove to Review Residency Requirements for Planning Commission

The Garden Grove City Council will review the city's residency requirements for its planning commission after Voice of OC reported last week that commissioner Vu Mai appears to live in the city of San Clemente.

Mai was present and addressed the council during public comment, emphasizing that while his family lives in San Clemente and he claims a tax exemption on his home there, he spends most of his time in Garden Grove, where his dental practice is located, and is invested in the city.

"When it comes to my home, the way I look at it, I'm going to get the most tax write off, that's why I put in for San Clemente...the home here is not worth as much as San Clemente," Mai said.

"There is no lie here, no malicious intent on my part, to do anything wrong for the city. There is no financial gain or political gain for me. I do it because I love the city," Mai added.

Although Mai does own a home in Garden Grove, which he uses for rental income, he is registered to vote in San Clemente and as of last week hadn't updated his registration since 2012, according to the county Registrar of Voters. He said he hadn't registered in Garden Grove because he typically doesn't vote in local elections.

At the meeting, City Attorney Omar Sandoval said Mai is now registered in Garden Grove. Several residents called for the city to clarify its requirements for residency.

"You can't have it both ways. It's one or the other...and the message is simple here," said Tony Flores. "If you're going to be on our commission, live in our city. Don't play in any games."

Resident Josh McIntosh praised Mai's work on the commission since he was appointed by Councilman Phat Bui in 2015.

"He's one of the most engaged, he asks questions, he partcipates. He always wants to dig deeper into the issues," McIntosh said.

Although planning commissioners must be residents and registered to vote in Garden Grove, the city operates on an honor system when processing applications and does not follow up on residency claims.

Some cities don't require their commissioners to be residents. The city of Emeryville, Calif., for example, allows business owners to serve as well.

Councilman Kris Beard suggested requiring all commissioners to be registered to vote in the city. At the next meeting, council members will also consider any appointments or removal of commissioners.

There is currently one vacancy on the Planning Commission after Commissioner Joe Pak stepped down from his seat early. The seat has been left open since Mayor Bao Nguyen's first appointment, Julie Vo, failed to gain support from his colleagues.

Bui said that, given the relative inexperience of the current commissioners, they should appoint a more experienced candidate to serve out the last year of Pak's term. Vo has never served on a city commission.

Nguyen said he plans to fill the seat at the next council meeting on Jan. 26.
