MEDICAL TRAFFIC COLLISION

GE2 ARRIVED AT THE REPORTED LOCATION TO FIND A SOLO VEHICLE TC INTO A BUILDING WITH A WATER LINE BREACHED. GGPD ONSCENE AND STATE THEY MADE CONTACT WITH WATER DEPT. GE2 SHUT OFF WATER FOR THAT ADDRESS AT THE METER. THE VEHICLE IS A 4-DOOR MID SIZE CAR WITH MODERATE TO HEAVY DAMAGE TO THE REAR DRIVER SIDE DOOR. GE2 WITH TWO PT'S FOUND LYING SUPINE ON THE GRASS NEXT TO THE VEHICLE. IT IS UNKNOWN AS TO WHOM WAS DRIVING AS THE STORY SEEMED TO BE CHANGING.

PT ONE IS A 33 YO MALE (POSSIBLY THE DRIVER) UNKNOWN WHETHER SEAT BELTS WERE WORN. PT IS A&OX4 WITH THE COMPLAINT OF HEAD PAIN. GE2 WITH PRIMARY, SECONDARY, VITALS, C-COLLAR.

PT TWO IS A 29 YO FEMALE UNKNOWN WHETHER SEAT BELT WAS WORN. PT IS A&OX4 WITH THE COMPLAINT OF BACK PAIN AND STATES SHE IS 20 WEEKS PREGNANT. GE2 WITH PRIMARY, SECONDARY, VITALS, AND FULL SPINAL PRECAUTIONS.

BOTH PT'S TRANSPORTED IN THE SAME AMBULANCE AND ESCORTED BY GE2 TO UCIMC FOR FURTHER EVALUATION. GE2 COMPLETED.
