The mission of the Neighborhood Traffic Unit (NTU) is to improve the quality of life by providing the safest and most efficient flow of vehicle and pedestrian traffic throughout the city. The NTU enforces traffic laws and educates the community in an effort to accomplish their mission.

The NTU targets areas in the city where traffic problems are prevalent. Traffic issues at schools are always a priority of the NTU. Calls come in from both parents and school officials about the flow of traffic during drop off and pick up times. Throughout 2015, members of the NTU have educated parents by conducting high visibility enforcement meeting with school officials for redirection of vehicles and adding new signs. The NTU works to keep the school zones safe for all students and parents.

In 2015, there were five fatal traffic collisions. Fatalities have decreased year after year since the 2012 record high. The NTU and police department committed officers to the Drug Recognition Expert program. This intense training and certification program trains officers in the detection of people who are driving under the influence of prescribed medication, drugs and/or a combination of drugs and alcohol.

The NTU received funding the California Office of Traffic Safety (OTS), which allowed the unit to conduct traffic related enforcement programs to combat impaired driving, primary collision factor and motorcycle safety. In 2015, OTS funded 8 checkpoints and several hours of impaired driving saturation patrols. The NTU was asked to attend a forum with OTS on innovative ideas for future funding for pedestrian and bicycle safety.

In 2015 the NTU and other Police Department personnel coordinated with several other city officials to host major events in the city. To name a few, two Disney Marathons and the city sponsored Re-Imagine Garden Grove Open Streets Event.

Several representatives from nearly all city departments planned several months in advance to close the downtown area of Garden Grove for a bicycle/festival. Included with the festival was the annual "Open House" for public safety and public works personnel. In the extreme heat and humidity, nearly 2000 people throughout the day joined Garden Grove in the festival and Open Streets theme. Bicycle safety along with live music, several arts and crafts, and games for children were hosted. Even though the weather was a challenge, the Garden Grove Police Department insured the safety of all who attended, while maintaining the highest quality of service to the rest of the community.

I apologize you didn't receive my email regarding this question. In answering your question, If there is no sign indicating the second lane is for right turns only, then it is a violation. As it pertains to Trask/Brookhurst, there is no such indication that vehicles can turn right, therefore it is a violation. The vehicle code is explained below with an emphasis on (3).

I hope this answers your question.

**22100.** Except as provided in Section 22100.5 or 22101, the driver of any vehicle intending to turn upon a highway shall do so as follows:

- (a) Right Turns. Both the approach for a right-hand turn and a right-hand turn shall be made as close as practicable to the right-hand curb or edge of the roadway except:
  - (1) Upon a highway having three marked lanes for traffic moving in one direction that terminates at an intersecting highway accommodating traffic in both directions, the driver of a vehicle in the middle lane may turn right into any lane lawfully available to traffic moving in that direction upon the roadway being entered.
  - (2) If a right-hand turn is made from a one-way highway at an intersection, a driver shall approach the turn as provided in this subdivision and shall complete the turn in any lane lawfully available to traffic moving in that direction upon the roadway being entered.
  - (3) Upon a highway having an additional lane or lanes marked for a right turn by appropriate signs or markings, the driver of a vehicle may turn right from any lane designated and marked for that turning movement.

Good afternoon. I wanted to express my concerns regarding the signage at our local Costco store. The exit lanes leading to GG Blvd have not been working well enough to prevent accidents all too often. I see room for improvement here. There is one sign, right near GG Blvd, indicating that the right lane is right turn only. Often times drivers shoot right across to Main Street because they either do not see the sign or they ignore it. I have personally witnessed this more than ten times and I am certain that this occurs at least ten times a day.

I am asking that someone get together with Costco and demand that they add an additional sign, at about a six foot level, closer to the store as people begin their frantic exit from the madness that is the GG Costco. In addition, I would like to have painted signage on the asphalt, in hopes that this will lessen the danger of this intersection of Main Street and GG Blvd.

By the way, the right turn only sign is barely visible in the evenings and seems to do even less good once the sun goes down.

Please have someone resolve this issue as soon as possible and please follow up with me.

I understand you are trying to obtain stats for 2014 - 2015 referece DUI Stats for the city. I am the supervisor of traffic and I can provide you with some stats, however, not all you are looking for. In 2014 the department made 592 DUI related arrests. We had 9 Checkpoints with a total of 17 arrests. As a department we increased efforts in DUI Saturation instead of focusing on Checkpoints I do not have the stats from the DUI Saturations for 2014, however, they were considerably more than the Checkpoint arrests.

In 2015 the department went through a lot of change with the computer system so I cannot provide you with statistics after Sept. 1st. Jan. 1, 2015 - Sept 1, 2015 there were 347 DUI Arrests. We held 6 Checkpoints with 3 arrests. As a department we continued efforts in the DUI Saturation with a more arrests than Checkpoints, unknown numbers.

Checkpoints are about educating the public on DUI, however in traffic we believe the education is working since the number of Alcohol related arrests are down. We also see an increase in Uber, Lift, and designated drivers going through our Checkpoints. What does not help is an APP that tells people where the county wide checkpoints are. It defeats the purpose of trying to make Garden Grove's streets safe or all streets safe from impaired drivers if all they have to do is check an APP to see where they are located, then avoid them. On our last Checkpoint, I simply googled it and the information was 100% correct on where our checkpoint was located. We didn't tell the location in our Media Release prior to the checkpoint. We believe the number of DUI arrests are down is because of technology so people can avoid Checkpoints and increase in responsible people who use privately owned companies such as Uber, Lift Etc.

Since the inception of "DRE" we are seeing more people under the influence of prescribed medication, Marijuana, drugs, and/or a combination of alcohol and drugs. Every year we try to send two officers to Drug Recognition Expert School. The department has a total of 6 DRE's with a plan to send more. We dont have stats for the number of DUI(D) Drugs for either years but soon we should have the understanding on how to obtain them.

Gents, I was going to send this out to Christopher Haire from OCregister but since I am speaking for Garden Grove, you may want to check it over and see if it is something we want to do. I am responding to his questions.

From December 18 - Jan 3 the motor unit increased their DUI Saturation instead of DUI Checkpoints. We completed a total of 2 Checkpoints over December and 147 hours of DUI Saturation. Not to mention the concentration of DUI on our regular work shifts. There were a total of 17 DUI arrests during that specified time period, approximately 126 vehicles were stopped specifically for suspicion of DUI. DUI arrests are down from years past and from speaking with representatives from OTS, they are down state wide as well.

We in Garden Grove believe that the education component from years of Checkpoints and DUI Saturations with a "Zero Tolerance" approach has contributed to the decrease of arrests specifically in Garden Grove. We have seen more designated drivers and private companies such as Uber and Lift going through our Checkpoints. We in Garden Grove increased the Saturation instead of Checkpoints because of Technology. There are Apps that give the location of Checkpoints throughout the county and on our last checkpoint, I Googled it and found our checkpoint along with others throughout the county on different Websites and our location was 100% accurate. We did not give the location of our Checkpoint in our press release. Impaired drivers can simply avoid the Checkpoint by checking a number of Apps / Websites. Sadly we did not arrest any DUI's at our checkpoints.

Also a good stat to be aware of is in the last 8 years, there has been a fatality during the month of December. We did not have one this year over the holiday's and we believe DUI Saturation, coupled with the education from years of Checkpoints and our aggresive "Zero Tolerance" approach toward DUI's during the holiday season may have contributed to the decrease in arrests and no fatalities.
