

Dear Mr. Wighton:

The City has received several complaints about a motorhome that has been parked in your driveway.

We appreciate the fact that you have done your best to keep the motorhome from sticking out past your driveway, however, there are two issues that still persist.

One issue is that due to the motorhome protruding into the street, we are unable to thoroughly clean the street. Under federal, state, and local laws, the City is required to keep debris out of the storm drain system. The most effective way to accomplish this is through routine street sweeping. Due to the fact that your motorhome exceeds the length of your driveway, the street sweeper is not able to completely clean the curb line in your cul-de-sac.

The second issue is that access to the public sidewalk in front of your driveway is blocked and inaccessible to the community. Under California Vehicle Code section 22500(f), it is illegal to park a vehicle in such a manner that it blocks access to a sidewalk.

It is requested that you move your motorhome so as not to interfere with street sweeping and access to the sidewalk. Failure to do so will result in the motorhome receiving parking citations in the future.
