Good Morning,

I would like to submit a complaint for two municipal codes. The address is 12781 Woodland Ln. Garden Grove. This house has had a 20+ ft. RV parked on city streets for extended amounts of time. I know there is a grace period of loading/unloading of 48 hours, but this has exceeded this time period by months at this point. I am referencing the city's municipal code of **9.16.040.140** for this violation, and it is an eyesore for this neighborhood to see a such a large vehicle parked in one spot for such an extended period of time. Not to mention he has been making repairs on the vehicle in the street which is a violation of code **10.40.050**.

Also this house has an inoperative vehicle with no license plate and no registration sitting on a trailer on city streets directly behind this RV for months as well. From my understanding of code **9.32.170**, inoperative vehicles should be stored on the home owners property in an enclosed space such as a garage.

We would be very appreciative if these matters were looked into seriously, as we have made a complaint before but nothing has changed. The home owner is a friend of a Garden Grove police officer that we are aware of, but does this mean he is exempt from the municipal codes which everyone else in this neighborhood is subject to? I am sure the responding officer will also hear from the home owner that he is a friend of an officer, as this is his typical response.

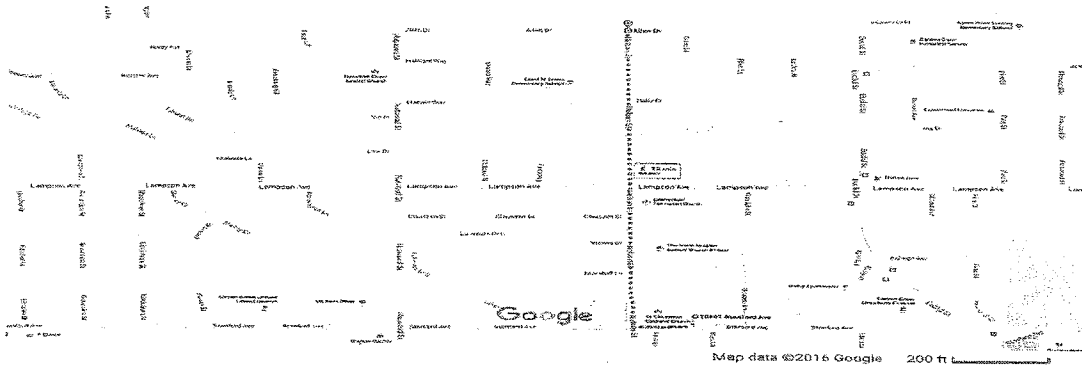

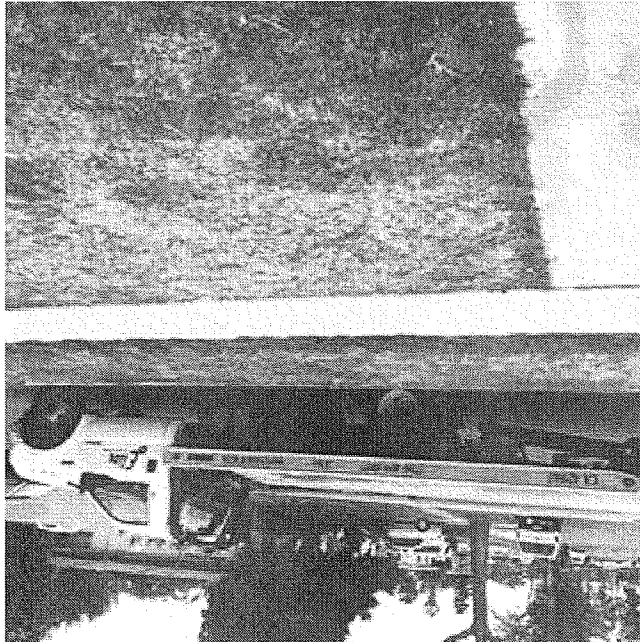


