Good afternoon everyone. I am writing you in order to have some dialogue regarding the policy of no parking on my street, Stanford Ave, on Sundays. I would like to know why and when this policy was created. As a seven year

resident, I have received a couple of citations, one of which I just paid for, Citation GP427003.

I recognize that we are extremely understaffed.

I have received a few street sweeper tickets over the years and paid them with no hesitation. This was the first time getting a Sunday parking ticket. I have witnessed people parking on the South side of Stanford every Sunday, for the past seven years. I have requested officers to come out and issue them a citation more than a few times. If they don't make a ton of noise from setting off their car alarms, arguing with each other, have screaming kids or create small traffic jams causing the oncoming traffic to lay on their horns, I just ignore the infraction.

My gripe is that it is a very seldom enforced policy. It is a confusing one too. There are breaks in the signage that make it look like it's OK to park there. Officers who have responded to calls from me have sometimes refused to cite people as they also have stated the signage is unclear.

I would like to better understand why I cannot park in front of my home on a Sunday. I am on the border of asking the city to remove this policy if the reason for it existing is not warranted. Perhaps a residential parking permit might solve the issue (whatever the issue is).

I look forward to your response and appreciate you taking the time to address this silly issue.



We have as many as 10 cars now parked across the street (Stanford Ave. between Wild Goose and Sutter) and in front of our house, and we know of more down the street towards Knott - from the condo residents behind us (who don't want to pay for an extra parking spot inside the condo tract). Since hubby has been retired, he has noticed that these are not all just used for work on weekdays (some are); instead, several of them do not get moved for more than 3 days during the week (or longer!) or until the sweeper comes by. Apparently the condo residents, or perhaps one or two of them are "**storing**" their extra vehicles on our street! One of the (junky-looking) trucks barely runs, and sounds awful when the guy moves it (seldom) and last time it spewed out bad smells from the exhaust. It's one thing to be using a car, but storing it on the street in someone else's neighborhood isn't right. Any thoughts?

Dale was kind enough to let you know about this recently; I am following up.

If I supply license plate numbers, can the PD run them and find out if more than one is

registered to the same person? We are pretty sure that someone is renting out one or more condos to several people, or a renter is sub-letting. We are wondering if this same person is buying and fixing then re-selling vehicles, although most we've seen are here for several months before they disappear and a different one takes its place, so we're not sure what's happening, and this condo group doesn't have a live-in manager to check with.

1. PROBLEM STATEMENT

In 2012, California traffic fatalities increased 1.5 percent (2,816 vs 2,857)- still one of the lowest levels since the federal government began recording traffic fatalities in 1975. California 2011 Mileage Death Rate (MDR)- fatalities per 100 million miles traveled is 0.88, and marks the third time California's has been below 1.0. Fatality rates increased 3 percent from 2010 to 2011, and are projected to increase in 2013 when final tallies are submitted.

Alcohol-impaired driving fatalities (fatalities in crashes involving a driver or motorcycle rider (operator) with a blood alcohol concentration (BAC) of 0.08 grams per deciliter (g/dL) or greater) matches our historic low of 774 in 2010 and 2011. The 774 figure is the lowest DUI death total ever. As a percent of total fatalities, alcohol-impaired fatalities decreased from 29 percent in 2010 to 28 percent in 2011 to 180,212 as compared to 195,897 in 2010. The 2011 DUI arrest figure represents the lowest DUI arrest since 2002.

For the second year in a row, OTS commissioned an observational survey of cell phone use by drivers within the state, looking for hand-held and hands-free talking as well as texting and other use of mobile devices while driving. The overall rate was 10.8 percent of drivers on the road using cell phones at any given daylight time, up from 7.3 percent in 2011. Although observed cell phone use increases were seen across all age groups, 16-25 year olds showed a dramatic rise, doubling from 9 percent to 18 percent. Distracted driving violations continue to be one of the most common cited violations by Garden Grove Police Department officers.

The problem of drugged driving continues to rise. Based on data from the National Highway Traffic Safety Administration, 30 percent of all drivers who were killed in motor vehicle crashes in California in 2011 tested positive for legal and/or illegal drugs, a percentage that has been increasing since 2006.

In the City of Garden Grove, we had 4 fatal traffic collisions in 2015. Of the 4 fatal collisions, 3 were pedestrian involved. The City of Garden Grove has a high concentration of people frequently use bicycles or travel by foot rather than automobile. Although an outreach program has been put into effect regarding bicycle and pedestrian safety in the City, we still have a high incidence of bicycle and/or pedestrian collisions. These collisions result in a high number of injuries each year.

Statewide, motorcycle fatalities increased 4.6 percent from 415 in 2011 to 435 in 2012. Motorcycle fatalities per 100,000 motorcycle registrations fell from 49 in 2009 to 44 in 2010. This rate had been relatively steady, averaging 68 from 2005 through 2008. Motorcycle safety has become an issue recently in the City of Garden Grove. Aside from numerous injury collisions and 1 fatal motorcycle in 2013. These injuries to officers resulted in hundreds of man-hours of traffic enforcement, putting the citizens of Garden Grove at even greater risk.

Over the years, approximately 60-75 percent of fatal and injury-combined collisions involved various Primary Collisions Factors (PCF) such as DUI, speed, right-of-way, traffic signals and signs, pedestrian violations, and improper turning.

The Garden Grove Police Department has noticed several arrestees are not showing up for their court dates, and are subsequently issued arrest warrants for not appearing. This enables “repeat-offending” and allows the public to once again be put at risk by the conscious negligence of an impaired driver. The same issues arises with the driver’s whom have had their driver’s licenses recently suspended. Several traffic isolators are stopped daily and are found to have suspended driving privileges. This happens as close as the courtroom parking lot, where the violators drive away directly after having their driver’s license suspended.

B. Phase 2 - Program Operations (Throughout Grant Year)

C. Phase 3 – Data Collection & Reporting (Throughout Grant Year)

Hello my name is [REDACTED]. I'm hoping this is the correct department to contact in regards to my current concern/issue. Recently on July 4th, 2016 my car was towed for reasons I am having trouble understanding. Like any apartment complex these days finding parking is difficult. I am granted one parking spot and the rest is first come first serve out on the street. Usually finding parking is near impossible by the time I get off work I have to hope there is any available space for me and my girlfriend to park. This past weekend was no exception. I arrived home late in the evening around 5 to find there was no parking. So I'm left with choices to either park in the red zone where a fire hydrant is stationed, park in a unauthorized zone near a business/school Argosy University that says its illegal to park there if not authorized (which no ones is unless you go there) and face the consequence of a fine or worse, or park blocking the entrance gate of a apartment entrance. I instead found a location where I would be out of the way of all cars in the most convenient and yet only responsible way possible to park. I took photos just in case because I knew it wasnt the ideal location to be and yet the next morning I arrive to find that my car was unfairly towed. I now had to pay \$300 for my car while trying to manage to attend school. I paid it and the police officers in the station said that I should contact my local city hall to file for an appeal for this doing. I tried to understand but I'm not sure where I was expected to park for my living situation.
