Nomenclature, specifications, and Capabilities of Rifles in use.

**Nomenclature:** The issued patrol rifle at the Garden Grove Police Department is the Sig Sauer M400 Enhanced Rifle. Duty ammunition for the rifle is the Winchester Ballistic Silvertip, .223 caliber, 55 grain.

**Specifications:** The rifle is equipped with a 16" barrel and collapsible Magpul stock allowing for shortening the rifle for storage and adjustments to the individual operators. The rifle is issued with 4, 30-round Magpul Generation 3 magazines, each loaded to 28 rounds. A two-point, Viking Tactical (VTAC) sling is affixed to each rifle which allows multiple carrying options and quick transition to other weapons when necessary. An Eotech hologram sight and backup iron sights (BUIS) are affixed to the picatinny rail on the receiver top. Each officer is issued a rifle carrying bag and a thigh-rig for carrying the issued magazines.

**Capabilities:** By issuing each officer their own rifle and related equipment, the Garden Grove Police Department enhances the officer's confidence should the rifle be required in the field to address a deadly threat. The rifle provides longer range and increased firepower with more accuracy compared to other standard police weapons. The easy-to-use system and enhanced confidence will result in fewer rounds fired, more accurate shot placement, and better terminal effect on intended targets should deadly force be necessary.

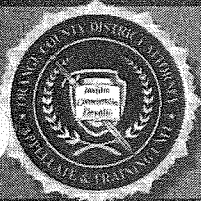

## DRIVING WHILE ADDICTED TO A DRUG

Vehicle Code Section 23152(c) criminalizes driving while addicted to the use of any drug. This bulletin discusses those elements, as well as suggestions for investigating and prosecuting an “addicted while driving” charge.

### PROSECUTION STRATEGIES:

#### PROVING ADDICTION

Vehicle Code Section 23152(c) makes it unlawful for a person who is addicted to the use of any drug to drive a vehicle. The term “addicted” is not defined in the statute itself. Rather, CalCrim 2112 requires that the People prove that the Defendant:

1. Has become physically dependent on the drug, suffering withdrawal symptoms if he or she is deprived of it;
2. Has developed a tolerance to the drug's effects and therefore requires larger and more potent doses; and
3. Has become emotionally dependent on the drug, experiencing a compulsive need to continue its use.

Under Section 23152(c), a person is addicted when he “has reached the point that his body reacts physically to the termination of drug administration.” *People v. O'Neil* (1965) 62 Cal.2d 748, 753. The purpose of the statute is to protect the public from the potential danger that an addicted person poses. *Id.* Courts have described addiction as “more a process than an event.” *People v. Duncan* (1967) 255 Cal.App.2d 75, 78 (internal citations and quotation marks omitted). In fact, the second two elements required by CalCrim 2112, namely: “emotional dependence and tolerance” have been found to be “descriptions of stages in the process which ultimately results in addiction.” *Id.* Some factors to consider in determining addiction are:

#### WITHDRAWAL ILLNESS/SICKNESS:

The People are not required to prove that the Defendant was in an *actual state* of withdrawal while driving. *People v. O'Neil*, 62 Cal.2d at 754. If withdrawal sickness is not proven, however, “the People must establish not only that [the Defendant] would exhibit such symptoms if he were deprived of his dosage, but also that he is emotionally dependent on the drug and that he has developed a tolerance to it.” *People v. Duncan*, 255 Cal.App.2d at 78-79.

If the People *can* prove that the Defendant was suffering from withdrawal sickness while driving, it “is the unmistakable signal that the user is addicted.” *Id.* at 78. Courts have identified the following common symptoms of withdrawal illness (aka abstinence syndrome):

1. Yawning	6. Muscle aches
2. Lacrimation	7. Hot and cold flashes
3. Sweating	8. Vomiting (when the withdrawal illness reaches its peak)
4. Pupillary dilation	9. Diarrhea (when the withdrawal illness reaches its peak)
5. Abdominal cramps	10. Fever (when the withdrawal illness reaches its peak)

**MORE THAN HABITUAL USE:**

Establishing “habitual use” is not enough to prove that a Defendant is guilty of violating Vehicle Code Section 23152(c). See *O’Neil*, 62 Cal.2d at 754. The Court distinguished addiction from habitual use, explaining that a person is an addict if he or she “has become physically dependent upon the use of narcotics [and] undergoes the *abstinence syndrome* or *withdrawal illness* upon the sudden cessation of drug administration.” *Id.* at 753.

**POLICE OFFICER AS AN EXPERT:**

In *Duncan*, the court found it proper for an officer with no formal medical degree or medical training to testify as an expert to “identify withdrawal symptoms and to express an opinion of addiction based upon those symptoms.” *People v. Duncan*, 255 Cal.App.2d 75 at 77. In that case, the court explained that the officer had served for almost 20 years as a police officer with his principal duties related to working with narcotics addicts, had examined approximately 2,000 to 3,000 addicts, spoken with numerous addicts as well as doctors, received training regarding the symptoms of narcotics’ addicts and read many books on the topic. The officer had also received first aid training as well as instruction in elementary psychology.

**DEFENSE TO VC 23152(c):** Vehicle Code Section 23152(c) does not apply to individuals participating in an approved narcotic treatment program using controlled substances such as methadone, levoalphacetylmethadol (LAAM), buprenorphine products or combination products approved by the FDA for maintenance or detoxification of opoid dependence, or any other federally approved controlled substances used for the purpose of narcotic replacement treatment. See Health and Safety Code Section 11875.

**MISDEMEANOR ONLY:** There is no comparable felony for “driving while addicted.”

**LAW ENFORCEMENT STRATEGIES:** Objective signs to document and investigative questions to ask:

## AREAS OF FOLLOWUP

Remember that when dealing with drug addicts and this specific Vehicle Code Section, you are looking for how the addiction affects both their driving *and* their daily life. Most people have a daily routine that involves starting their day with tasks such as eating, showering, etc. People who are addicted to drugs are thinking about other tasks such as where they are going to get their fix and when. This presents a starting place for these investigations in terms of discussing what the suspect does during the course of the day.

I have finished my off site file review. There is only one issue that I need you to address. In standard 84.1.6 on evidence inspections, you only included one report in bullets a and d. Since this is a time sensitive standard, and your policy specifies these inspections occur quarterly, you have to include two inspection proofs for each year (2013, 2014, and 2015). This is according to Appendix G. I am not going to copy Dan on this email so that you can find the other reports and enter them before I officially finish.

I know in the old days this would have been a file maintenance issue. We don't worry about that in Gold Standard. As long as you can show me you met your policy requirements and CALEA requirements, I will be happy.

I also did not finish chapter 72 on holding facilities. From what I have read, I want to discuss this on site and see if this chapter actually applies to your agency. Remember, the Holding Facility is defined as one which holds prisoners NO LONGER than 72 hours. Since it looks like you run a traditional jail, your facility may not fall under CALEA. This can be handled on site and is not a big deal for me to finish now.

I also have a question about Civil Process in Chapter 74. You put in information on how subpoenas for officers are handled, but the standard is really more closely designed to address if you serve restraining orders, subpoenas to civilians, and

other court orders. This can be discussed on site as well and is easily met with a quick interview.

**Subject: Need for Vigilance in Light of Terror Attacks in Brussels**

Multiple coordinated attacks on Tuesday morning struck Brussels, Belgium, including two explosions at the Zaventem International Airport and one at the Maalbeek Metro Station, resulting in dozens of fatalities and hundreds of injuries. The Belgian government has raised its terror alert to the country's highest level and Belgian citizens have been advised to continue to shelter in place as police search for individuals linked to the attacks.

These events underscore the need for continued vigilance for all California public safety, emergency response and law enforcement officials. While these events are taking place abroad, we remain alert to the possibility that individuals inspired by or in support of these acts may take action here in California. We remain particularly concerned about officer safety given the number of incidents of radicalized individuals targeting uniformed or law enforcement personnel.

All public safety, emergency response and law enforcement officials should remain vigilant and in close contact with local, state and federal partners, and immediately report any unusual or suspicious activity through proper channels. State and local agencies remain on the front line and can serve as critical tripwires for disrupting this threat.

There is currently no specific or credible information linking the attacks to the United States, according to the U.S. Department of Homeland Security. Cal OES and California's six Fusion Centers are coordinating closely with U.S. law enforcement and intelligence agencies and U.S. officials continue to monitor developments in Brussels.



Well the time is quickly approaching for our CALEA onsite inspection, which is to take place next week from March 29 to April 1, 2016.

It will take a concerted effort by all personnel to do well in the inspection, and I believe we can and will do well.


I want to discuss some topics prior to the arrival of the CALEA assessors: Chief Daniel Boring, Ret'd, Culpeper, Virginia Police Department and Lieutenant Darrin Abbink, Colorado Springs Police Department.

1. For all non-uniformed personnel, please wear your department issued ID cards and make sure they are visible.  
Also, if you bring a visitor into the PD, then please use the Department protocol of checking them in with the front desk for a visitor's ID badge.
2. If your work space has any memes that may seem offensive to any person, then please remove them for the inspection.  
It's also a good time to tidy up the work space too.
3. The CALEA assessors will be working out of the upstairs PD East Conference room, so the majority of their time here will be upstairs conducting interviews.
4. If you are lucky enough to be interviewed by a CALEA assessor, then they wanted me to pass on this information: The nature of the questions asked are general knowledge to your position. They added that there are no trick questions.  
I have reviewed three prior assessment reports completed by the lead assessor and he really likes when personnel exude professionalism with a positive attitude towards the organization.
5. The area of focus for the CALEA assessors will be the Records Division, which means they will generally assess the overall operations of Records and provide some input, suggestions, and advice, if any is needed. With that being said, only personnel who work within the Records Division will have electronic access into Records for the inspection week.  
This is being done to limit the amount of foot traffic into Records. All work related access privileges into Records will be restored after the on-site assessment.
6. Ride-Alongs will take place with patrol officers and the Lieutenant Watch Commanders will choose which patrol personnel shall have the assessor ride-along.
7. CALEA is an acronym for Commission on Accredited Law Enforcement Agencies. We were first accredited back in 1988 and we are seeking our ninth re-accreditation next week.

Our police department has been part of a national accreditation program, Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA), since 1988. National accreditation is a voluntary process and the award is a highly prized recognition of law enforcement excellence for a period of four years. A team of assessors from CALEA will arrive on March 29, 2016, to examine all aspects of the police department's policies and procedures, management, operations and support services. The assessors from CALEA are Chief Daniel Boring, Ret'd, Culpeper, Virginia Police Department and Lieutenant Darrin Abbink of the Colorado Springs Police Department.

A major part of their on-site review includes a tour of our facilities, an observation of our activities, ride-alongs with our officers and interviews with members of our department, city hall management, local community members, judges, attorneys, local media, and city council members.

The reassessment period of 2013 through 2015 will be the focus of their visit and they will highly scrutinize our CALEA staff's efforts to document the Department's adherence to the applicable 484 CALEA standards. During the three year reassessment period, our agency has submitted annual reports attesting to continued compliance with mandated standards and our ability to maintain up-to-date policies with respect to current laws.

Once the Commission's assessors complete their review of the agency, they report back to the Commission, which will then determine if our police department is to be granted reaccredited status until the year 2020. I fully expect to be reaccredited based on the efforts put forth by the police department's CALEA staff members involved in this endeavor and because of the constant professionalism exuded by all members of our police department.

## **History with CALEA**

The Law Enforcement Accreditation Program was established by CALEA after its founding in 1984. CALEA, a private organization, was established to address what was seen as a need to enhance law enforcement as a profession and to improve law enforcement service delivery. The CALEA Accreditation program has become the primary method for an agency to voluntarily demonstrate their commitment to excellence in law enforcement.

In 1985, then Garden Grove Police Chief Frank Kessler embarked on a three-year self-assessment program with CALEA to achieve National Accreditation. In 1988, the Garden Grove Police Department was the first Police Department in California to receive the CALEA Accreditation award. As of today, only 14 other law enforcement agencies within the State of California has achieved and sustained the CALEA Law Enforcement Accreditation award.

The Police Department has successfully completed CALEA reaccreditation every three years to maintain the continuous award. The upcoming March 2016 on-site assessment will be the ninth time the Department has sought reaccreditation. The process will scrutinized the years 2013-2015 via the Gold Standard Assessment review process.

## Garden Grove Police Department And The CALEA Gold Standard Assessment

CALEA introduced a new methodology for assessing agencies seeking reaccreditation. Known as the Gold Standard Assessment (GSA), this assessment format focuses primarily on processes and outcomes associated with standards specific to agency policies. **In short, the GSA works to measure the impact of accreditation as opposed to simply confirming compliance through a file-by-file review.**

The GSA allows for a limited number of specific files to be reviewed off-site prior to the on-site assessment. Agencies participating in the GSA will generally have no files reviewed during the on-site assessment. **Further standards compliance is verified through interviews and observations in the normal work environment where the specific activities are expected to occur.**

The GSA provides insights into opportunities for process improvements and it identifies areas where data is effectively or ineffectively being used to support operational or administrative activities. **In short, the GSA reviews key issues for the agency and identifies strengths, weaknesses, opportunities, and threat as it relates to standards-based issues.**

Agencies that have participated in the GSA have consistently indicated it is the most effective use of accreditation as an organization growth tool, and it has involved more of their staff in the process. **The GSA moves the accreditation process from a file management exercise to an assessment of intended outcomes based specifically on agency needs.**

Visible video camera surveillance systems are a great deterrent to potential thieves and they provide for a greater sense of safety to employees. When video surveillance captures a crime in progress, our police officers are trained to immediately review the footage to gather as much information about the suspect. A crime captured on video surveillance is a critical component in solving the case, which inevitably provides for a successful prosecution and conviction of the perpetrator.*

*Within the last year, the Garden Grove Police Department has solved many serious crimes that were captured on a business video surveillance system. One such case involved mail thefts that were occurring throughout the west end of Garden Grove during the tax season of 2015. These thefts turned into several identity theft victims losing thousands of dollars at multiple businesses and financial institutions. Surveillance video from Target, Walmart, and other bank ATM machines helped identify the suspects committing these crimes. This helped in the successful prosecution of the suspects involved and video surveillance was credited with solving a crime trend.*

*Another case in 2015 involved a two suspects armed with firearms who robbed a local gas station. The gas station had a very good video surveillance system, which captured the robbery in its entirety. The surveillance video was released to the media, which resulted in an*

*anonymous tip that lead to the identification and arrest of one of the suspects. Information from the first arrested suspect allowed police detectives to identify and eventually arrest the second suspect. The first suspect pled guilty to robbery is presently in jail. The second suspect is now awaiting trial and is expected to face a lengthy prison term upon conviction.*

*In closing, a video camera surveillance system is the smart way for any business owner to create a working environment that provides a sense of safety and security to customers and employees.”*
