

ORDINANCE NO. 1316

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE REPEALING A CHAPTER OF THE GARDEN GROVE MUNICIPAL CODE AND BUILDING AND RELATED CODES AND ADOPTING BY REFERENCE THE FOLLOWING CODES WITH CERTAIN AMENDMENTS, DELETIONS AND ADDITIONS THERETO: UNIFORM BUILDING CODE VOLUME I, 1970 EDITION; UNIFORM BUILDING STANDARDS FOR VOLUME I, 1970 EDITION; UNIFORM MECHANICAL CODE 1970 EDITION; UNIFORM BUILDING CODE VOLUME III, HOUSING 1970 EDITION; UNIFORM BUILDING CODE, VOLUME IV, DANGEROUS BUILDINGS, 1970 EDITION; UNIFORM BUILDING CODE, VOLUME V, SIGNS, 1970 EDITION; UNIFORM PLUMBING CODE 1970 EDITION; NATIONAL ELECTRIC CODE 1971 EDITION; and UNIFORM FIRE CODE 1971 EDITION

THE CITY COUNCIL OF THE CITY OF GARDEN GROVE DOES ORDAIN AS FOLLOWS:

SECTION 1: The following ordinances are hereby repealed: Ordinance Nos. 521, 638, 818, 850, 1009, 1010, 1011, 1012, and 1013.

SECTION 2: The following listed codes with amendments, additions and deletions thereto are hereby adopted by reference:

UNIFORM BUILDING CODE, VOLUME I, 1970 EDITION including Appendix and Exhibit "A"

UNIFORM BUILDING STANDARDS FOR VOLUME I, 1970 EDITION

UNIFORM MECHANICAL CODE, 1970 EDITION, including Appendix "C" only and Exhibit "A"

UNIFORM BUILDING CODE, VOLUME III, HOUSING, 1970 EDITION excluding Appendix, but including Exhibit "A"

UNIFORM BUILDING CODE, VOLUME IV, DANGEROUS BUILDINGS, 1970 EDITION, and Exhibit "A"

UNIFORM BUILDING CODE, VOLUME V, SIGNS, 1970 EDITION, and Exhibit "A"

UNIFORM PLUMBING CODE, 1970 EDITION, including Appendixes "A" through "G" and Exhibit A

NATIONAL ELECTRIC CODE, 1971 EDITION, and Exhibit "A"

UNIFORM FIRE CODE, 1971 EDITION, including Appendixes and Exhibits "A" and "B"

SECTION 3: Three copies of the codes referred to hereinabove, with all amendments, deletions and additions thereto, are on file with the City Clerk and are open to public inspection.

SECTION 4: Chapter 18.08 of the Garden Grove Municipal Code, Revised, is hereby repealed.

SECTION 5: This ordinance shall take effect thirty (30) days after adoption and shall within fifteen (15) days of adoption be published with the names of the Councilmen voting for and against same in the Orange County Evening News, a newspaper of general circulation, printed, published and circulated in the City of Garden Grove.
