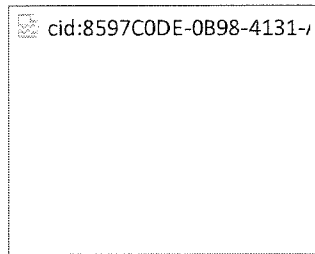

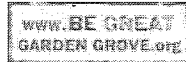

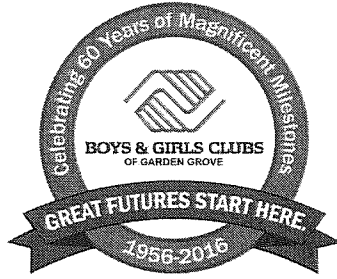

Mr. Stiles and City Council,

In follow up to my e-mail below and in anticipation of tonight's 2016-2017 budget discussions, we citizens strongly urge you Mr. Stiles and our city council to place keen focus on our law enforcement needs.

It is no secret that for many years GGGPD has been doing so much with very little, but our police department, business owners and citizens are now beyond our breaking point. In the past our GGGPD and our citizens were able to get away with very low police staffing, but since our crime rate has become the highest in Orange County we must now address this priority issue not with talk but with action.

It has been well established in policing that the optimal level of staffing is 1.0 to 1.2 officers per 1000 population. According to our 2015-2016 budget, our population is 174,774 which means the number of sworn police officers in our city should be approximately 206.

We at this time request that this e-mail be part of tonight's budget discussion and entered into the minutes/record of tonight's meeting.

Subject: Garden Grove's Uncontrolled Crime Rate

Bao,

Please accept this e-mail as a follow up to my presentation at the city council on Tuesday, May 24, 2016.

As I've stated on more than one occasion at this and other city council meetings, our crime rate appears to be out of control and you don't appear to have a plan to combat the crime in our city. It is well known and well documented that Garden Grove's crime rate is among the highest in Orange County (see attachment 1) while our police to population ratio is among the lowest in our county, state and possibly in our Nation. From what I can gather from our past

and present city budget(s), our levels of police staffing are presently at 1985 levels that have not kept pace with our development strategies, high density housing policies and/or population growth.

Keeping in mind that we citizens have been told time and again that the revenues being generated from the hotels and hotel visitors tax along Harbor Boulevard are in the millions, we citizens are not realizing the benefits. It has also been reported that the city will receive an estimated \$8 million in annual tax revenue from the Great Wolf Lodge Resort alone, according to city documents. (see attachment 2) Even with all of this taken into account, the quality of life has diminished in Garden Grove with the crime rate in an upward spiral that you and our council have not yet addressed.

In talking with many other citizens, we believe that you should be less focused on your congressional campaign and more engaged with our city staff in exploring, finding and implanting ways to reduce our crime rate. If there are revenue and/or budget concerns, may we suggest that you shift your time and energy away from your marijuana campaign fund raising priority (see attachment 3) and use that same time and energy into working with GGPD, city staff, consultants and/or citizens in reducing the crime and crime rate here in Garden Grove.

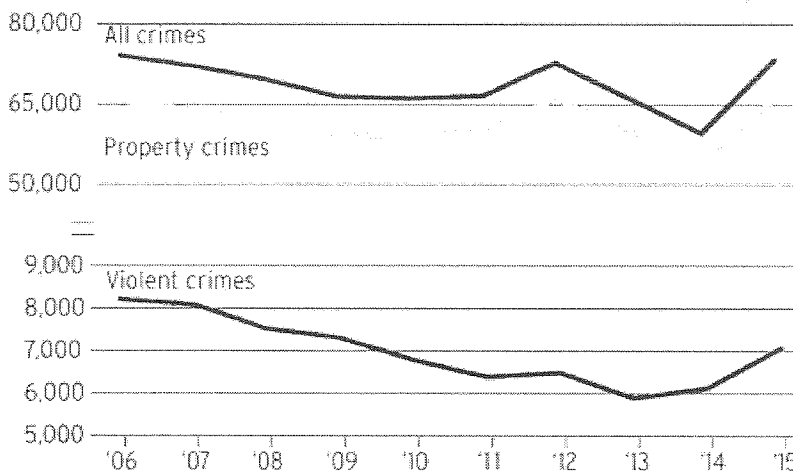
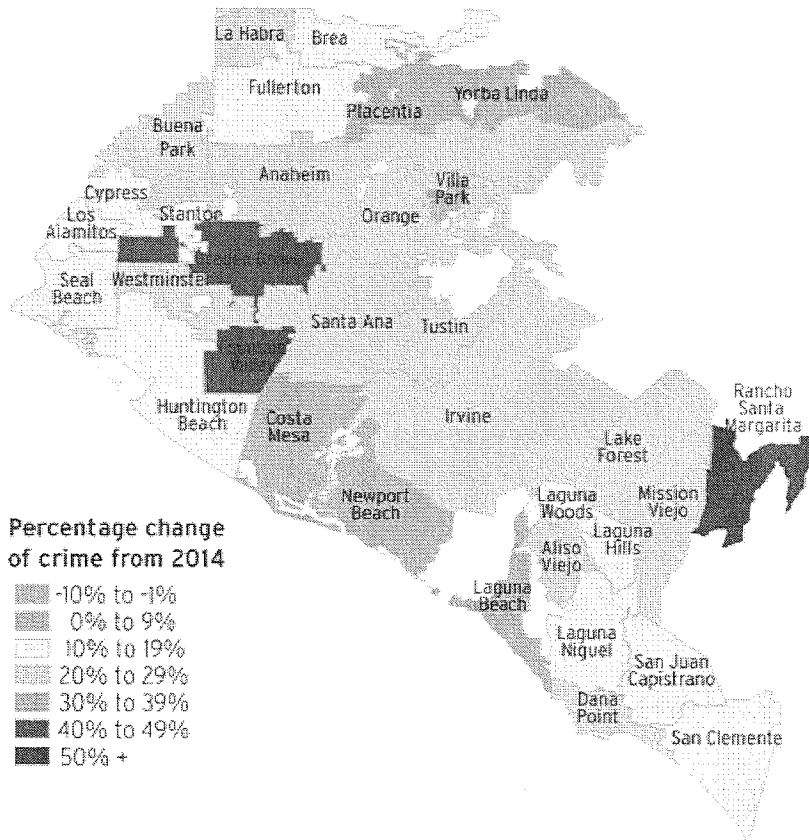

It is no secret that for many years GGPD has been doing so much with very little, but our police department, business owners and citizens are now beyond our breaking point. In the past our GGPD and our citizens were able to get away with very low police staffing, but since our crime rate has become the highest in Orange County we must now address this priority issue not with talk but with action.

It has been well established in policing that the optimal level of staffing is 1.0 to 1.2 officers per 1000 population. According to our 2015-2016 budget, our population is 174,774 which means the number of sworn police officers in our city should be approximately 206.

We at this time request that this e-mail be part of tonight's budget discussion and entered into the minutes/record of tonight's meeting.

Bao,

Please accept this e-mail as a follow up to my presentation at the city council on Tuesday, May 24, 2016.

As I've stated on more than one occasion at this and other city council meetings, our crime rate appears to be out of control and you don't appear to have a plan to combat the crime in our city. It is well known and well documented that Garden Grove's crime rate is among the highest in Orange County (see attachment 1) while our police to population ratio is among the lowest in our county, state and possibly in our Nation. From what I can gather from our past and present city budget(s), our levels of police staffing are presently at 1985 levels that have not kept pace with our development strategies, high density housing policies and/or population growth.

Keeping in mind that we citizens have been told time and again that the revenues being generated from the hotels and hotel visitors tax along Harbor Boulevard are in the millions, we citizens are not realizing the benefits. It has also been reported that the city will receive an estimated \$8 million in annual tax revenue from the Great Wolf Lodge Resort alone, according to city documents. (see attachment 2) Even with all of this taken into account, the quality of life has diminished in Garden Grove with the crime rate in an upward spiral that you and our council have not yet addressed.

In talking with many other citizens, we believe that you should be less focused on your congressional campaign and more engaged with our city staff in exploring, finding and implanting ways to reduce our crime rate. If there are revenue and/or budget concerns, may we suggest that you shift your time and energy away from your marijuana campaign fund raising priority (see attachment 3) and use that same time and energy into working with GGPD, city staff, consultants and/or citizens in reducing the crime and crime rate here in Garden Grove.

Per our discussion, the Orange County Mosquito and Vector Control District has confirmed the first mosquito sample infected with West Nile virus (WNV) in the City of Garden Grove.

The mosquitoes were collected in mosquito traps from a residential area near Garden Grove Boulevard and Newhope Street.

Our teams will be posting the area (poster attached). We will also be sending crew members to alert residents to the detection of WNV, and preventative measures they can take to protect themselves and their families from mosquitoes and WNV.

A couple weeks ago, you should have received outreach materials regarding West Nile virus, Zika virus, and invasive mosquito species to help educate the city residents about mosquito control. We would be happy to provide additional materials for distribution to your city residents, please contact me to request more.

At this time, please advise city residents to take precautions and wear mosquito repellents when mosquitoes are most active (dawn or dusk).

Please utilize any and all communications tools you may have to help spread the word (please let me know so we can also follow and share your efforts).
