A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GARDEN GROVE CERTIFYING THAT THE CITY HAS THE RESOURCES TO FUND THE PROJECTS SUBMITTED FOR INCLUSION IN THE 2015 FEDERAL TRANSPORTATION IMPROVEMENT PROGRAM AND CONFIRMING THE CITY'S COMMITMENT TO IMPLEMENT ALL THE PROJECTS SUBMITTED TO THE PROGRAM AND HAS THE RESOURCES TO FUND THE PROJECTS IN THE FISCAL YEAR 2014/15 THROUGH 2019/20 TRANSPORTATION IMPROVEMENT PROGRAM AND AFFIRMS ITS COMMITMENT TO IMPLEMENT ALL PROJECTS IN THE PROGRAM

WHEREAS, the city of Garden Grove is located within the metropolitan planning boundaries of the Southern California Association of Governments (SCAG);

WHEREAS, the City desires to include the projects submitted to the Orange County Transportation Authority's (OCTA) Federal Transportation Improvement Program (FTIP);

WHEREAS, the City warrants that it has committed funding for it's share as required and accepts responsibility to fully implement for the projects submitted;

WHEREAS, the City is the lead agency for projects and will comply with applicable local, state, and federal provisions including the Federal Transportation Improvement Program, California Environmental Quality Act, National Environmental Policy Act, American with Disabilities Act, and Buy America;

WHEREAS, the City agrees to the amendments to the projects as shown in the 2015 FTIP;

WHEREAS, the City possesses legal authority to submit the projects for inclusion in the FTIP and to finance and construct the projects as noted in the amendments;

WHEREAS, the City agrees to finance and construct Transportation Control Measure projects as noted in the amendments in a timely manner; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Garden Grove does hereby affirm the City's commitment to the projects submitted in the 2015 Federal Transportation Improvement Program.
