Bees pollinate a significant majority of the world's food — and these vital pollinators are in serious trouble.

In North America alone, honey bees pollinate nearly 95 kinds of fruits and nuts, including almonds, avocados, cranberries and apples. Each of us relies on bees — and the pollination services they provide — every day. But bees and other pollinators are reaching a tipping point, with beekeepers reporting annual hive losses of a third or more in recent years.

What's at the root of this alarming trend? Scientists agree there are multiple, interacting causes at play, including pathogens, nutrition and habitat loss — and **pesticide exposure** is a key factor, exacerbating other stressors.

Federal policymakers are moving too slowly to implement pollinator protective policies, but bees need meaningful action — and they need it now.

We need you to protect our future food sources and our children's sustainability by voting NO to aerial spray - Vector Control is above all laws and are the major culprit of the demise of our pollinators - it is time to be the change we need to see.

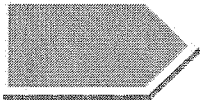

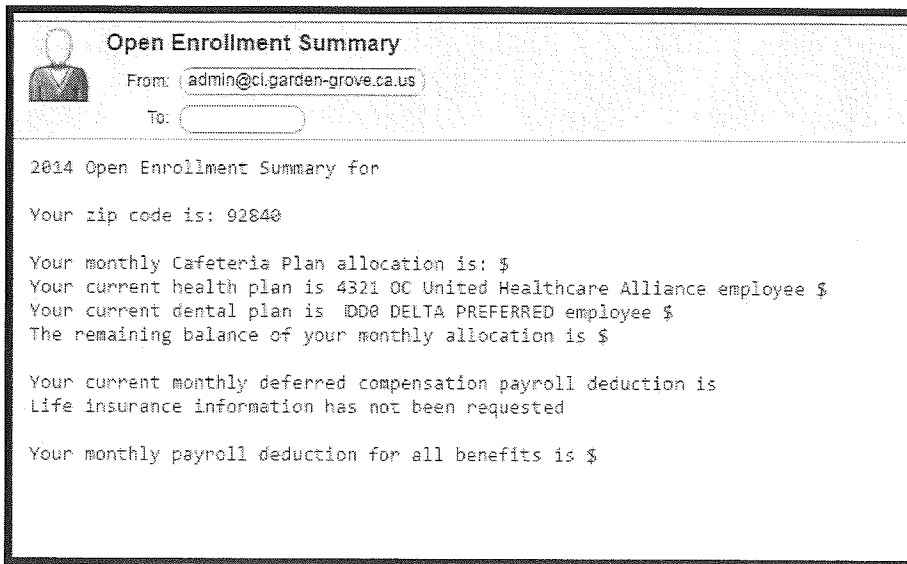

LIFE INSURANCE OPTIONS

What is Term Life Insurance?

Term Life Insurance is a policy that pays a benefit for a particular term. For the City, the term is employment. It is effective the first of the month after your hire date, and cancelled on your separation or retirement date. The City has two types of Term Life Insurance, a City paid group policy, which covers all full-time employees, and an Optional Additional Term Life Insurance policy, which is paid by the employee.

Lincoln Life Insurance - City Paid

All full-time employees are provided with a City paid life insurance policy equal to one year of your annual base salary, rounded up to the nearest thousand (\$1,000) dollars to a maximum of \$300,000. The policy also includes a policy for your spouse/domestic partner and all children of \$5,000. The policy also has an Accidentally Death and Dismemberment (AD&D) provision that provides a benefit equal to the amount of your basic life insurance should you die accidentally. However, the AD&D provision is subject to certain exclusions and limitations.

To calculate your City Paid Life Policy, take your base monthly salary, multiply by 12 and round to the nearest thousand dollars. If your gross base salary is \$3,295 you will do the calculation below:

- Example: $\$3,295 \times 12 = \$39,540$ rounded to nearest thousand means your policy is for \$40,000.

Term Life Insurance - Employee Paid (optional additional)

You may choose to pay for additional life insurance coverage for yourself, your spouse/domestic partner and/or children. Premium payments are payroll deducted bi-weekly. Below is a chart of the cost per \$1,000 of additional coverage. Premiums are based on your age and the amount of coverage you elected.

Available Coverage Amounts:

- Employee - You may elect in multiples of \$10,000 up to \$500,000 coverage for yourself, however the policy amount cannot exceed 5x your annual salary.
- Spouse/Domestic Partner - You may elect up to 50% of our annual coverage for your spouse, in multiples of \$5,000.
- Children - You may elect up to \$10,000 coverage for your child(ren)
 - Eligible children must be under 21 years of age and unmarried, or under age 25 if maintaining full-time student status.

If you terminate your employment or become ineligible for coverage, you have the option to convert all or part of the amount of coverage in force to an individual life policy on the date of termination without completing a new Evidence of Insurability. Conversion election must be made within 31 days of your date of termination.

LONG TERM DISABILITY

The City does not pay into State disability. Instead, we have self-funded plans for bargaining units. Please visit the Open Enrollment website to view your LTD benefits.

For Employee's Association & Employee's League Only

You have the option to enroll in the "buy up" plan, which reduces your waiting period from 90 days to 60 days. Make sure to read about this optional benefit and if you are interested in enrolling, do so when completing your Open Enrollment this year.

FLEXIBLE SPENDING ACCOUNT (FSA)

Regular, full-time employees are eligible to participate in the Flexible Spending Account (FSA) if they enroll within the program eligibility guidelines. This plan allows employees to reduce their cash compensation on a pre-tax basis and establish reimbursement accounts for out-of-pocket expenditures for child care and medical care expenses. Eligible expenses are then reimbursed on a non-taxed basis after they are incurred and paid by the employee. Federal law sets a number of severe restrictions on the use of this program, which include:

- Elections are made once a year and are irrevocable during the year except for certain changes in the employee's family status
- The two accounts cannot be commingled
- Any amounts not claimed during the plan year (January 1 through March 15 of the following calendar year) are forfeited by the employee
- Dependent care contributions are limited to \$5,000 annually, or \$2,500 if married and filing a separate tax return
- Health care contributions are limited to \$2,500 annually.

Employees must re-enroll in FSA accounts each year during Open Enrollment or they cannot participate.

Deadline to submit: October 7, 2016 at 4:00 p.m.

Reimbursement from Accounts

- A completed Reimbursement Request Claim Form must be submitted to Human Resources with all receipts attached.
- Funds designated in the Health Care account are available January 1 of that plan year. *(Example - If an employee designates \$260 [\$10 bi-weekly deduction from pay check] into the Health Care account and incurs expenses for \$260 January 1, he/she may submit and receive reimbursement for the full amount. The bi-weekly deduction will continue for the remainder of the calendar year.)*
- Funds designated in the Child Care account are reimbursed only as money is deposited into the account. *(Example - If an employee designates \$1,300 [\$50 bi-weekly deduction from pay check] into the Child Care account and submits receipts for \$300, he/she will be reimbursed \$50 per pay period until the balance of the receipt is zero.)*
- No checks will be issued for less than \$50, except to close an account.

DEFERRED COMPENSATION (457 PLAN)

A government 457(b) deferred compensation plan is a retirement savings plan that allows eligible employees to supplement any existing retirement and pension benefits by saving and investing before-tax dollars through a voluntary salary contribution. Contributions and any earnings on contributions are tax-deferred until money is withdrawn. Distributions are subject to ordinary income tax.

Traditional (Before-tax) and After-tax (ROTH) Contributions

The ROTH option gives you the flexibility to designate all or part of your 457 elective deferrals as ROTH contributions. ROTH contributions are made after-tax dollars.

Enrolling in Deferred Comp

If you would like to enroll in deferred comp, complete the enrollment form and return it Human Resources. You will need to make four decisions when completing the form:

- Which type of account do you want to participate in? Traditional (before-tax contributions, or ROTH (after-tax contributions).
- When do you want to start contributing? Your enrollment changes are always effective the first of the month. It does not have to be in January, you can start participating anytime.
- How do you want your account managed? Do it yourself, or enroll in the Managed Account Service (for a fee).
- Who do you want to be your beneficiary? You must have at least one primary beneficiary and will need their date of birth and social security number when completing the form.

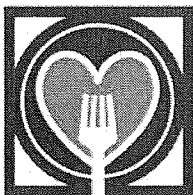

RESOLUTION

Republic of Vietnam Day

October 26

WHEREAS The Vietnamese American community of Garden Grove was originally a community of Vietnamese refugees consisting of the exiles of all backgrounds from the Republic of Vietnam fleeing their country after the Vietnam War, which was launched by the Vietnamese Communists from 1955 to 1975 and ended on April 30, 1975, in order to protect their lives and cultural heritage from being eliminated or possibly destroyed, and

WHEREAS During the Vietnam War the Government of the Republic of Vietnam and its armed forces, people, elected, and governmental officials struggled courageously and bravely to defend and protect the freedom, lives and property of the people, to safeguard the Republic and the more than democratic government created after the reestablishment of independence from French colonial rule, and

WHEREAS During the Vietnam War against the invasion of the Vietnamese Communists, the United States and its allied armies from Australia, South Korea, Thailand, New Zealand, and Philippines also made enormous contributions and sacrifices in protecting freedom, democracy, lives, and property of the Vietnamese people and the Republic of Vietnam, and

WHEREAS The Vietnamese American community with a population of nearly two million, consisting of many professionals and technical members, after four decades of migration has made tremendous contributions in all fields from culture to education, business and politics, economic and technology, electronics and internet, trading and financing, civil and military, and has contributed a significant effort to the maintaining of the development and protecting the fabric of the American society at the local, state and federal government levels, and

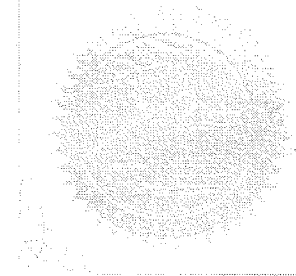

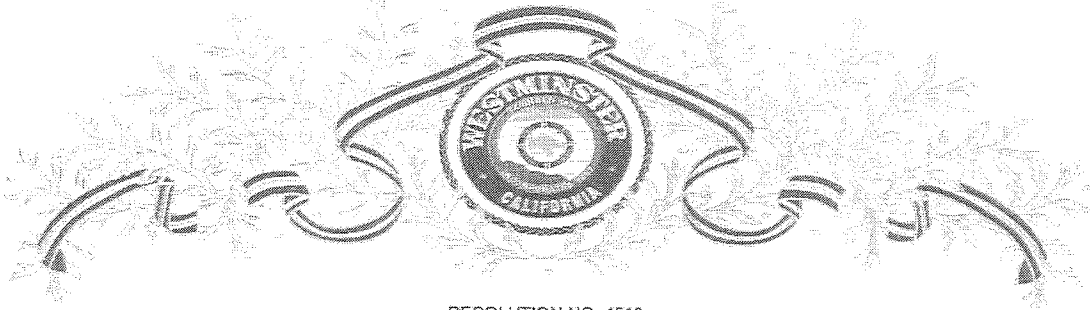

RESOLUTION NO. 4518

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER DESIGNATING OCTOBER 26TH OF EACH YEAR AS REPUBLIC OF VIETNAM DAY TO HONOR THE JUST CAUSE AND COMMEMORATE THE CONTRIBUTIONS AND SACRIFICES OF THE ARMY, PEOPLE, ELECTED AND GOVERNMENTAL OFFICIALS OF THE REPUBLIC OF VIETNAM AS WELL AS AMERICAN SOLDIERS, VIETNAM WAR VETERANS, ALLIED ARMIES AND THEIR FAMILIES

WHEREAS, the Vietnamese American community of Westminster was originally a community of Vietnamese refugees consisting of the citizens of all backgrounds from the Republic of Vietnam fleeing their country after the Vietnam War, which was launched by the Vietnamese Communists from 1955 to 1975 and ended on April 30, 1975, in order to protect their lives and cultural heritage from being damaged or possibly destroyed;

WHEREAS, during the Vietnam War the Government of the Republic of Vietnam and its armed forces, people, elected, and governmental officials struggled continuously and bravely to defend and protect the freedom, lives, and property of the people, to safeguard the Republic and the new born democratic government created after the reestablishment of independence from French colonial rule;

I would like to urge you to vote "NO" on aerial spraying. There is strong data that suggests it is neither safe nor effective.

Although the EPA claims it is safe, they have never conducted independent testing and simply only rely on data given to them by the chemical manufacturers themselves. Many health and environmental groups strongly state that indiscriminate spraying of pesticides, especially in heavily populated urban areas, such as Orange County, is far more dangerous to human health and the environment than a relatively small risk of West Nile Virus. Ironically, such spraying is especially dangerous to those with impaired immunity for whose 'protection' such spraying is mainly being done.

The CDC, EPA, and a large Harvard study all admit that it only reaches about 10% of the population of targeted adult mosquitos. I believe we can continue to encourage the dumping of water to reduce breeding grounds.

Again, I urge you to vote "NO" on aerial spraying for mosquitos. I thank you for your time.

Dear Mayor Nguyen,

My name is Verlin Richins and as a home owner in the city living in Chapman Commons adjacent to Pioneer park. I would like to make you aware of the return homeless campers in Pioneer Park.

At Chapman Commons we have experienced homeless people climbing over the wall between us and the park. Homeless people have been found sleeping within our condo community, trying to use the swimming pool showers, and defecating in our common areas.

I grew up in this city and am very happy with the improvements and more upscale approach the city has taken in the last decade. Homeless people camping in our parks moves us back to the old derogatory name of "Garbage Grove".

I am a compassionate person by nature and I feel for homeless people yet their living in Pioneer park makes the park no longer a family safe location. The homeless are living in the park 24 hours per day. At night many of them are hidden from view in the rear southeast corner behind outbuilding and other things but they are there. Their presence makes the park uninviting or even scary for families to take children to. Compassion toward the homeless in our city cannot extend to the level where the majority of residents do not feel safe in city parks. Please take action to remove the homeless from at least sleeping in Pioneer Park at night.
