Dear Trustees of Vector Control,

I have heard that it is possible a consolidated group of Trustees not representing all of the Cities in Orange County will vote to decide if Vector Control can “pull the trigger” as they like to call it and poison the County, our families, water and air.

It is imperative that education in many languages is offered to reduce standing water and overall education on personal precautions. The fear mongering Vector Control employs is ineffective and should immediately stop. Instead replace this with a thoughtful program to get the message home to every resident in Orange County. A darling mascot like Smokey the Bear who was loved and effective and his motto lives on to this day would be a much longer lasting solution to the small mosquito problem our desert of Orange County faces.

I am opposed to aerial spraying for many reasons – most of which are common sense and aerial spraying causes so many unintended repercussions as demonstrated with every pesticide sprayed by plane throughout history. Because Vector Control is exempt from all laws does not mean they should take such liberty of aerial spraying pesticides on my private home and property, compromising my health and harming my real property that I take great care to keep free from pesticides and harmful chemicals.

The pesticides uses to kill adult mosquitoes also kill other insects. Little is known about the effect of widespread long-term pesticide spraying on insect biodiversity, however, recent studies show we are loosing a great number of wonderful insects such as dragon flies and so many more at a alarming rapid rate. Studies have shown that butterflies are a risk from pesticide residues on vegetation. Bees and other pollinators will be grotesquely effected as the Duet label clearly states so. The effect on the myriad of small insects with which we share our world (moths, harmless wasps, etc.) is largely unknown. The morality of killing large numbers of non-target insects to control mosquitoes is debatable as well as the morality of harming so many families when we already know that pesticides harm us all and especially our children.

The spraying program is likely to have only short-term benefits. There are several studies that showed the effect of spraying on mosquito abundance lasted for just several days. The study

concluded: “The trials of this study showed that control was achieved for a few nights before the mosquito populations returned to pre-application levels.... Indications are that the findings in this study were primarily the result of repopulation by neighboring mosquito populations”.

EPA approval, does not mean there is no risk and some risks may be unknown or underestimated to human health, in fact the EPA does not APPROVE Duet as Vector Control would have you believe – it is actually against the law to state that a pesticide is safe or approved by the EPA – I would like Vector Control to clean up its act and stop pretending that every agency in our government endorses Duet.

Vector Control should consider another approach.

First emphasize personal protection to reduce the risk of mosquito bites. Wearing long-sleeved shirts and long pants when outdoors, using insect repellents, and fixing holes in window screens. Check for standing water weekly and to share with friends neighbors and family to do the same.

Vector Control because it is exempt from all laws should adhere to a standard that does not harm everyone and to put our health and pollinators in great harms way by their irresponsible use of pesticides, it is time they start being more accountable and responsible. 1. Executive Summary:

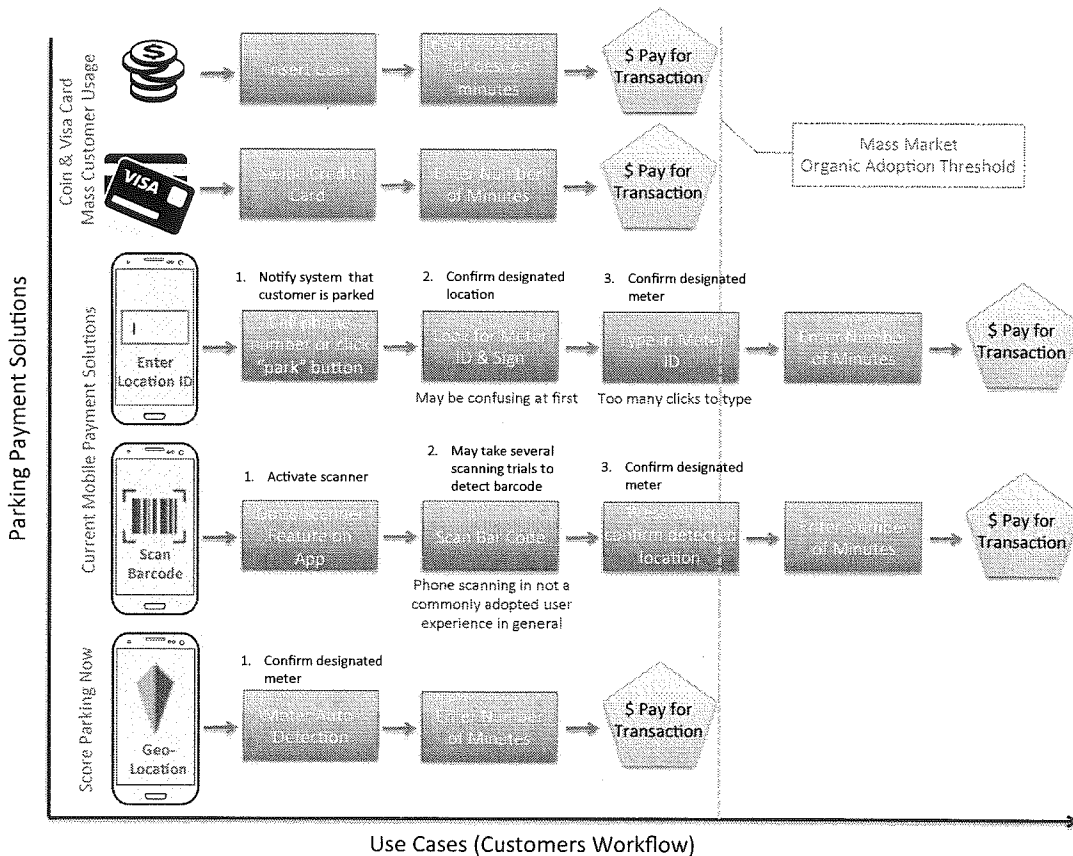
2.0 UNDERSTANDING OF SOLUTION BEING SOUGHT BY CITY

Score Parking Now is designed to increase the average rate of parking payment by at least 30% through ease-of-use, best in class user experience with geo-location meter detection, fast rate of adoption and mobility.

Score Parking Now designs reflect a virtual meter on the user's phone, which allows any parking customers to pay for parking via mobile phone or other wireless devices. Score Parking Now's interface mirrors the designated meter's look and feel, functionalities and regulations, including but not limited to city's parking hours, rates, and restrictions subjected to the parking location in real time.

2.1. Geo-location Meter Detection

Theme: “Heroes Road”-“Camino de los Heroes”

The Parade Check-In Area will be located in a **Parking Lot on 16th Street between Main and Bush**. Units entering the formation area must enter on 16th off Bush. **One person per entry must stop at the Check-in area to register and pick up the Parade Entry Number. This number must be displayed on the left hand side, of the front unit, clearly visible to the Parade Announcers.**

Formation/Unloading area: All buses and cars will **unload participants on Bush Street at 16th Street**. Participants are to walk to the spot on the street where their number is marked and are to re-assemble at that space. The Parade Entry numbers will be marked on the street (A map with numbers will be provided at check-in). **There is no parking for parade participants in the formation area.** All buses must be moved to the disbanding area, which is located near the end of the parade on Santa Ana Blvd., east of Flower St. Parade participants can park their cars at these locations: West of Broadway Street on 15th, and East of Bush on 16th & 15th; at the end of the parade at the Stadium Parking Structure for a minimal fee, the Parking Structure located in front of City Hall or at the Parking Lot west of the County Courthouse.

The Equestrian Formation is on **Sycamore Street, on the West Side and East Side of the Street, south of Washington**. Please enter the formation area through **10th and Sycamore where Equestrian Check-in is located**. One person must go to the Check-in to pick up Parade Entry Number. All Equestrian units will be escorted back to the starting formation area at the end of the parade by the Santa Ana Police Department.

The Float Formation entry is on **Main Street off 17th Street**. Your entry number will be marked on the street. Each float must be **inspected prior to entering the formation area**. Check-in and inspection is located on **Sycamore between 15th and 17th**. The float will be inspected and parade entry pass will be issued at this location. Inspections start at **9:00 a.m. and continue until 12:00 p.m.** Once inspection is complete successfully, floats are able to remain in this area until able to enter Parade Formation Area after 1:00pm.

The Parade Announcer area will be located on **Main St. and Civic Center Dr**. Bands are requested to perform several times during the entire parade route. Entries are also reminded that this is a **forward moving parade** - drills and routines must be performed while moving forward at all times. Again, all performances must be executed in a forward motion. (Stopping to perform causes gaps in the parade). 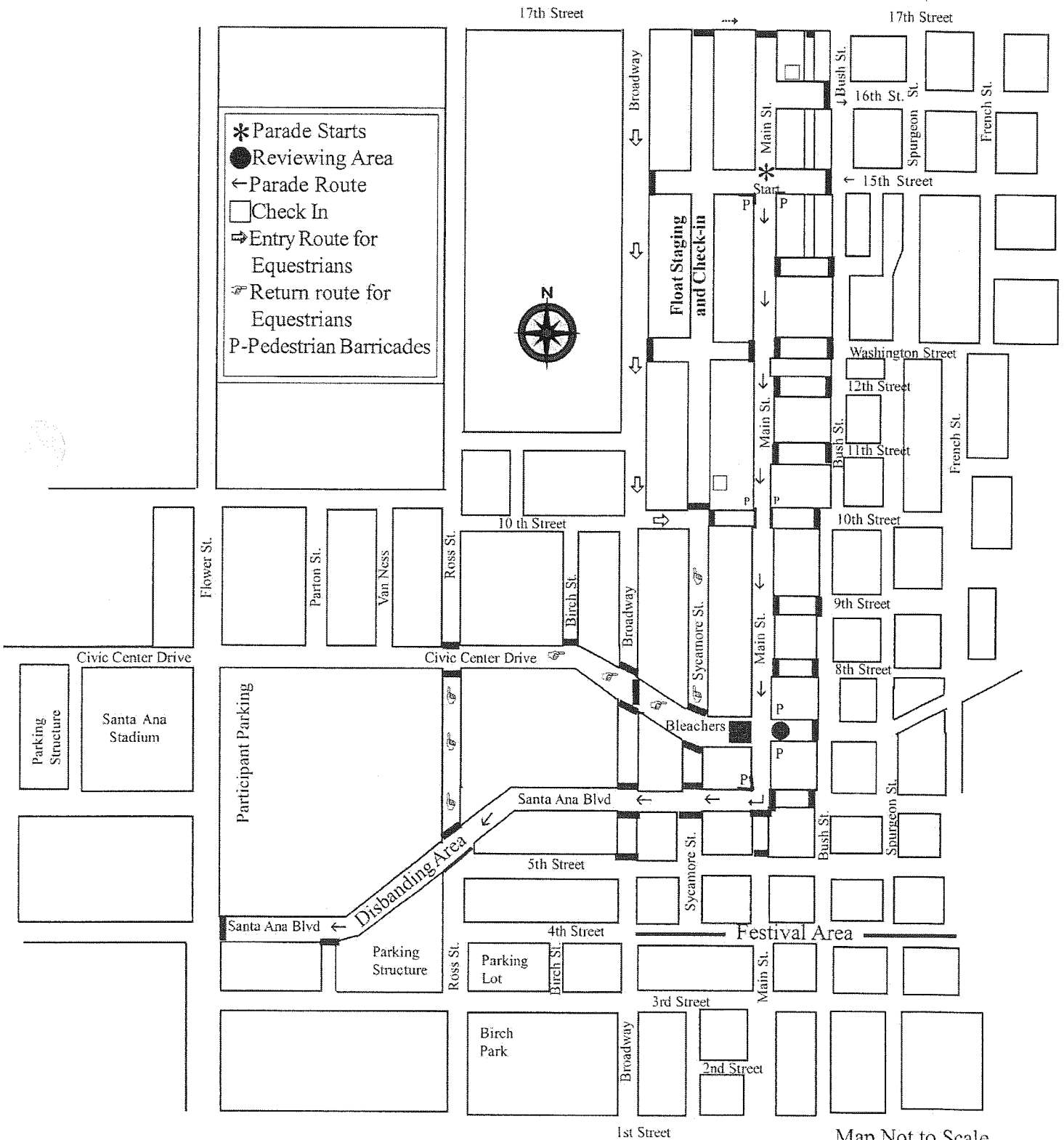


