OPEN ENROLLMENT CHECKLIST

Open Enrollment is a great time to review your existing benefit plans, evaluate any anticipated needs, learn more about your benefits and make adjustments for the upcoming calendar year.

1. Review

Review your benefits in the Open Enrollment System. You can access the system by logging in from your work or home computer. You should also review the information in this packet and on the Open Enrollment website or help menu.

4. Complete

Login to the Open Enrollment System and make any necessary changes. Not Making Changes? Login to the Open Enrollment system and make 100% sure everything is the way you want it. If you don't, and it's incorrect, you cannot fix it after October 7, 2016.

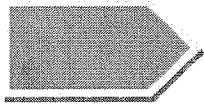

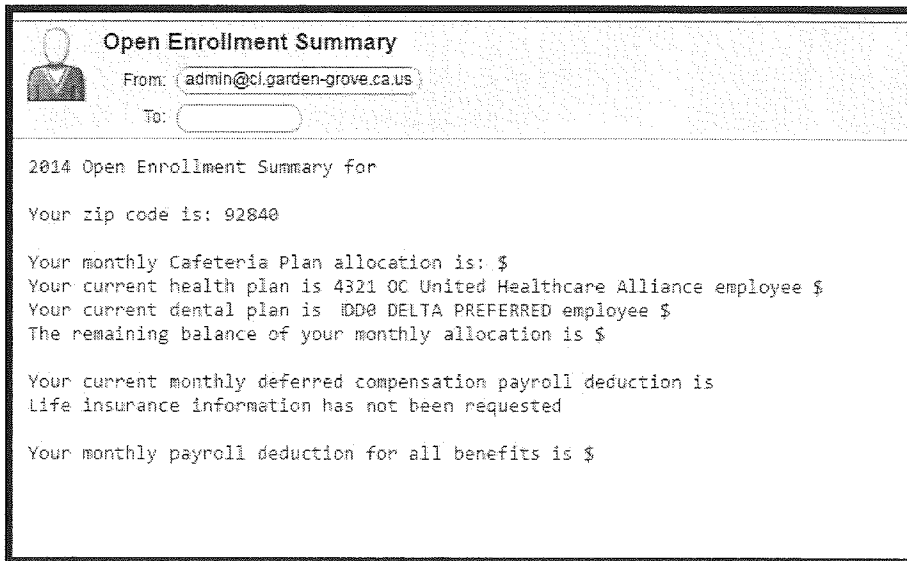

LIFE INSURANCE OPTIONS

What is Term Life Insurance?

Term Life Insurance is a policy that pays a benefit for a particular term. For the City, the term is employment. It is effective the first of the month after your hire date, and cancelled on your separation or retirement date. The City has two types of Term Life Insurance, a City paid group policy, which covers all full-time employees, and an Optional Additional Term Life Insurance policy, which is paid by the employee.

Lincoln Life Insurance - City Paid

All full-time employees are provided with a City paid life insurance policy equal to one year of your annual base salary, rounded up to the nearest thousand (\$1,000) dollars to a maximum of \$300,000. The policy also includes a policy for your spouse/domestic partner and all children of \$5,000. The policy also has an Accidentally Death and Dismemberment (AD&D) provision that provides a benefit equal to the amount of your basic life insurance should you die accidentally. However, the AD&D provision is subject to certain exclusions and limitations.

To calculate your City Paid Life Policy, take your base monthly salary, multiply by 12 and round to the nearest thousand dollars. If your gross base salary is \$3,295 you will do the calculation below:

- Example: $\$3,295 \times 12 = \$39,540$ rounded to nearest thousand means your policy is for \$40,000.

Term Life Insurance - Employee Paid (optional additional)

You may choose to pay for additional life insurance coverage for yourself, your spouse/domestic partner and/or children. Premium payments are payroll deducted bi-weekly. Below is a chart of the cost per \$1,000 of additional coverage. Premiums are based on your age and the amount of coverage you elected.

Available Coverage Amounts:

- Employee - You may elect in multiples of \$10,000 up to \$500,000 coverage for yourself, however the policy amount cannot exceed 5x your annual salary.
- Spouse/Domestic Partner - You may elect up to 50% of our annual coverage for your spouse, in multiples of \$5,000.
- Children - You may elect up to \$10,000 coverage for your child(ren)
 - Eligible children must be under 21 years of age and unmarried, or under age 25 if maintaining full-time student status.

If you terminate your employment or become ineligible for coverage, you have the option to convert all or part of the amount of coverage in force to an individual life policy on the date of termination without completing a new Evidence of Insurability. Conversion election must be made within 31 days of your date of termination.

LONG TERM DISABILITY

The City does not pay into State disability. Instead, we have self-funded plans for bargaining units. Please visit the Open Enrollment website to view your LTD benefits.

For Employee's Association & Employee's League Only

You have the option to enroll in the "buy up" plan, which reduces your waiting period from 90 days to 60 days. Make sure to read about this optional benefit and if you are interested in enrolling, do so when completing your Open Enrollment this year.

LEXIBLE SPENDING ACCOUNT (FSA)

Regular, full-time employees are eligible to participate in the Flexible Spending Account (FSA) if they enroll within the program eligibility guidelines. This plan allows employees to reduce their cash compensation on a pre-tax basis and establish reimbursement accounts for out-of-pocket expenditures for child care and medical care expenses. Eligible expenses are then reimbursed on a non-taxed basis after they are incurred and paid by the employee. Federal law sets a number of severe restrictions on the use of this program, which include:

- Elections are made once a year and are irrevocable during the year except for certain changes in the employee's family status
- The two accounts cannot be commingled
- Any amounts not claimed during the plan year (January 1 through March 15 of the following calendar year) are forfeited by the employee
- Dependent care contributions are limited to \$5,000 annually, or \$2,500 if married and filing a separate tax return
- Health care contributions are limited to \$2,500 annually.

Employees must re-enroll in FSA accounts each year during Open Enrollment or they cannot participate.

Deadline to submit: October 7, 2016 at 4:00 p.m.

Reimbursement from Accounts

- A completed Reimbursement Request Claim Form must be submitted to Human Resources with all receipts attached.
- Funds designated in the Health Care account are available January 1 of that plan year. *(Example - If an employee designates \$260 [\$10 bi-weekly deduction from pay check] into the Health Care account and incurs expenses for \$260 January 1, he/she may submit and receive reimbursement for the full amount. The bi-weekly deduction will continue for the remainder of the calendar year.)*
- Funds designated in the Child Care account are reimbursed only as money is deposited into the account. *(Example - If an employee designates \$1,300 [\$50 bi-weekly deduction from pay check] into the Child Care account and submits receipts for \$300, he/she will be reimbursed \$50 per pay period until the balance of the receipt is zero.)*
- No checks will be issued for less than \$50, except to close an account.

DEFERRED COMPENSATION (457 PLAN)

A government 457(b) deferred compensation plan is a retirement savings plan that allows eligible employees to supplement any existing retirement and pension benefits by saving and investing before-tax dollars through a voluntary salary contribution. Contributions and any earnings on contributions are tax-deferred until money is withdrawn. Distributions are subject to ordinary income tax.

Traditional (Before-tax) and After-tax (ROTH) Contributions

The ROTH option gives you the flexibility to designate all or part of your 457 elective deferrals as ROTH contributions. ROTH contributions are made after-tax dollars.

Enrolling in Deferred Comp

If you would like to enroll in deferred comp, complete the enrollment form and return it Human Resources. You will need to make four decisions when completing the form:

- Which type of account do you want to participate in? Traditional (before-tax contributions, or ROTH (after-tax contributions).
- When do you want to start contributing? Your enrollment changes are always effective the first of the month. It does not have to be in January, you can start participating anytime.
- How do you want your account managed? Do it yourself, or enroll in the Managed Account Service (for a fee).
- Who do you want to be your beneficiary? You must have at least one primary beneficiary and will need their date of birth and social security number when completing the form.

MAYORS AGAINST ILLEGAL GUNS

STATEMENT OF PRINCIPLES

Whereas: 30,000 Americans across the country are killed every year as a result of gun violence – including 12,000 who are murdered – destroying families and communities in big cities and small towns; and

Whereas: As Mayors, we are duty-bound to do everything in our power to protect our residents, especially our children, from harm, and there is no greater threat to public safety than the threat of illegal guns;

Now, therefore, we resolve to work together to find innovative new ways to advance the following principles:

PUNISH – to the maximum extent of the law – criminals who possess, use, and traffic in illegal guns.

TARGET and hold accountable irresponsible gun dealers who break the law by knowingly selling guns to straw purchasers.

EXTEND background check requirements to all gun sales, including the private sales that take place between strangers online and at gun shows

OPPOSE all federal efforts to restrict cities' right to access, use, and share trace data that is so essential to effective enforcement, or to

interfere with the ability of the Bureau of Alcohol, Tobacco, Firearms and Explosives to combat illegal gun trafficking.

WORK to develop and use technologies that aid in the detection and tracing of illegal guns.

SUPPORT all local, state, and federal legislation that targets illegal guns; coordinate legislative, enforcement, and litigation strategies; and share information and best practices.

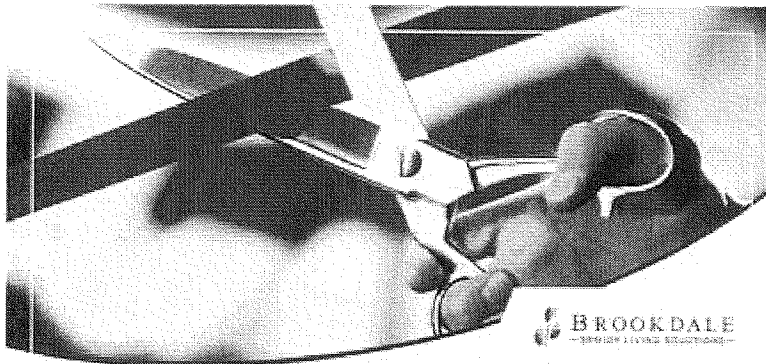

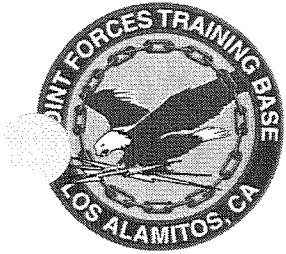

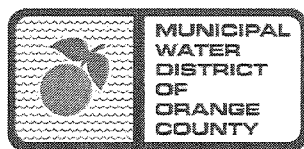

SUBJECT: Monthly Water Usage Data, Tier 2 Projection & Water Supply Information

The attached figures show the recent trend of water consumption in Orange County (OC), an estimate of Tier 2 volume for MWDOC, and selected water supply information.

- Fig. 1 OC Water Usage, Monthly by Supply OCWD Groundwater water was the main supply in July.
- Fig. 2 OC Water Usage, Monthly, Comparison to Previous Years Water usage in July 2016 was low compared to the last 5 years with the exception of July 2015. Lower usage is primarily due to strong conservation efforts and mandatory restrictions set by the Governor for the period of June 2015 to May 2016. In June 2016 all water conservation became voluntary for MWDOC agencies.
- Fig. 3 Historical OC Water Consumption OC water consumption is projected to be 517,000 AF in FY 2016-17 (*this includes ~15 TAF of agricultural usage and non-retail water agency usage*). This is about 22,000 AF more than FY 2015-16 and is about 55,000 AF less than FY 2014-15. Water usage per person is projected to be slightly higher than in FY 2015-16 for Orange County at 145 gallons per day (This includes recycled water). Although OC population has increased 20% over the past two decades, water usage has not increased, on average. A long-term decrease in per-capita water usage is attributed mostly to Water Use Efficiency (water conservation) efforts.
- Fig. 4 MWDOC "Firm" Water Purchases, 2016 "Firm" water above the Tier 1 limit will be charged at the higher Tier 2 rate. Our current projection of Tier 2 purchases is zero in 2016.

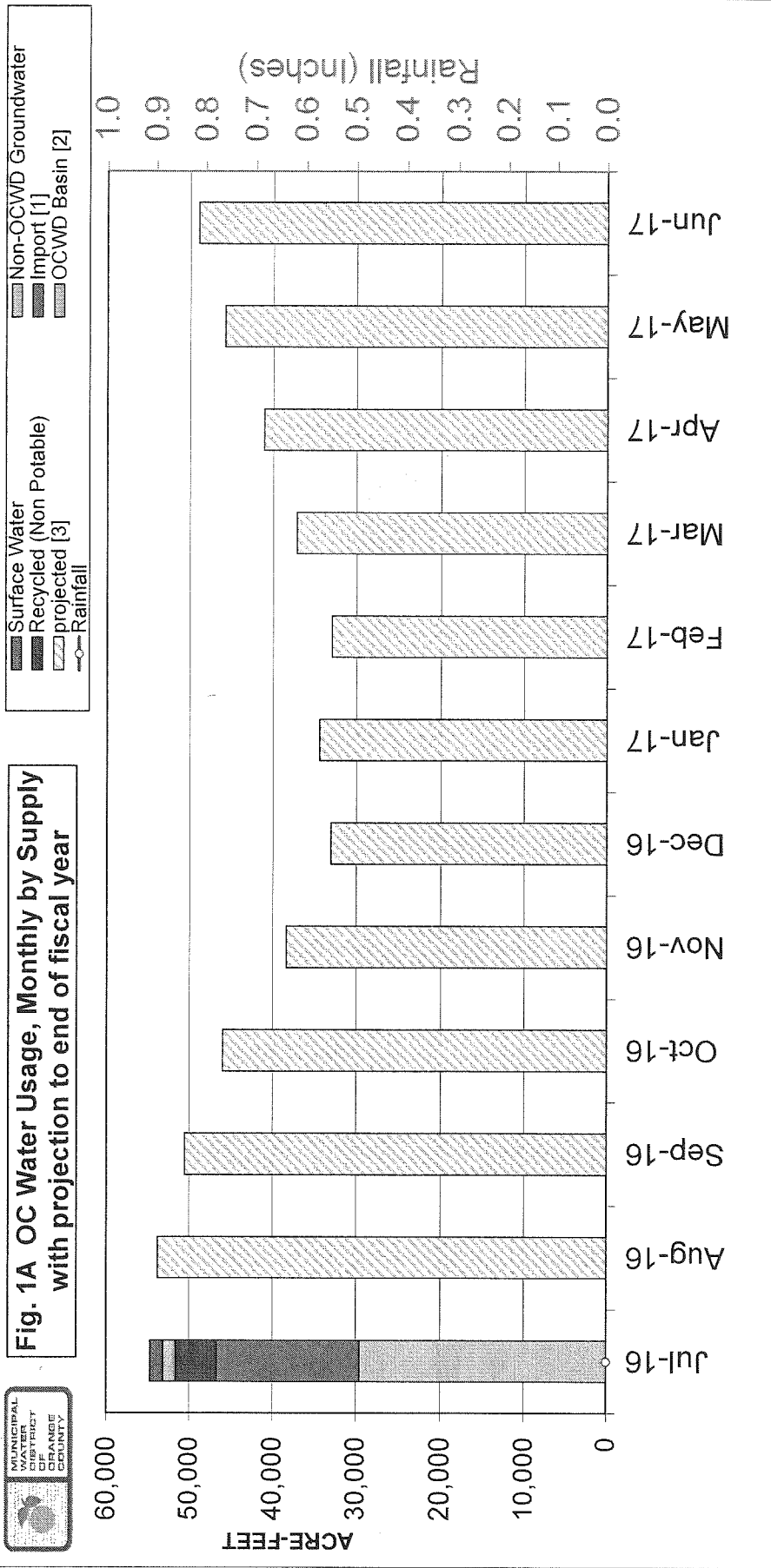
Water Supply Information Includes data on: Rainfall in OC; the OCWD Basin overdraft; Northern California and Colorado River Basin hydrologic data; the State Water Project (SWP) Allocation, and regional storage volumes. The data has implications for the

magnitude of supplies from the three watersheds that are the principal sources of water for OC. Note that a hydrologic year is Oct. 1st through Sept. 30th.

- Orange County's accumulated rainfall through August was well below average for this period. This continues the impact of the previous four hydrologic years' below-normal rainfall in reducing those local supplies that are derived from local runoff. El Nino conditions have diminished and NOAA is predicted a moderate chance of La Nina for next winter (La Nina is generally associated with cool dry winters in Southern California).
- Northern California accumulated precipitation in August was around 117% of normal for this period. The Northern California snowpack is 97% of normal as of April 1st. This follows three below-average hydrologic years. The State of California has been in a declared Drought Emergency since January 2014. The State Water Project Contractors Table A Allocation is at 60% as of the end of June.
- Colorado River Basin accumulated precipitation in August was 96% average for this period. The Upper Colorado Basin snowpack was 85% of normal as of April 15th. This follows two below-average hydrologic years, the Colorado River Basin is in the recovery of a long term drought. Lake Mead and Lake Powell combined have about 61% of their average storage volume for this time of year. If Lake Mead's level falls below a "trigger" limit 1,075 ft. at the end of a calendar year, then a shortage will be declared by the US Bureau of Reclamation (USBR), impacting Colorado River water deliveries for the Lower Basin states. As of late August Lake Mead levels were slightly below the "trigger" limit but fortunately levels are expecting to increase due to water releases schedule at Lake Powell. The USBR predicts that the "trigger" level will not be hit by the end of 2016.

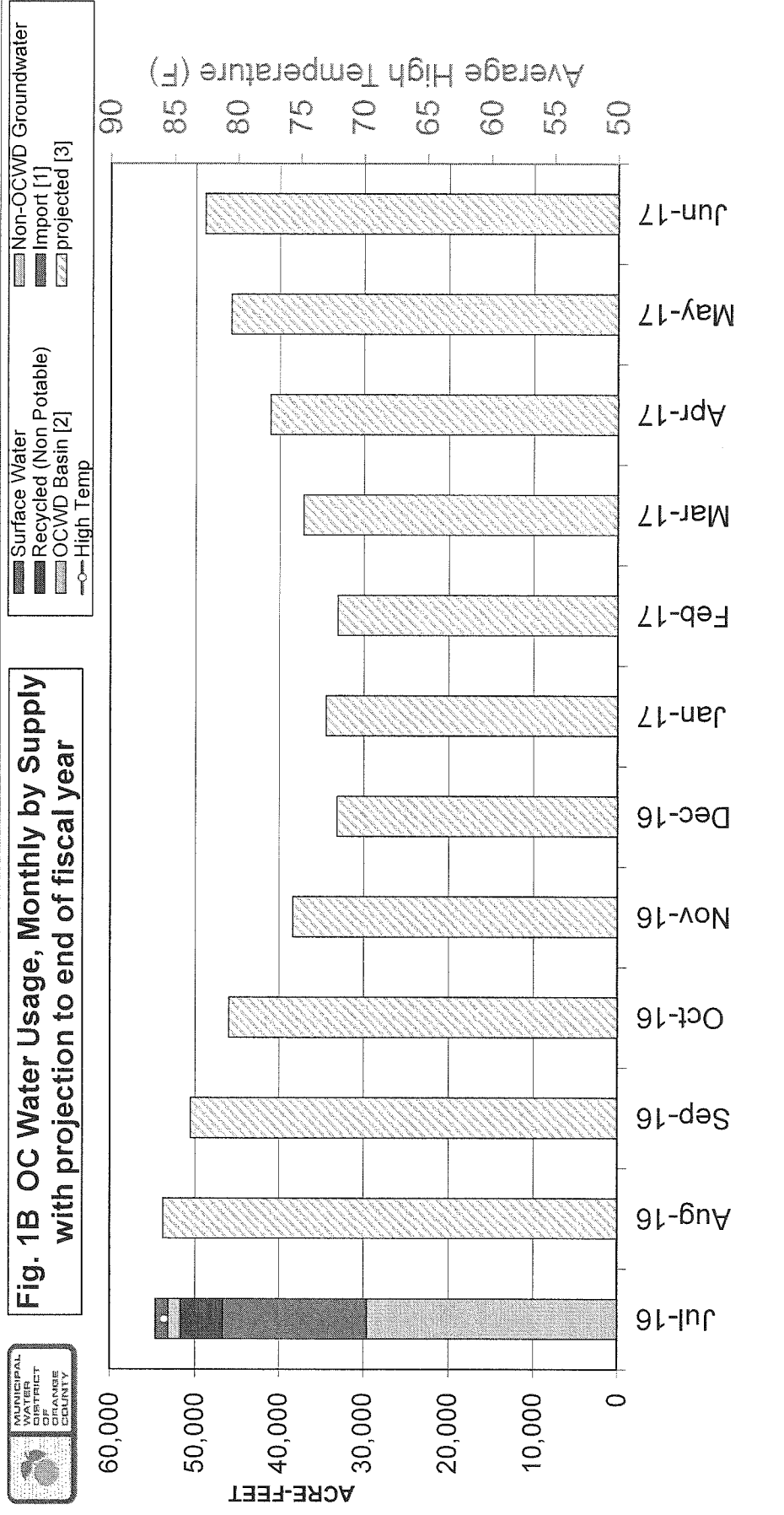

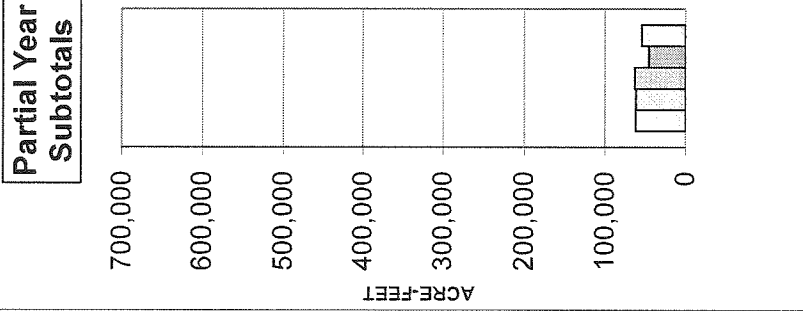
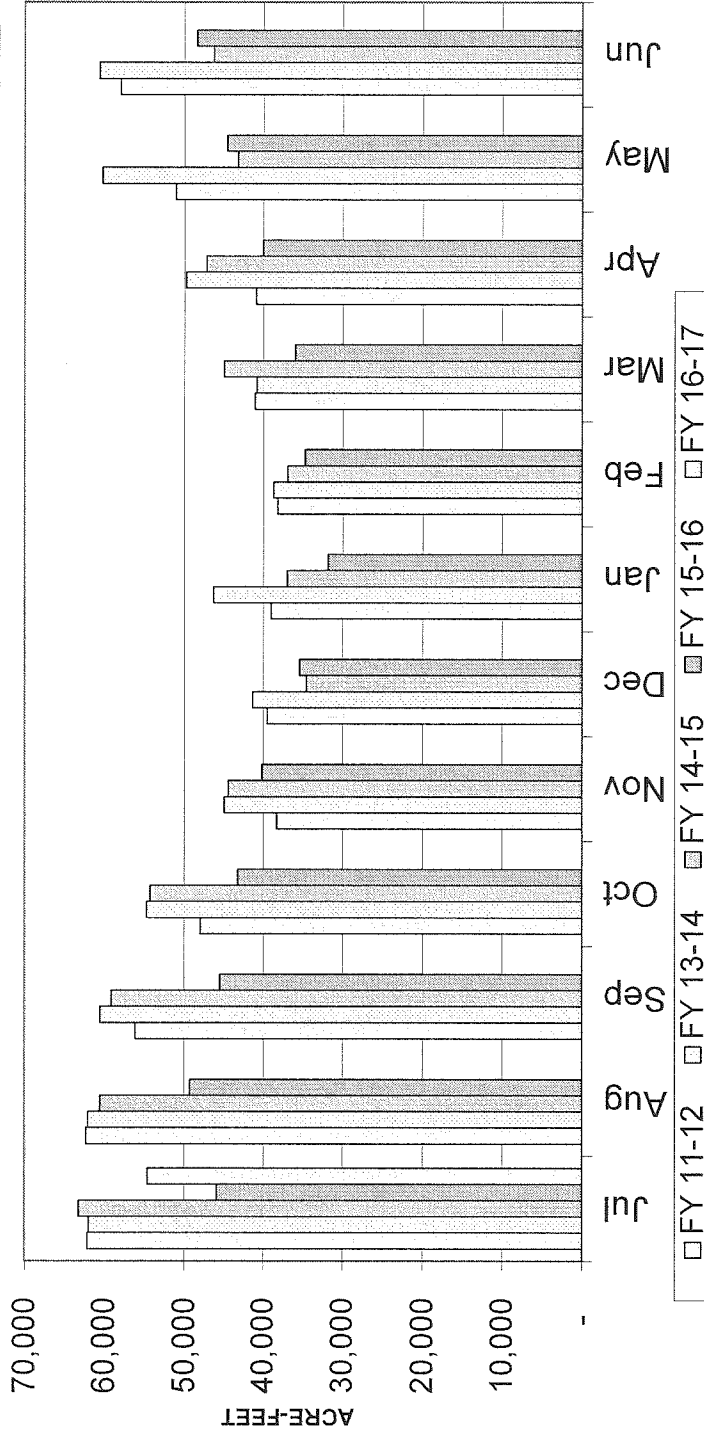
Fig. 1B OC Water Usage, Monthly by Supply

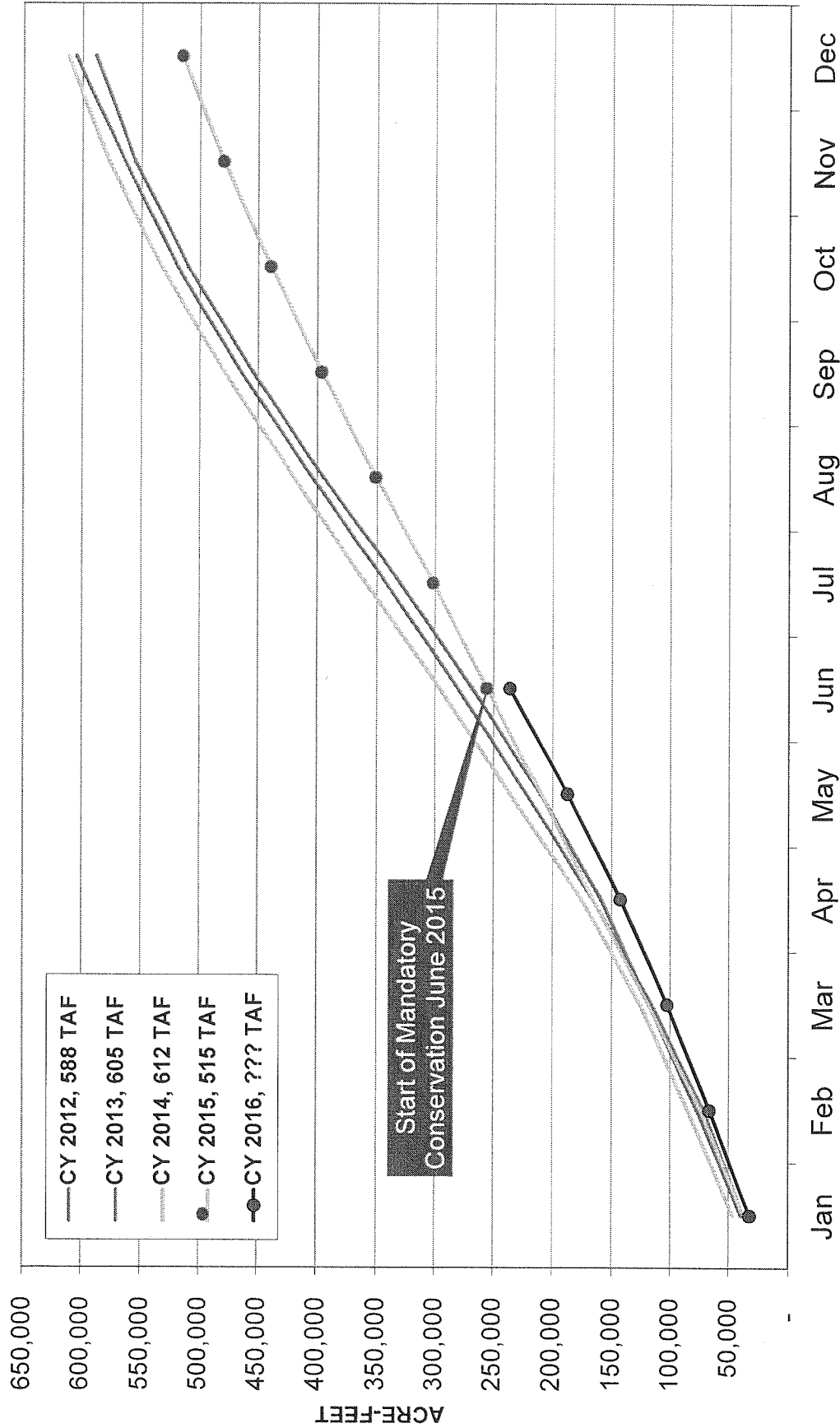
Fig. 2A OC Monthly Water Usage [1]: Comparison to Last 4 Fiscal Years

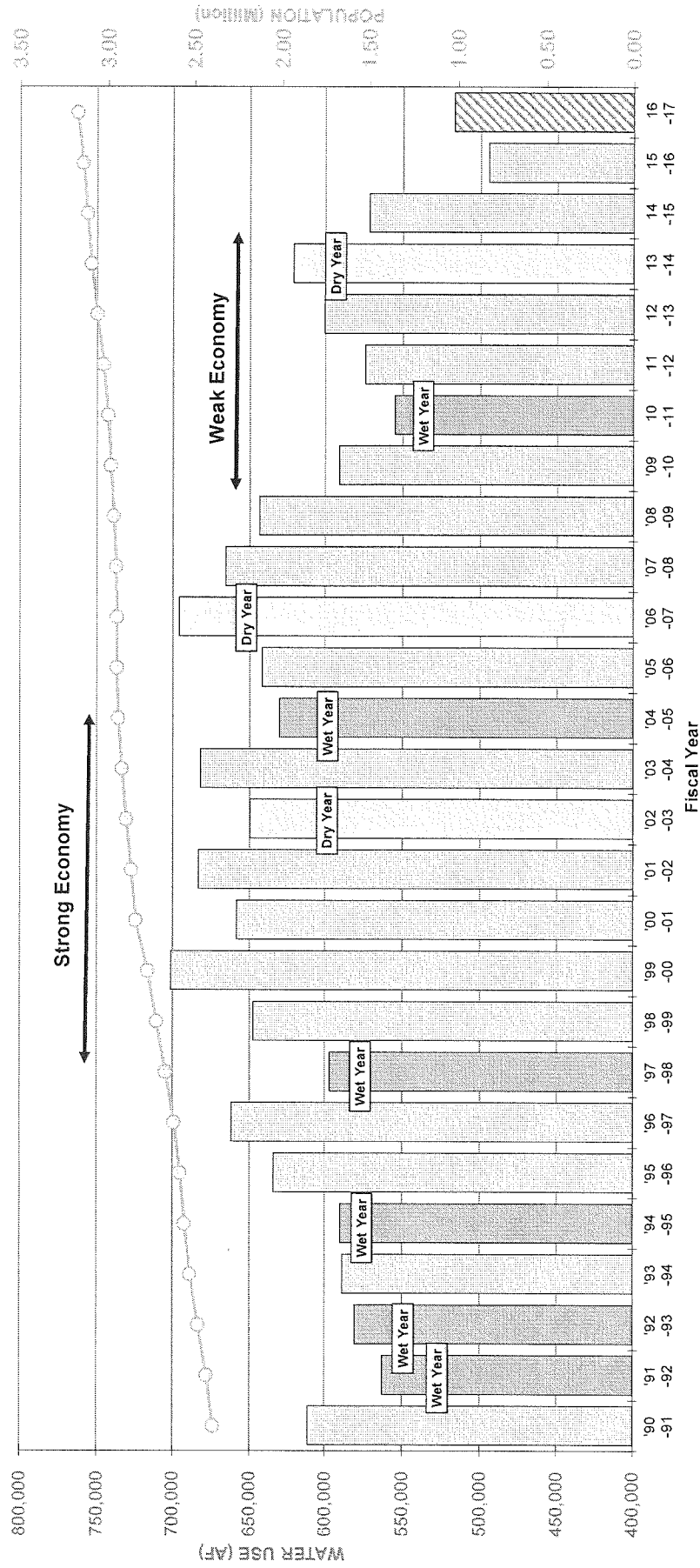
Fig. 2B Orange County Cumulative Monthly Consumptive Water Usage [1]: present year compared to last 4 calendar years

Fig. 3A HISTORICAL WATER CONSUMPTION[1] AND POPULATION[2] IN OC



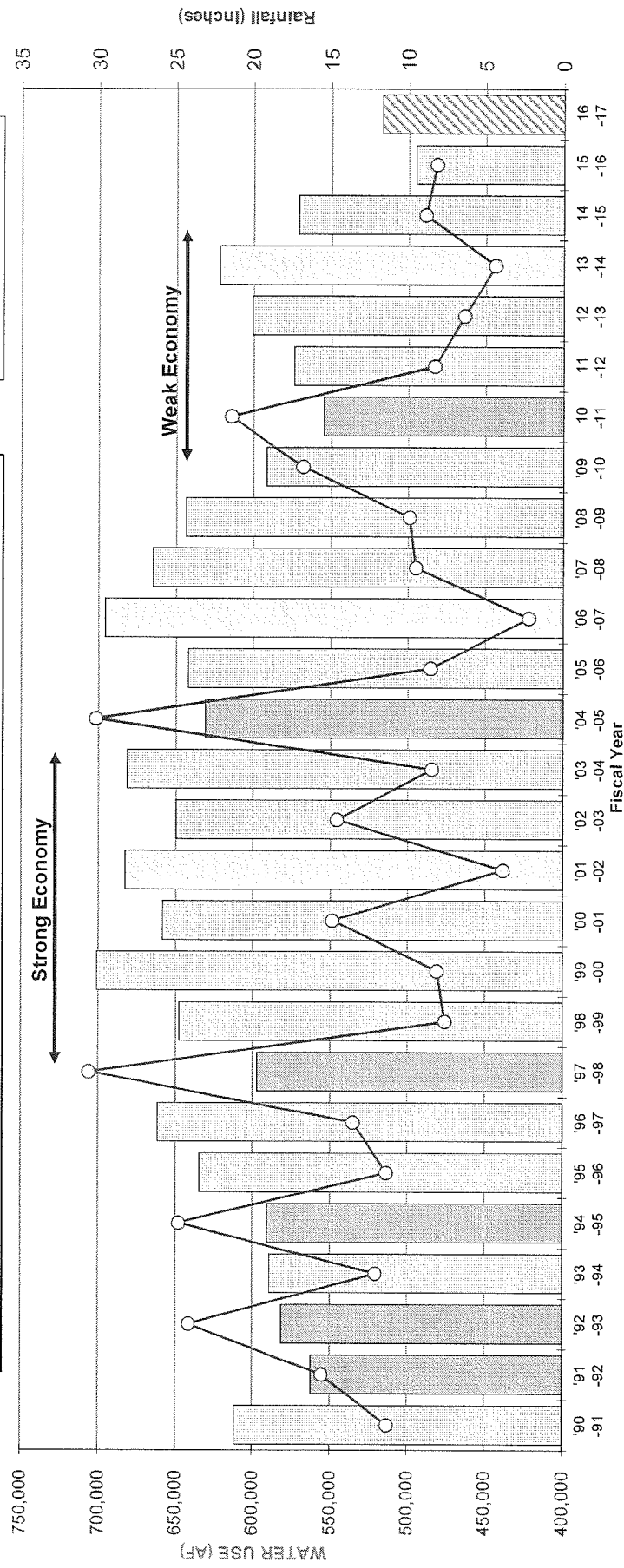

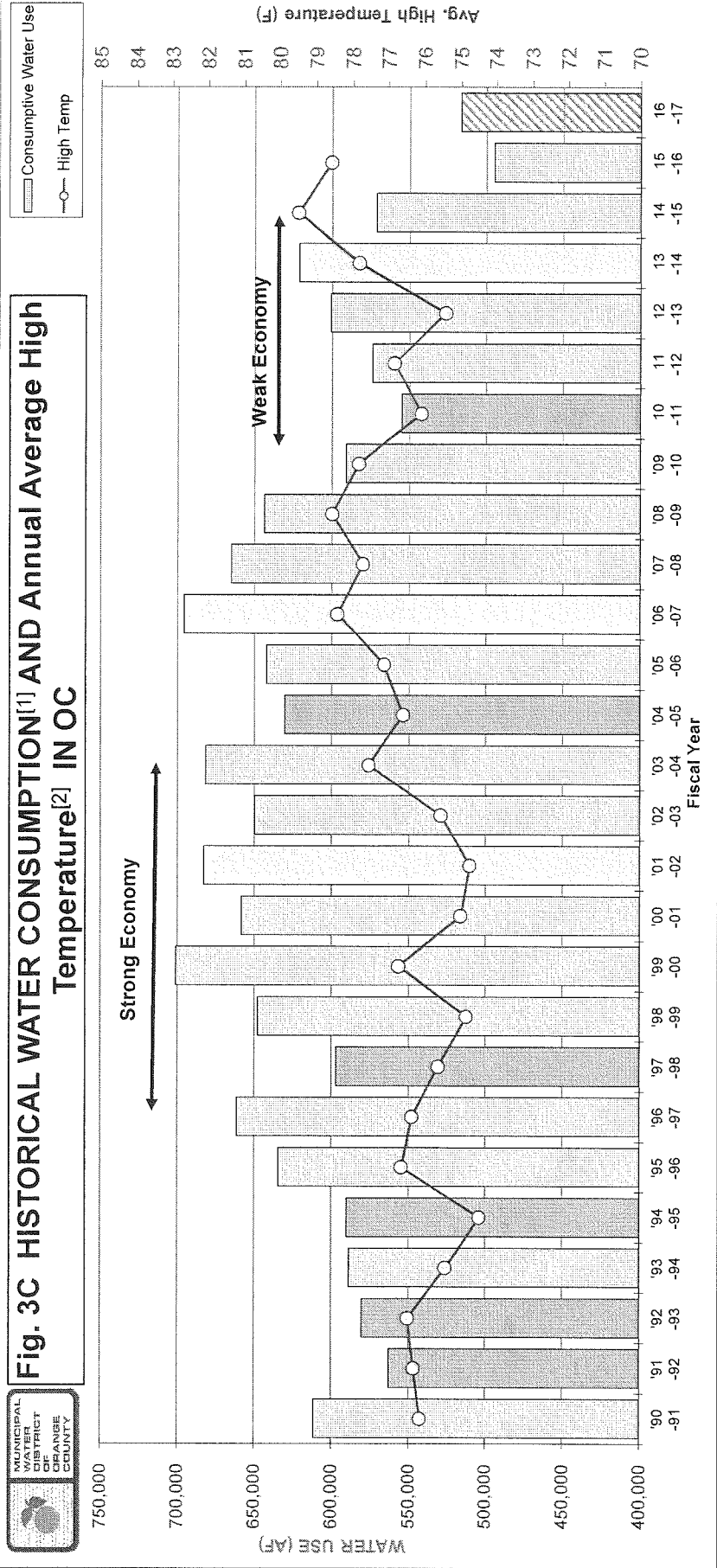


Fig. 3B HISTORICAL WATER CONSUMPTION^[1] AND Annual Rainfall^[2] IN OC

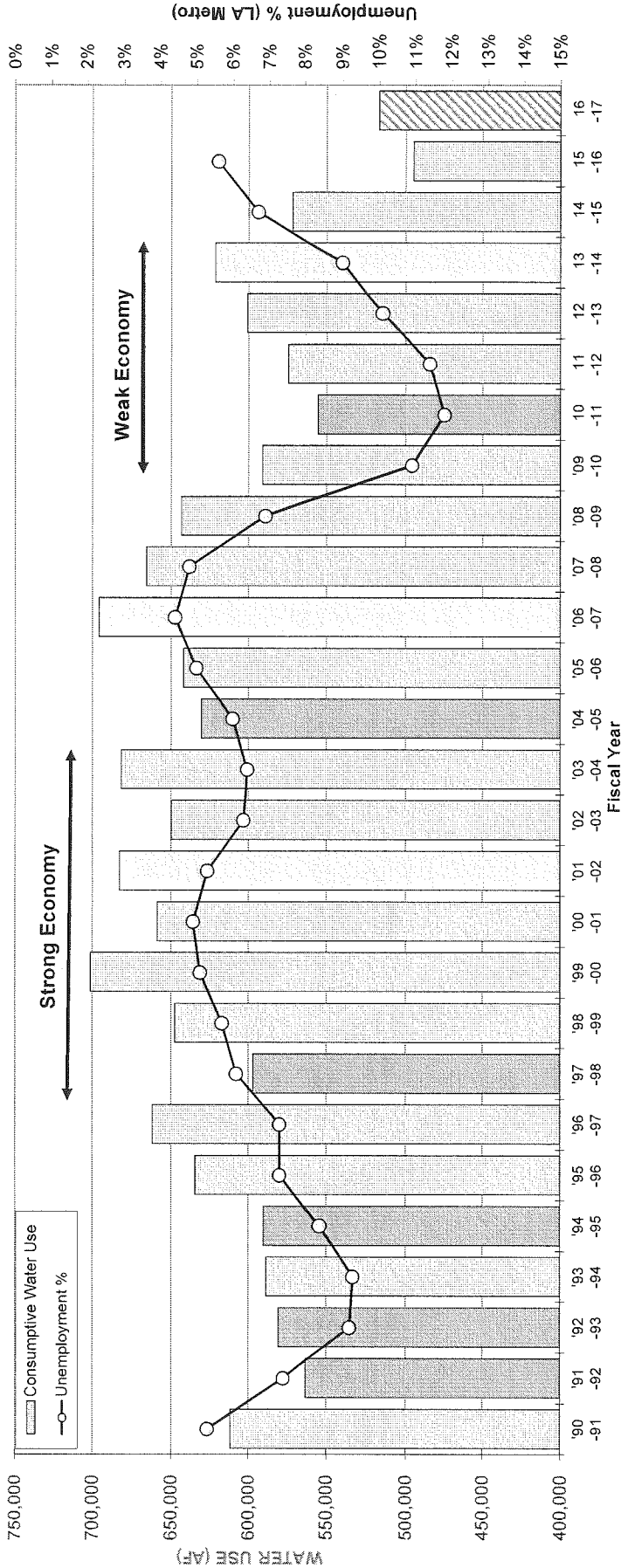

Fig. 3D HISTORICAL WATER CONSUMPTION[1] AND Average Unemployment[2] IN OC



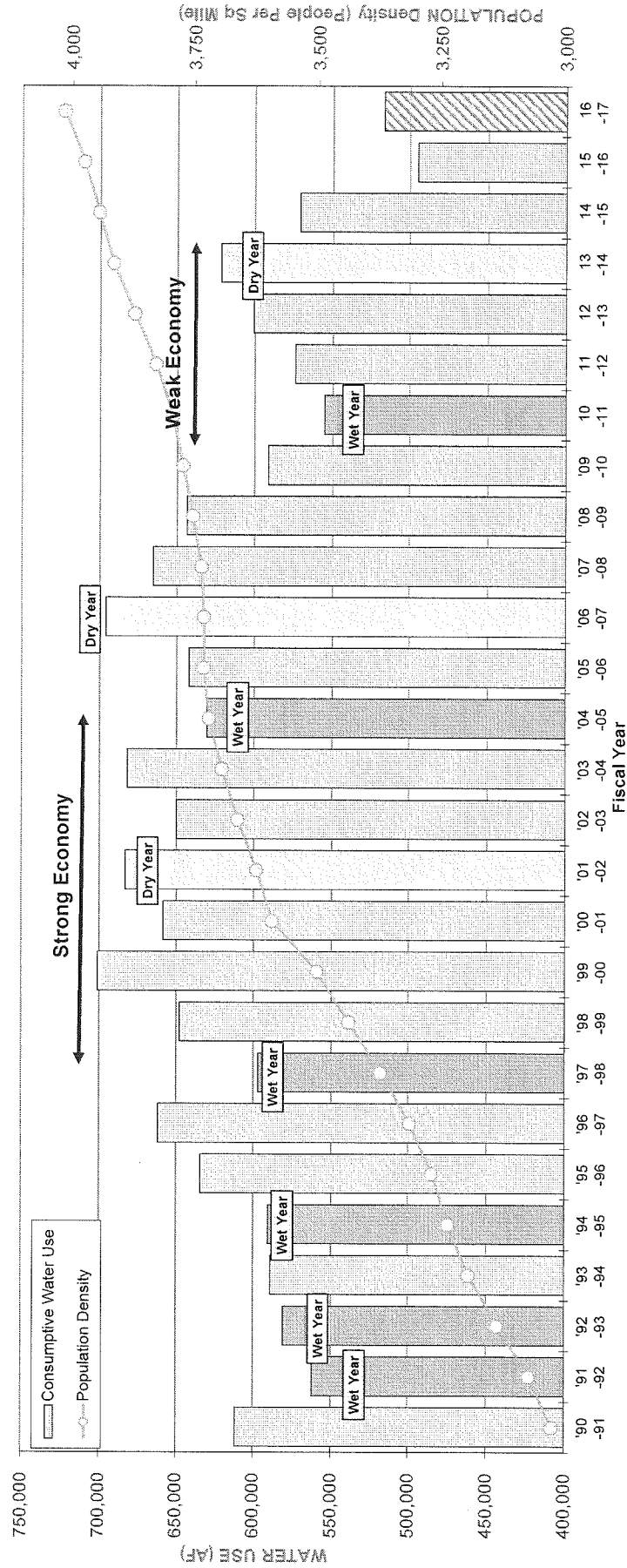

Fig. 3E HISTORICAL WATER CONSUMPTION^[1] AND POPULATION DENSITY^[2] IN OC

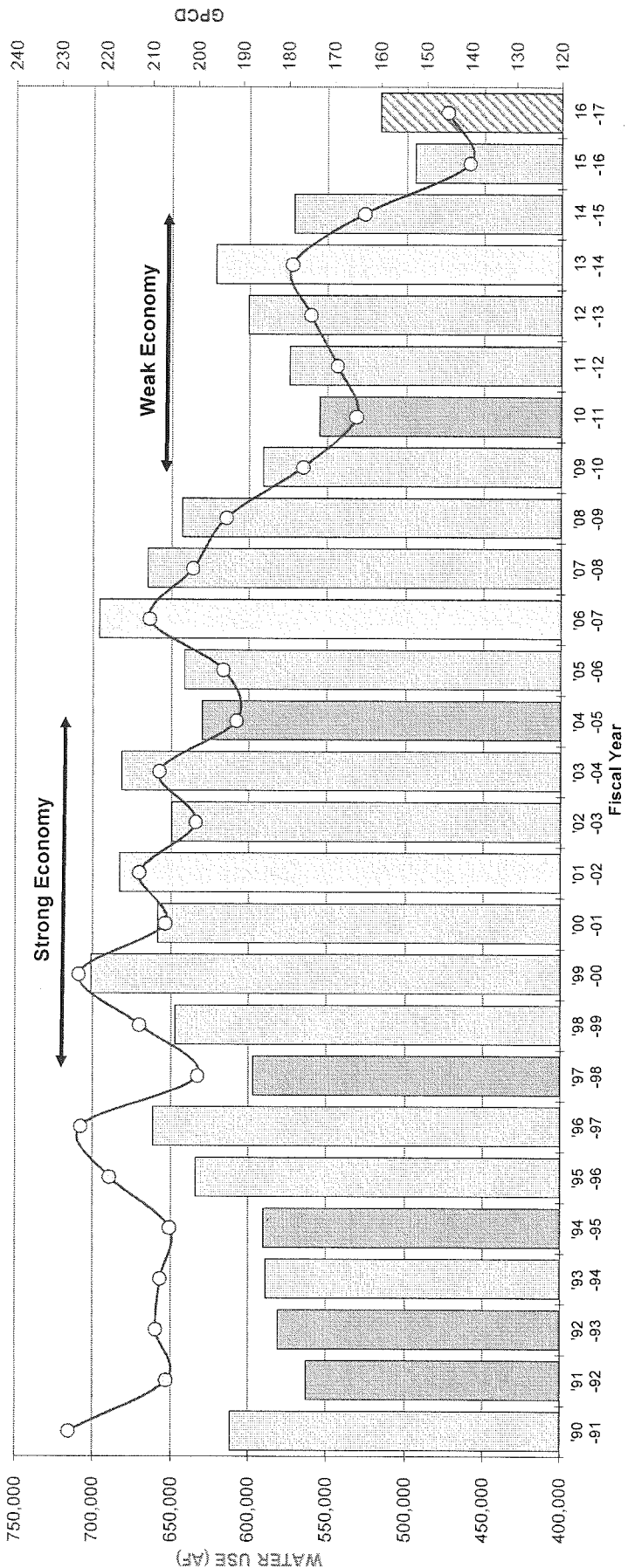

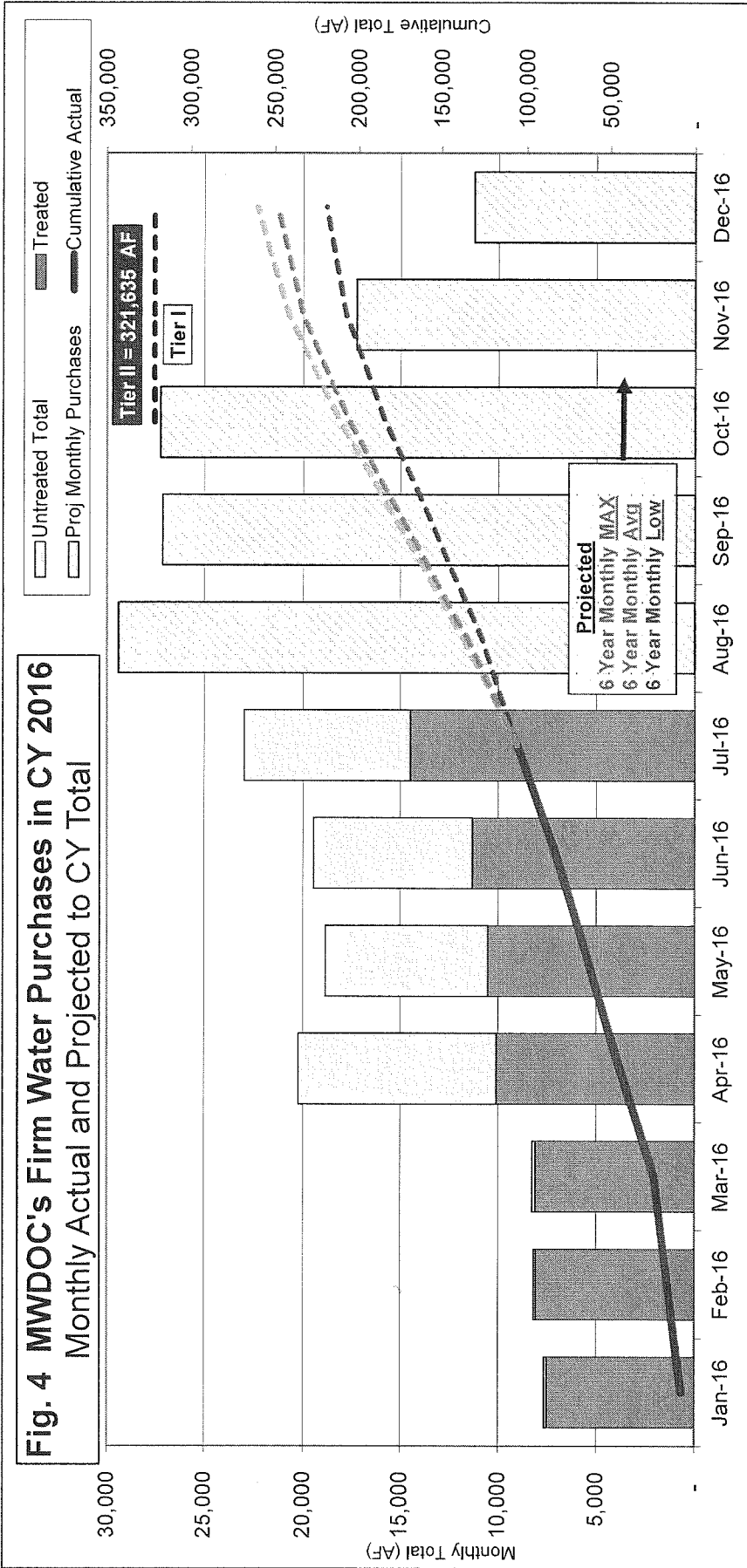


Fig. 3F HISTORICAL WATER CONSUMPTION[1] AND GPCD [2] IN OC

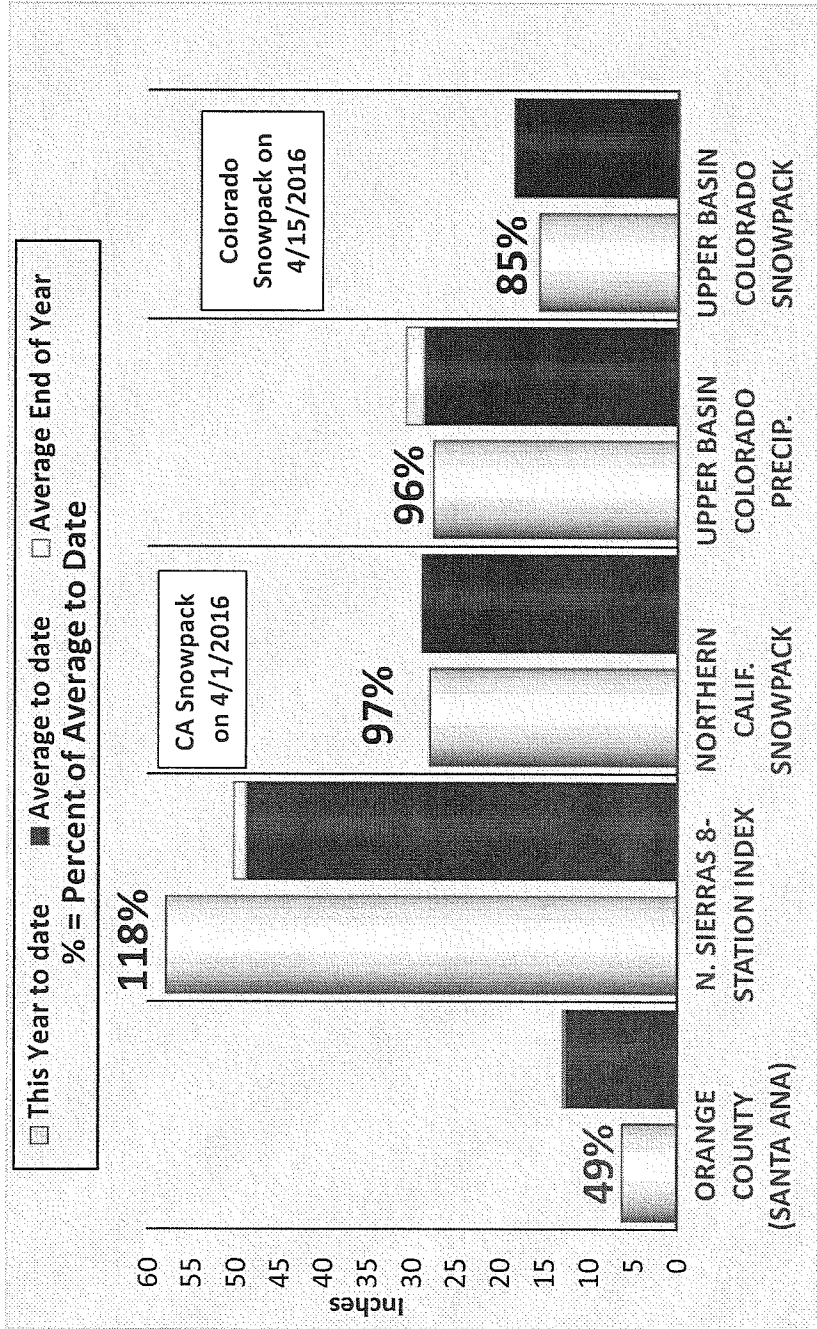

for the Oct.-Sep. water year, through late August 2016

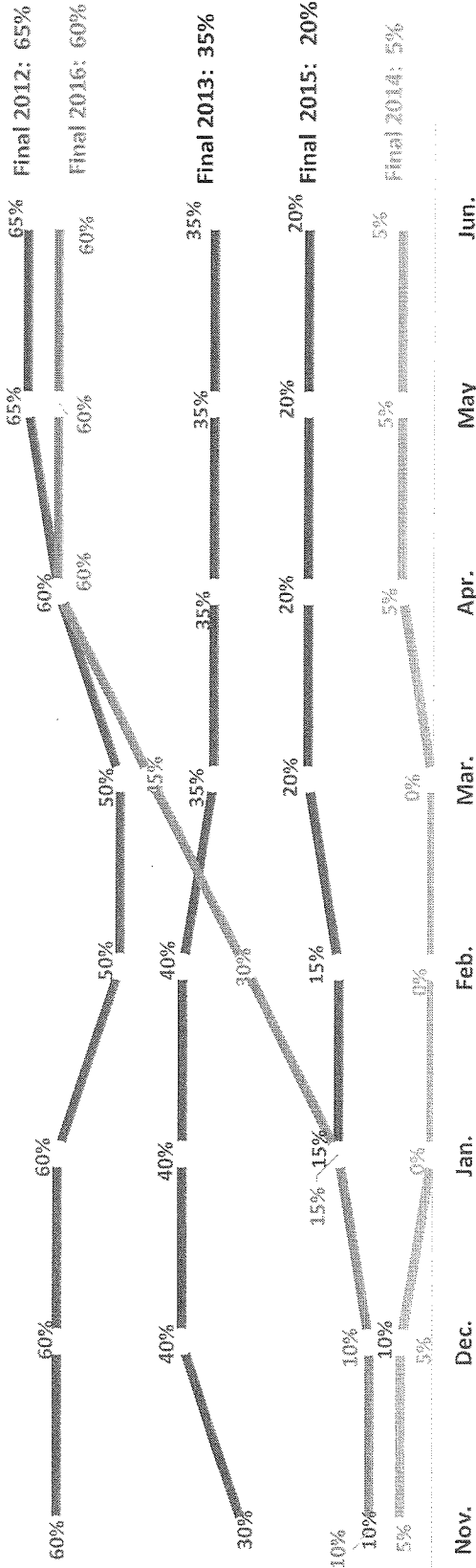

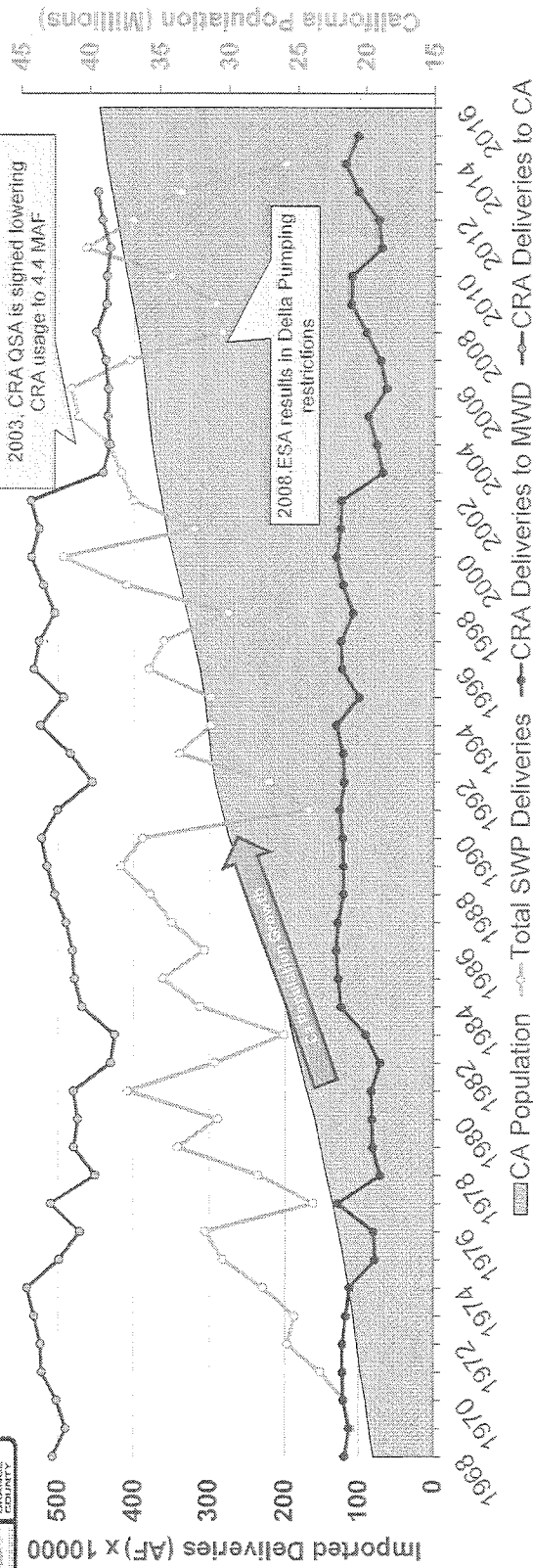

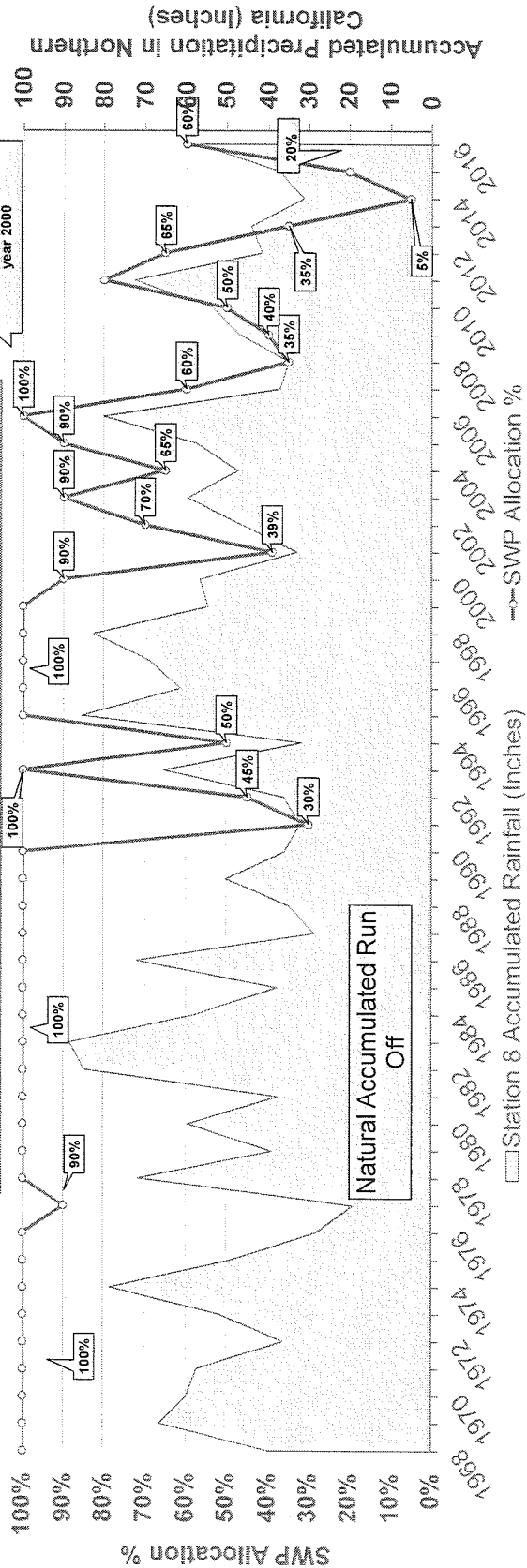

Imported Water Deliveries Vs. California Population Growth



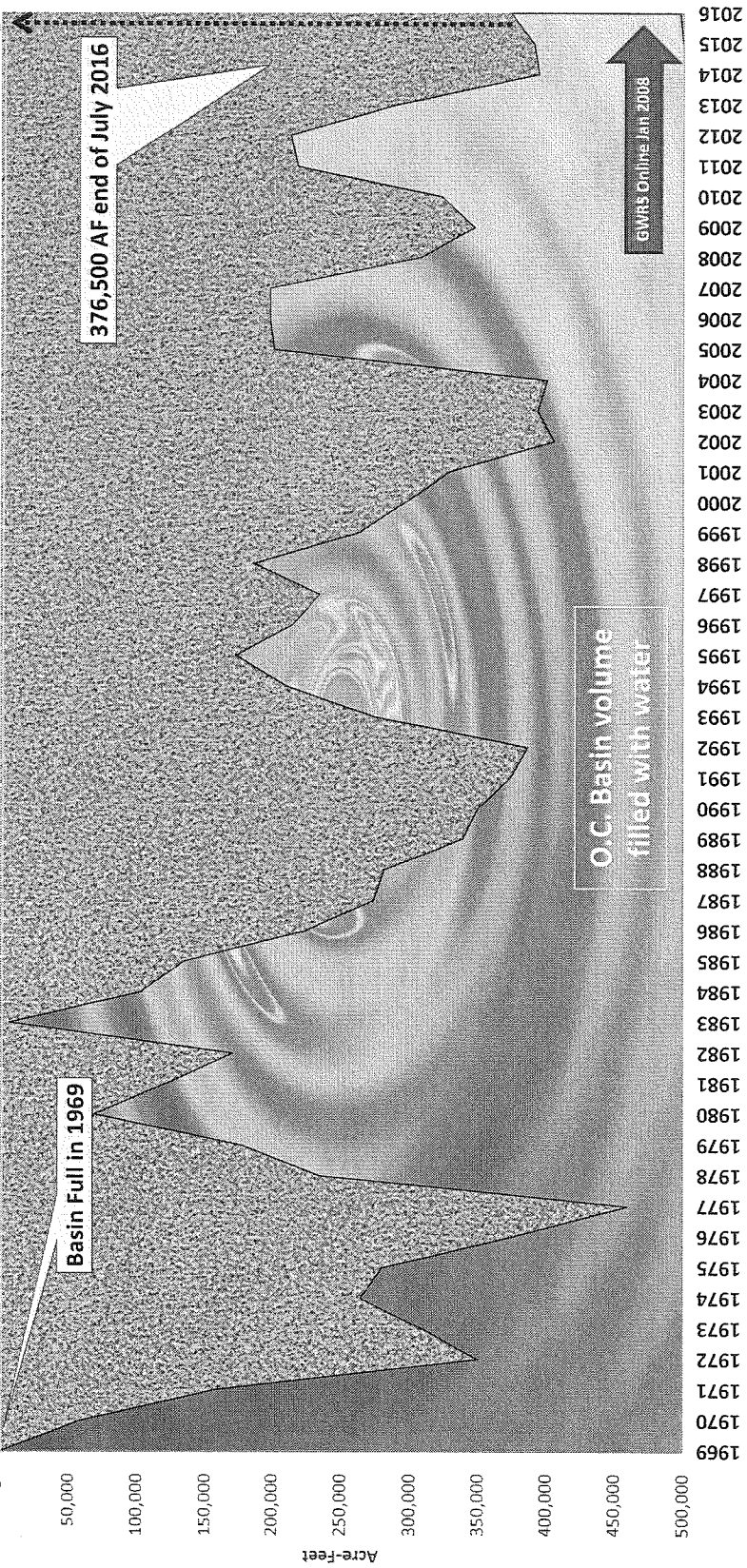
SWP Allocation % Vs. Station 8 Accumulated Rainfall

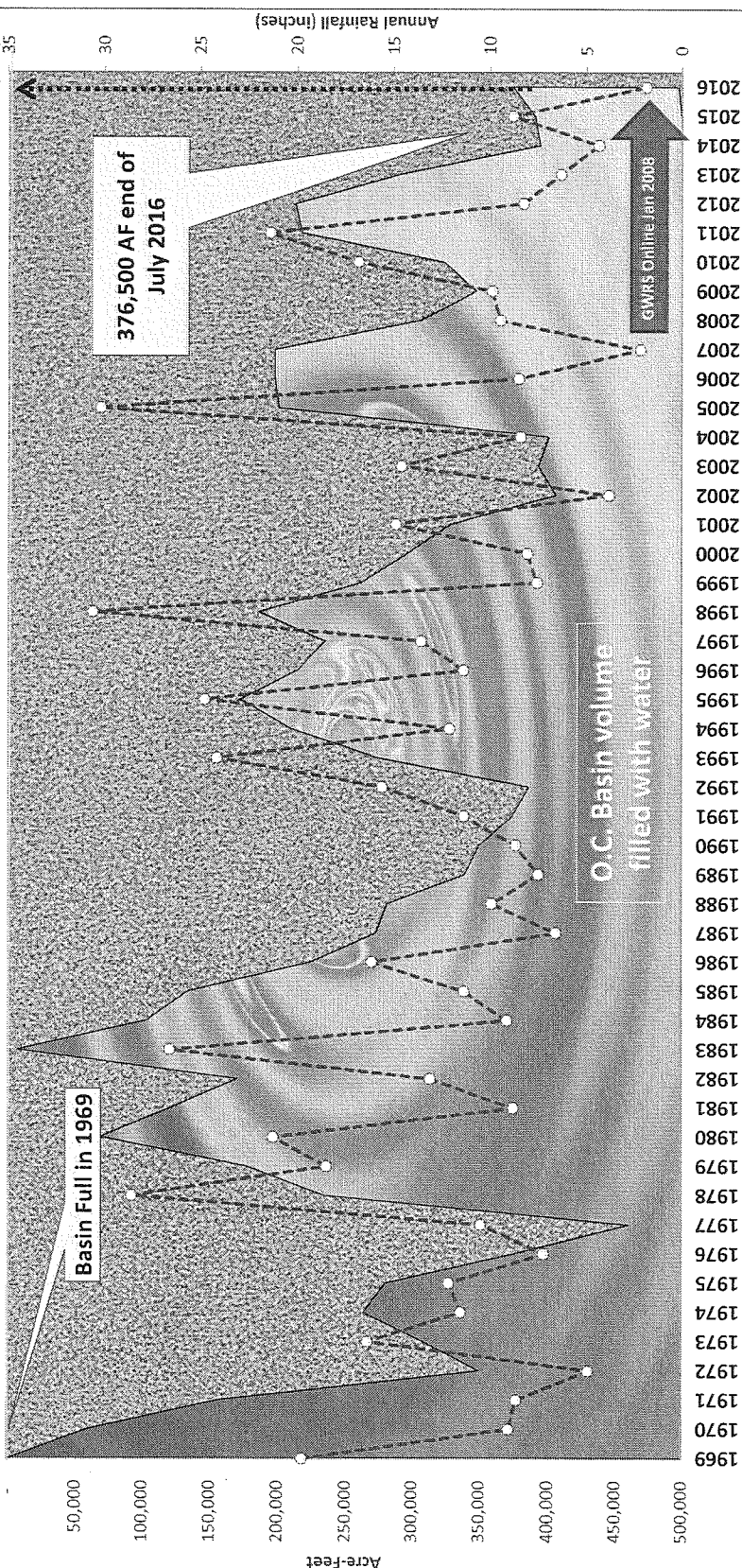

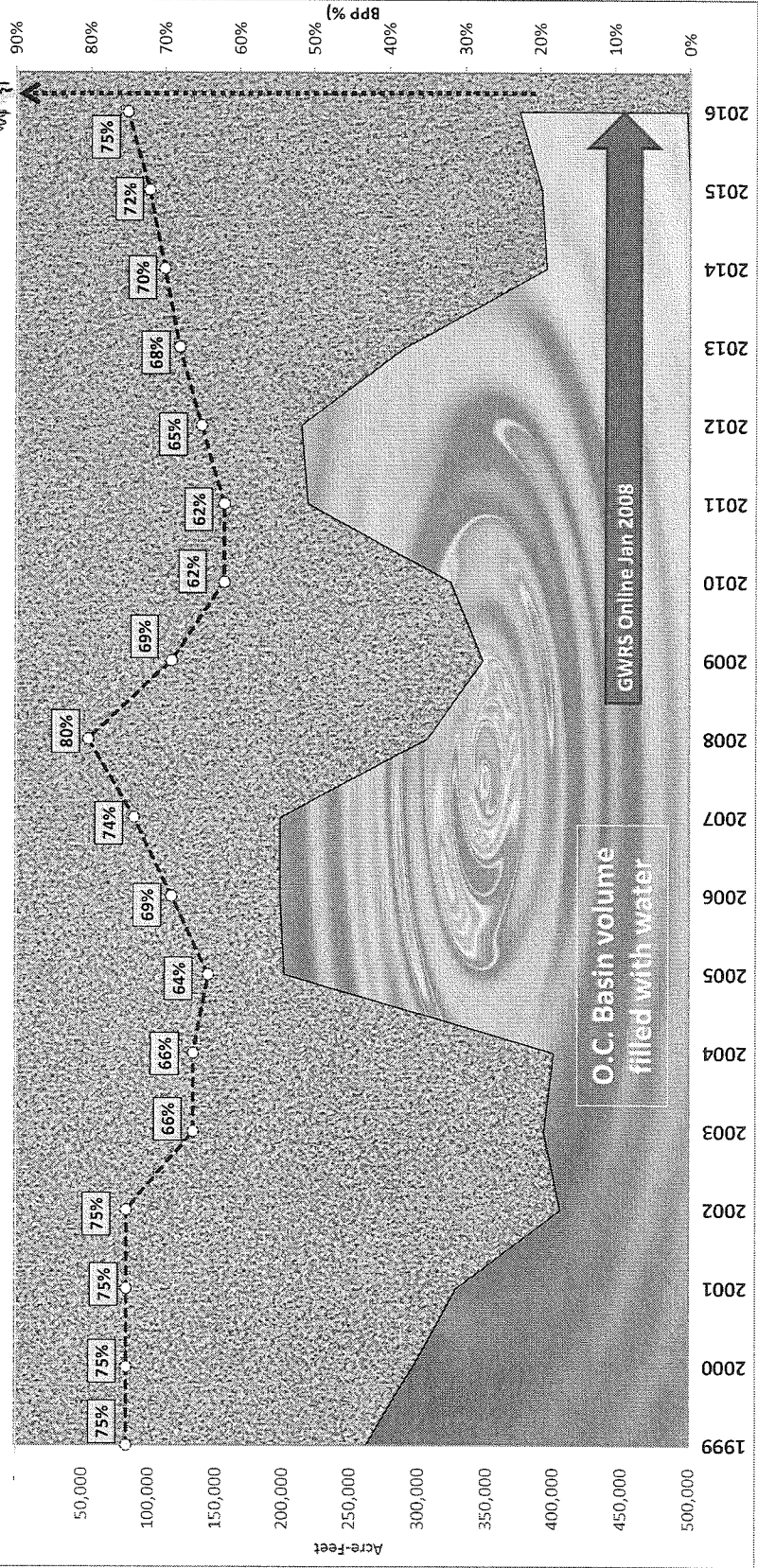

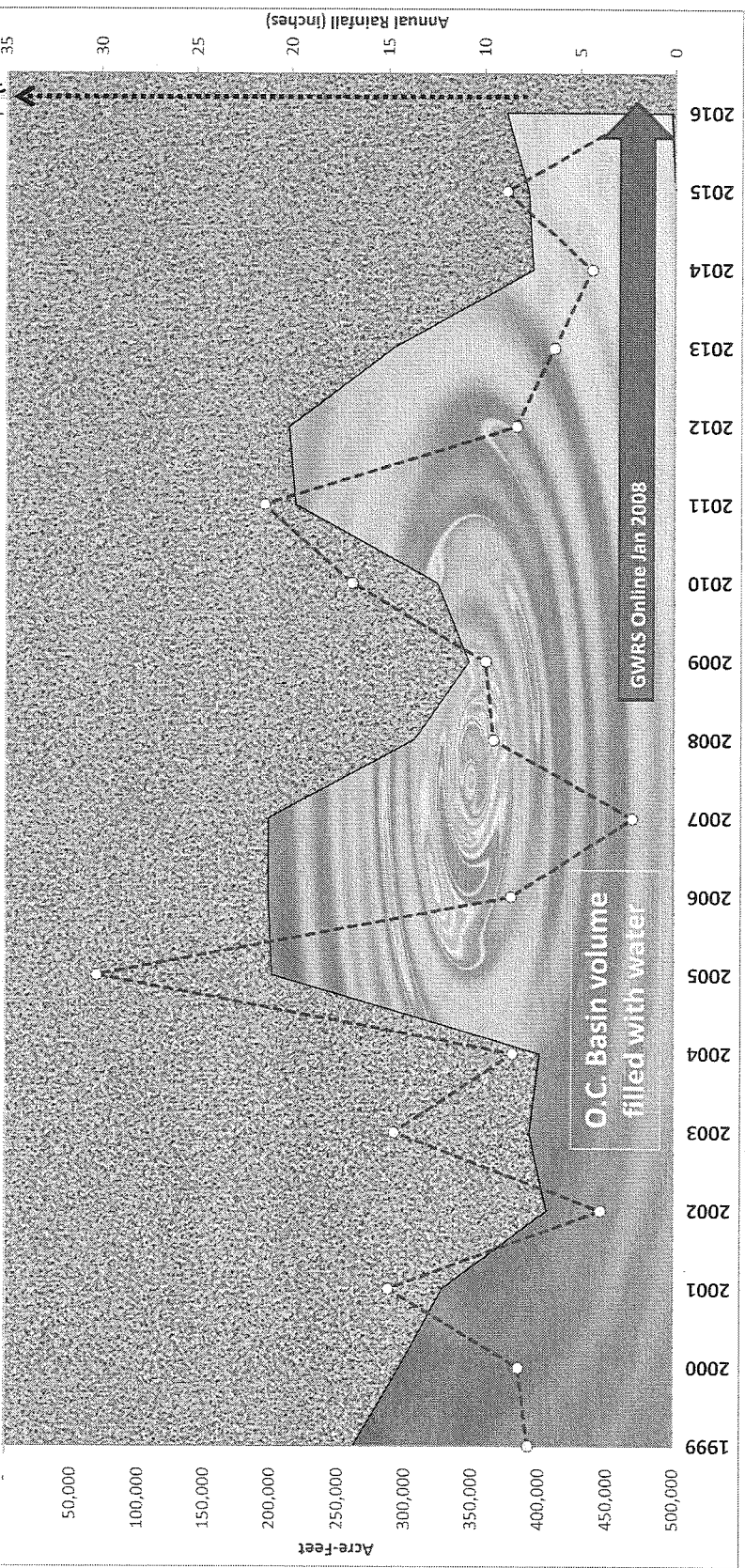

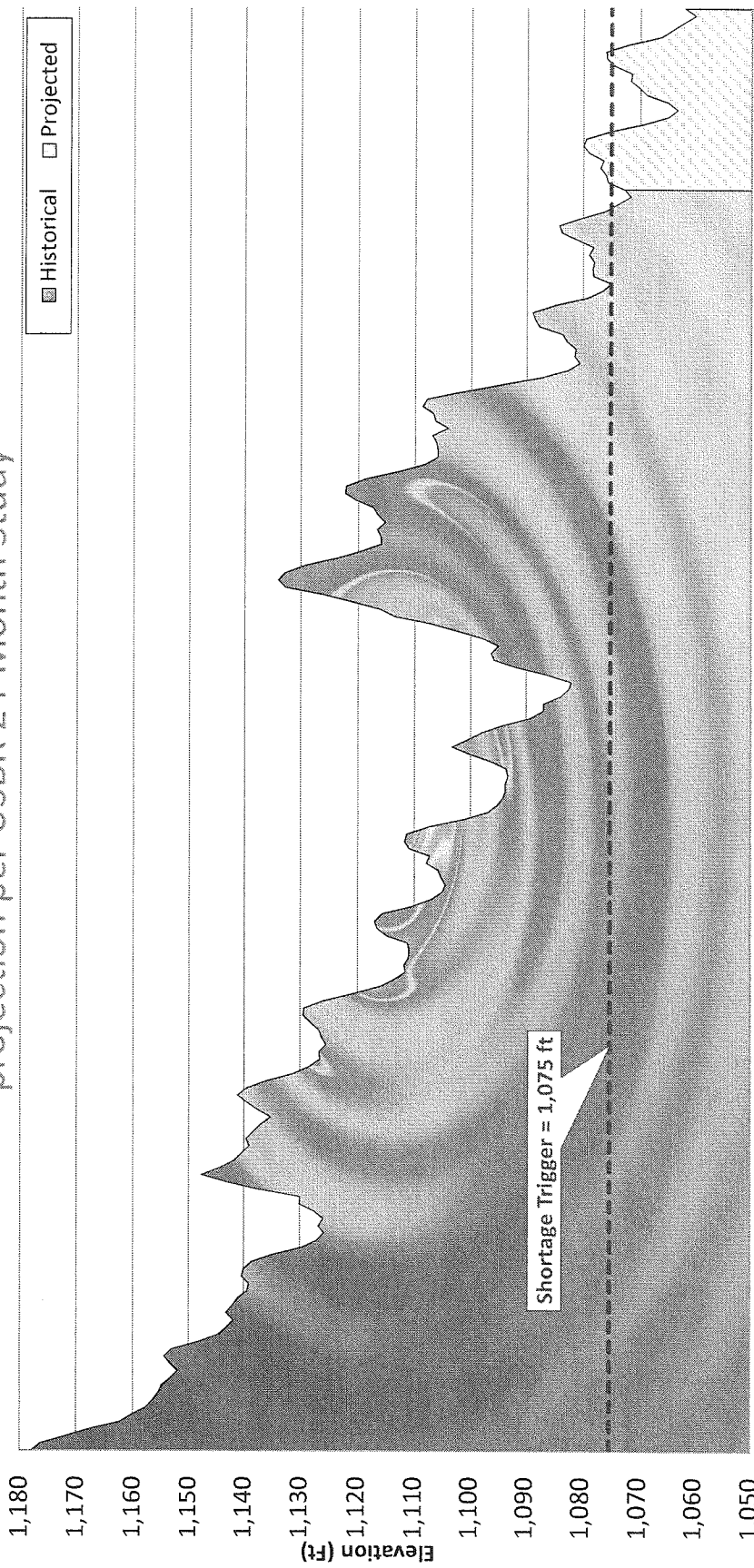

LIFE INSURANCE OPTIONS

What is Term Life Insurance?

Term Life Insurance is a policy that pays a benefit for a particular term. For the City, the term is employment. It is effective the first of the month after your hire date, and cancelled on your separation or retirement date. The City has two types of Term Life Insurance, a City paid group policy, which covers all full-time employees, and an Optional Additional Term Life Insurance policy, which is paid by the employee.

Lincoln Life Insurance - City Paid

All full-time employees are provided with a City paid life insurance policy equal to one year of your annual base salary, rounded up to the nearest thousand (\$1,000) dollars to a maximum of \$300,000. The policy also includes a policy for your spouse/domestic partner and all children of \$5,000. The policy also has an Accidentally Death and Dismemberment (AD&D) provision that provides a benefit equal to the amount of your basic life insurance should you die accidentally. However, the AD&D provision is subject to certain exclusions and limitations.

To calculate your City Paid Life Policy, take your base monthly salary, multiply by 12 and round to the nearest thousand dollars. If your gross base salary is \$3,295 you will do the calculation below:

- Example: $\$3,295 \times 12 = \$39,540$ rounded to nearest thousand means your policy is for \$40,000.

Term Life Insurance - Employee Paid (optional additional)

You may choose to pay for additional life insurance coverage for yourself, your spouse/domestic partner and/or children. Premium payments are payroll deducted bi-weekly. Below is a chart of the cost per \$1,000 of additional coverage. Premiums are based on your age and the amount of coverage you elected.

Available Coverage Amounts:

- Employee - You may elect in multiples of \$10,000 up to \$500,000 coverage for yourself, however the policy amount cannot exceed 5x your annual salary.
- Spouse/Domestic Partner - You may elect up to 50% of our annual coverage for your spouse, in multiples of \$5,000.
- Children - You may elect up to \$10,000 coverage for your child(ren)
 - Eligible children must be under 21 years of age and unmarried, or under age 25 if maintaining full-time student status.

If you terminate your employment or become ineligible for coverage, you have the option to convert all or part of the amount of coverage in force to an individual life policy on the date of termination without completing a new Evidence of Insurability. Conversion election must be made within 31 days of your date of termination.

LONG TERM DISABILITY

The City does not pay into State disability. Instead, we have self-funded plans for bargaining units. Please visit the Open Enrollment website to view your LTD benefits.

For Employee's Association & Employee's League Only

You have the option to enroll in the "buy up" plan, which reduces your waiting period from 90 days to 60 days. Make sure to read about this optional benefit and if you are interested in enrolling, do so when completing your Open Enrollment this year.

FLEXIBLE SPENDING ACCOUNT (FSA)

Regular, full-time employees are eligible to participate in the Flexible Spending Account (FSA) if they enroll within the program eligibility guidelines. This plan allows employees to reduce their cash compensation on a pre-tax basis and establish reimbursement accounts for out-of-pocket expenditures for child care and medical care expenses. Eligible expenses are then reimbursed on a non-taxed basis after they are incurred and paid by the employee. Federal law sets a number of severe restrictions on the use of this program, which include:

- Elections are made once a year and are irrevocable during the year except for certain changes in the employee's family status
- The two accounts cannot be commingled
- Any amounts not claimed during the plan year (January 1 through March 15 of the following calendar year) are forfeited by the employee
- Dependent care contributions are limited to \$5,000 annually, or \$2,500 if married and filing a separate tax return
- Health care contributions are limited to \$2,500 annually.

Employees must re-enroll in FSA accounts each year during Open Enrollment or they cannot participate.

Deadline to submit: October 7, 2016 at 4:00 p.m.

Reimbursement from Accounts

- A completed Reimbursement Request Claim Form must be submitted to Human Resources with all receipts attached.
- Funds designated in the Health Care account are available January 1 of that plan year. *(Example - If an employee designates \$260 [\$10 bi-weekly deduction from pay check] into the Health Care account and incurs expenses for \$260 January 1, he/she may submit and receive reimbursement for the full amount. The bi-weekly deduction will continue for the remainder of the calendar year.)*
- Funds designated in the Child Care account are reimbursed only as money is deposited into the account. *(Example - If an employee designates \$1,300 [\$50 bi-weekly deduction from pay check] into the Child Care account and submits receipts for \$300, he/she will be reimbursed \$50 per pay period until the balance of the receipt is zero.)*
- No checks will be issued for less than \$50, except to close an account.

DEFERRED COMPENSATION (457 PLAN)

A government 457(b) deferred compensation plan is a retirement savings plan that allows eligible employees to supplement any existing retirement and pension benefits by saving and investing before-tax dollars through a voluntary salary contribution. Contributions and any earnings on contributions are tax-deferred until money is withdrawn. Distributions are subject to ordinary income tax.

Traditional (Before-tax) and After-tax (ROTH) Contributions

The ROTH option gives you the flexibility to designate all or part of your 457 elective deferrals as ROTH contributions. ROTH contributions are made after-tax dollars.

Enrolling in Deferred Comp

If you would like to enroll in deferred comp, complete the enrollment form and return it Human Resources. You will need to make four decisions when completing the form:

- Which type of account do you want to participate in? Traditional (before-tax contributions, or ROTH (after-tax contributions).
- When do you want to start contributing? Your enrollment changes are always effective the first of the month. It does not have to be in January, you can start participating anytime.
- How do you want your account managed? Do it yourself, or enroll in the Managed Account Service (for a fee).
- Who do you want to be your beneficiary? You must have at least one primary beneficiary and will need their date of birth and social security number when completing the form.
