# 4. DISCUSSION ITEMS:

4.a. Council Chamber Renovations Update

Staff reported that phase II, renovation of the Council Chamber at the Community Meeting Center (CMC), was approved by the City Council. The project is currently out to bid, and bids are due on July 29. The goal is to award the contract at the August 9 City Council meeting, begin preconstruction in September, and complete project by the end of December assuming there are no setbacks. During construction,

City Council meetings will take place in the CMC A room and Commission meetings in the Constitution room. Renovations include: new monitors for each City Council member, making the dais and podium ADA compliant, new lighting, carpet, voting system, and seating to accommodate the new City Council and Housing Authority.

#### 4.b. Park Master Plan

Staff reported that the supplemental for this year's budget for the Park Master Plan was approved. The objectives for the Park Master Plan are to; evaluate and prioritize what the community desires for parks and facilities; to identify all funding including grants and fees; to identify trends relevant to Garden Grove; and create a maintenance priority plan. The next step is to hire a consultant through an RFQ process. Public Works will be working in conjunction with Community Services to complete the Park Master Plan by the end of Fiscal Year 16/17.

### 4.c. Parks Capital Projects

The Eastgate Park playground equipment has been ordered. Staff will go out to bid for the demolition and installation in the following week and anticipate to break ground in September.

The Garden Grove Park fitness equipment has been purchased. The project has been awarded to a contractor for the installation of the 12 piece equipment. Staff is in the process of finalizing the Agreement with the contractor and hoping to install the equipment at the end of August.

The installation of a fitness trail, set to go around the perimeter of Eastgate Park, has been delayed. There is a need to hire a landscape architect to design the trail to avoid damage to any of the rooting system or compromise any of the trees. Once staff obtains the design, it will be shared with Commissioners. Staff addressed Commissioner Soeffner's concern regarding the timeline of the project with an explanation of obstacles encountered.

Staff is in the beginning stages of the project at West Haven Park which consists of a new 2000 square foot recreation building and new playground equipment. The construction of the Fire Station will be a separate project, staff is in the process of hiring a landscape architect to help with the design of the hardscape around the fire station. The recreation building and playground will be closed during construction. Staff also reported that small improvements to the bathrooms will be made as well as adding a cover to the picnic structure.

### 4.d. Public Works Update

Staff apologized to the Commissioners for moving forward on the Spirit of '76 Mini Park without involving them. This project was in response to the Governor's action plan to cut a percentage of water usage, and displayed this by planting drought tolerant plants at the mini park. Staff extended an invitation to Commissioners to join in the re-dedication of the park on August 9 at 5:00 p.m.

Staff reported on several Public Works projects including the retrofitting of park lights with LED lighting, and overseeding at Garden Grove Park, Village Green Park, and Chapman Sports Complex.

#### 4.e. Recreation and Human Services Update

- Will begin taking donations for the Buena Clinton Youth and Family Center and the Magnolia Family Resource Center Back to School drive. This drive serves about 200-300 kids, donations will be collected through August 5.
- Senior Center day time Luau taking place on August 17 from 10:00 a.m. 12:00 p.m. Evening Luau will be on August 26 from 6:00 10:00 p.m.
- Spelling Bee at the Senior Center on September 20 from 10:00 a.m. 12:00 p.m.
- The City's 60<sup>th</sup> Anniversary event was a success. Activities included: carnival games, selfie station, GGUSD performances, mini museum, car show, bounce houses, cake cutting and happy birthday song lead by Mayor Nguyen, SOTO band, interactive workshops, and Main Street after party featuring Stone Soul band.
- Movie on Main Street featuring "Star Wars: The Force Awakens", brought in about 450 plus members of the community making it a successful event.
- Atlantis Family Campout scheduled for July 15 is sold out with 120 participants. The theme for this year's campout is Luau, there will be activities for kids, dinner, a movie, s'mores, and a continental breakfast the next morning.
- Summer Concerts at Eastgate Park will continue every Thursday through August 11.
- Movie in the Park featuring "Minions" is scheduled for August 17 at Village Green Park starting at 8:00 p.m.

### 5. MATTERS FROM COMMISSIONERS:

Commissioner Soeffner thanked staff for the improved communication. He opened up a discussion regarding the location of the Concert Series and the recommendation to have some of the concerts on the east side of Garden Grove. Staff explained the different factors that determine the location and that the final decision is made by the Concert Committee. Staff will take this recommendation to the Concert Committee.

Commissioner Montoya made a motion to open discussions with the Garden Grove Unified School District for a multi-use agreement for open space. Motion seconded by Commissioner Soeffner. Motion carried by a unanimous vote. Staff will check with City Clerk's Office to make sure there are no conflicts with the Brown Act.

Commissioner Klopfenstein inquired about the landscaping around the Community Meeting Center and the possibility of re landscaping to deter the homeless issues. Staff addressed her concern by stating that there is discussion to landscape with drought tolerant plants.

Commissioner Perez shared that she attended the Strawberry Ball and the Senior Center 4<sup>th</sup> of July luncheon and that both events were great.

Commissioner Bamini inquired about Commissioner Chung, staff explained that he moved out of state and are waiting to hear from the City Clerk's office about appointing a new commissioner. She also asked if there would be another Open Streets event. Staff replied that they had a preliminary planning meeting for a possible spring 2017 event. Commissioner Soeffner added that he attended a budget workshop and learned that there is \$60,000 in the budget for the 2017 Open Streets event.

Commissioner Soeffner asked when this Commission's final meeting would be and when the appointment of Commissioners for the next term would take place. Staff will check with the City Clerk's office and will get back to the Commission with information.

### 4. DISCUSSION ITEMS:

4.a. Council Chamber Update

Staff reported that the Council Chamber renovation is projected to be completed by the end of November. Staff identified the renovations included in the project. Chair Montoya inquired if the audience seating will be replaced, staff replied that those will remain the same due to not being in the budget.

### 4.b. Eastgate Park Fitness Trail Update

Staff distributed a rendering of the Eastgate Park Fitness Trail. The trail will be made up of decomposed granite material, will be ¼ of a mile long around the perimeter of the park, and 5 to 6 feet wide. Staff pointed out that there will be a public meeting by the end of November for the community within a ½ mile radius from the park. The goal is to bid the project and break ground in early winter.

### 4.c. West Haven Park Update

Staff reported that the Fire Station 6 and recreation building originally planned as two separate projects will now be combined as one. The new modular Recreation building will continue to be used as the Tiny Tots preschool program site. The playground equipment will be relocated north of the building. The fire station is currently undergoing environmental review, staff anticipates to go out for proposals in mid-January 2017. Commissioner Soeffner inquired on the possibility of increasing parking at that site, staff replied that 15 parking spots will be added. Staff distributed a rough rendering of the project.

### 4.d. Public Works Update

Staff reported that the West Grove building is getting upgrades to the flooring. Public Works staff are also working on some security measures at the Festival Amphitheatre as there have been a number of break-ins the last few months. Staff continues to work on the light pole issues at various parks.

Staff shared three main bullet points on a response letter to Council Member Bui regarding the donation of a monument proposed to be placed at Garden Grove Park. There will be a discussion at the next City Council meeting to direct staff to develop a policy for these type of proposals. Depending on the recommendation of the City Council, the proposal will then be presented to the Parks, Recreation and Arts Commission for review and approval. Said policy will be general and will encompass art pieces such as sculptures, monuments, murals, etc. Commissioner Soeffner pointed out that it is written in the Municipal Code that it is the responsibility and duty as Commissioners to be involved as an advisory board in developing policies concerning the parks.

Commissioner Klopfenstein stated that as a commission there is interest in having a deeper level of involvement and being more active in their roles.

Chair Montoya added that Commissioners would like to be more involved on giving input on what goes into the parks and programming. He also inquired on how the number of meetings for each Commission is determined, Commissioner Soeffner stated that it is written in the Municipal code that the Parks, Recreation and Arts Commission meets four times a year.

Several commissioners suggested offering concerts in different parks throughout Garden Grove rather than having them solely at Eastgate Park. Staff informed the Commissioners that the Garden Grove Community Foundation sponsor the concerts but commissioners are welcome to attend a meeting and present that recommendation to the board.

Chair Montoya made a motion to recommend that the City Council approve staff to open up a discussion with the Garden Grove School District for a joint use agreement regarding the use of school parking lots, specifically for City programming. The motion was seconded, and voted upon; however, the item was not on the Agenda for the meeting, therefore making the motion invalid. A Special meeting has been scheduled and the item has been added to the Agenda for further discussion and vote.

Commissioner Perez thanked the Commission Secretary for adding more detailed information to the minutes.

It was moved by Chair Montoya and seconded by Commissioner Perez to:

Recommend that the City Council approve staff to open discussions with the Garden Grove Unified School District for joint use agreements regarding school properties including parking lots for City programming.

Staff pointed out that there are six existing joint use agreements that allow the City to use school land as park space. Staff is interested in entering into this same type of agreements for the use of additional school properties.

Chair Montoya added that having access to school parking lots that are adjacent to Garden Grove parks would facilitate City programming where parking is problematic.

Commissioner Soeffner inquired on how soccer leagues and the City are currently able to use school properties. Staff explained that it is done through joint use agreements, the City is responsible for financially maintaining those. Staff is considering the possibility of using Doig Intermediate School's 20 acres of open space that is not currently being used for programming, but there are still some factors to consider such as the cost to maintain and to program before entering into an agreement.

Commissioner Bamini added that the 2016 Strawberry Festival had many parking/traffic issues and inquired on the possibility of being able to utilize the Garden Grove High School parking lot as overflow for future festivals. Staff will pass on this information to the Community Events Committee.

#### 6. MATTERS FROM STAFF:

Staff updated the Commission on the proposal submitted by Council Member Bui to bring a donated monument to Garden Grove Park. Once the design is finalized, it will be presented to the Parks, Recreation and Arts Commission, this will give the Commission an opportunity to hold community meetings to get comments on the design from the public. Staff will take a draft policy to the January Parks, Recreation and Arts Commission meeting.
