AMENDMENT TO RETAINER AGREEMENT FOR INTERIM CITY ATTORNEY SERVICES

This amendatory Agreement is made and entered into this 16th
day of June , 1992, by and between the CITY OF GARDEN
GROVE, a municipal corporation, hereinafter "CITY" and ROURKE &
WOODRUFF, a professional corporation, hereinafter the "ATTORNEYS."

RECITALS

- 1. WHEREAS, the City Council approved an Agreement for Interim City Attorney Services on May 26, 1992, with ATTORNEYS; and
- 2. WHEREAS, a typographical error is present in paragraph 8 of said Agreement with respect to the amount of deductible applicable to any claim made with respect to ATTORNEYS' errors and omissions coverage; and
- 3. WHEREAS, paragraph 8 provides for a \$25,000.00 deductible, whereas it is the intent of the parties that this provision should have provided for a \$50,000.00 deductible per claim.

NOW, THEREFORE, be it hereby resolved between CITY and ATTORNEYS that paragraph 8 of said Interim City Attorney Services Agreement be amended to read as follows:

"8. <u>Insurance</u>.

Attorneys shall maintain during the term of

this Agreement a policy of professional errors and omission liability insurance in the amount aggregate, subject \$1,000,000 \$50,000.00 deductible per claim. Not derogation of Attorneys' indemnity set forth in Paragraph 7 above, Attorneys shall maintain set forth in the coverage as insurance incorporated "Renewal attached and Certificate" Exhibit A, and provide City with an additional certificate of insurance at the expiration of the subject renewal certificate. Attorneys agree to give City 30 days' notice before the effective date of policy nonrenewal or cancellation or in the event Attorneys receive less than 30 days' notice of non-renewal insurer from its Attorneys agree to immediately cancellation. non-renewal of such or notify City cancellation."


