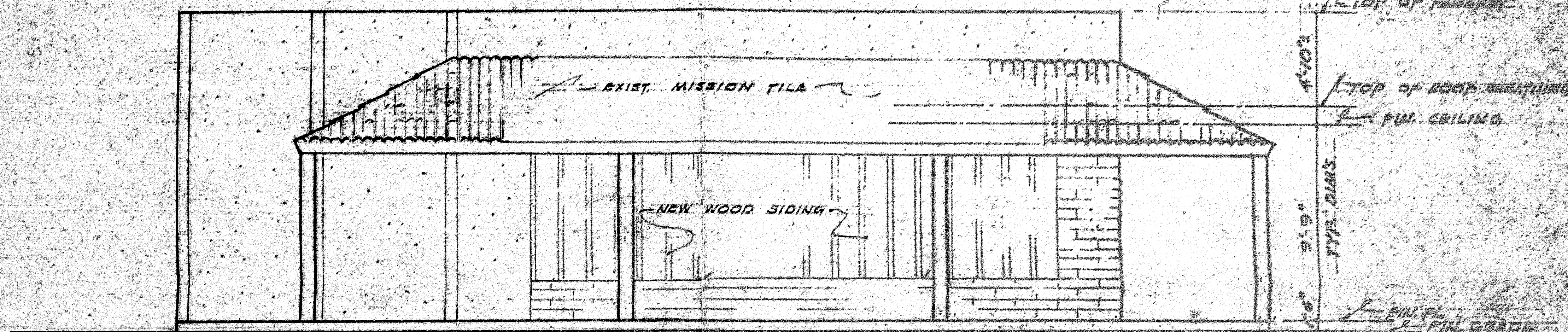
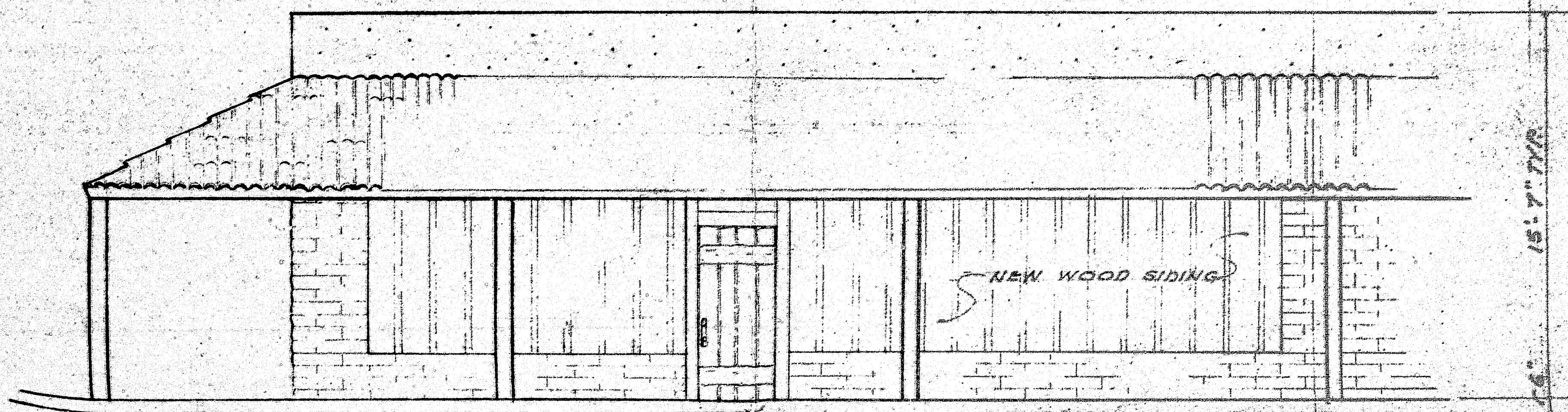

NORTH ELEVATION



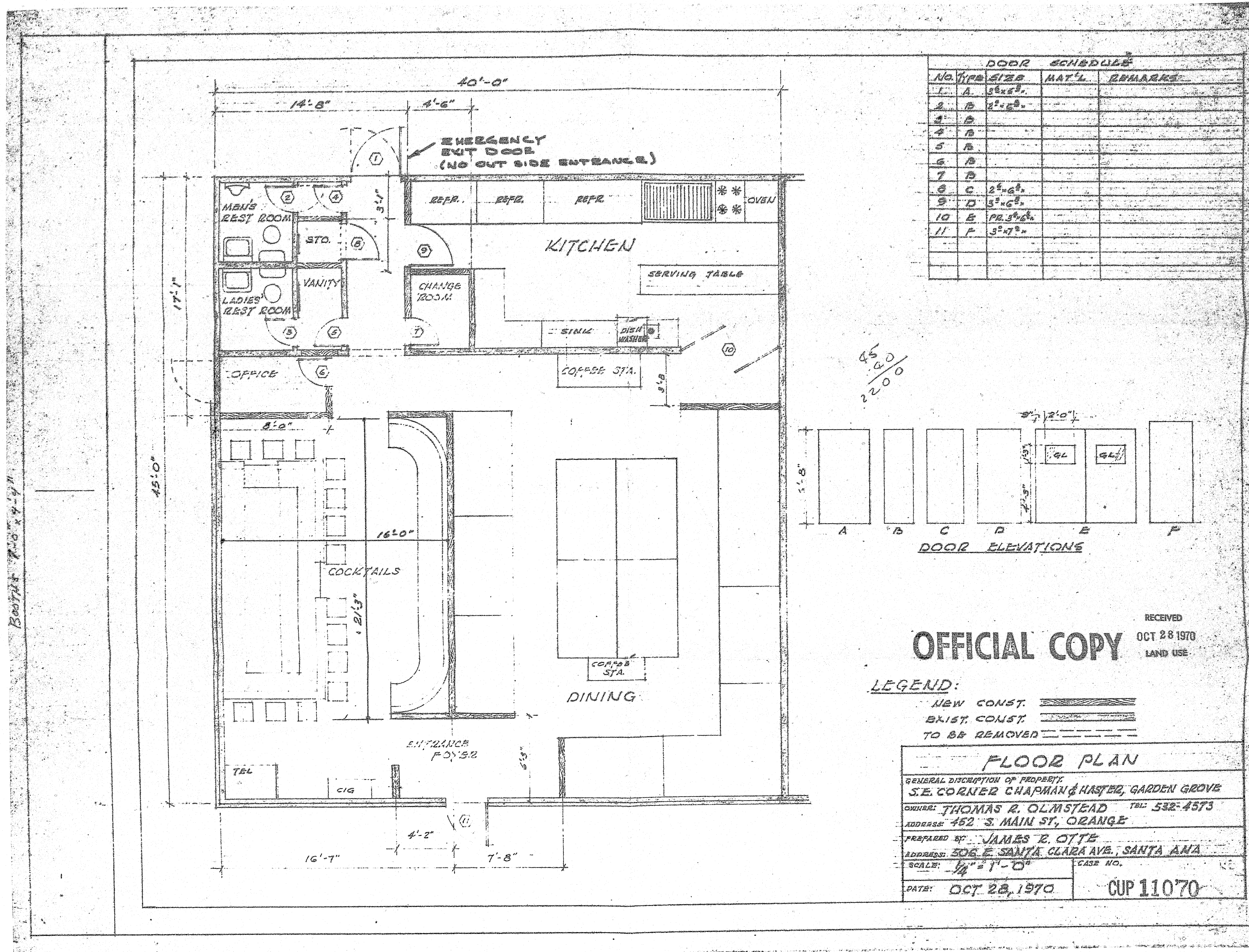

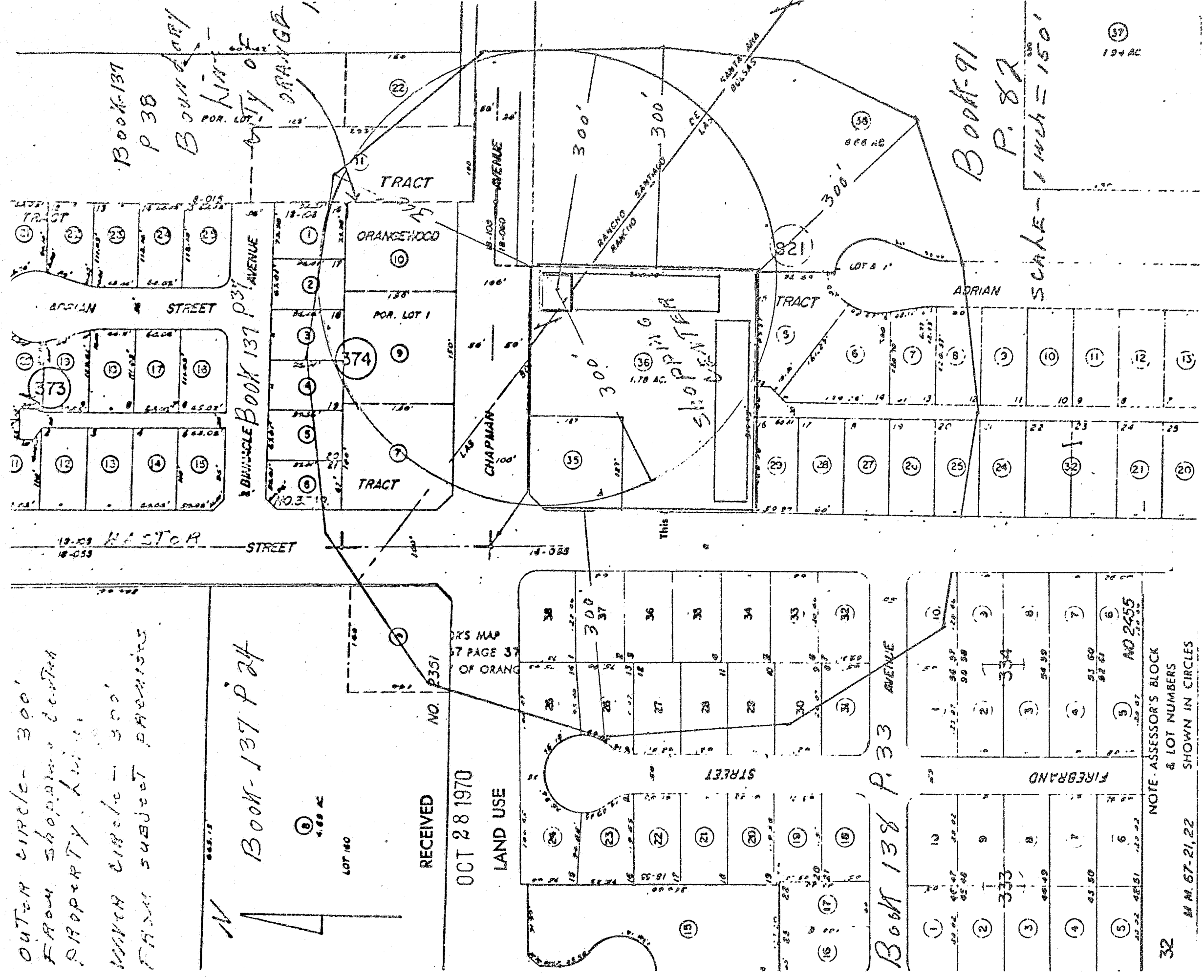
