MISC TYPE FIRE-MULTIPLE CAR FIRES

GE2 RESPONDED TO BROOKHURST ST / BIXBY AV FOR A REPORT OF A TRASH FIRE. GE2 FOUND THAT THERE WERE MULTIPLE CARS ON FIRE AS A RESULT OF A RUBBISH FIRE THAT STARTED. THE FIRE WAS LOCATED IN AN ALLEY IN BETWEEN A SMALL WALL AND A FENCE THAT IS A STORAGE FACILITY FOR HYUNDAI OF GARDEN GROVE. AS A RESULT OF THE FIRE THREE HYUNDAI CARS WERE DAMAGED. GE2 WENT INTO FIRE ATTACK AND PUT OUT THE FIRE IN A MATTER OF MINUTES. GE2 FOUND THREE CARS THAT WERE DAMAGED AS A RESULT. GE2 MADE CONTACT WITH INVESTIGATOR KUHLMAN AND EXPLAINED THE SITUATION. INVESTIGATOR KUHLMAN SAID HE WOULD FOLLOW UP ON THE MATTER. GE2 FOUND A BURNED UP UPHOLTERED CHAIR AND OTHER TRASH ITEMS WHERE THE FIRE STARTED. GE2 ALSO NOTICED A LOT OF TRANSIENT ACTIVITY IN THE AREA AND RIGHT NEXT TO THE AREA OF ORIGIN. THE THREE BRAND NEW CARS WERE AS FOLLOWS: STOCK #: 17G4152, 17G04485, 17G35011. ALL THREE CARS WERE HYUNDAI ELANTRA'S AND ALL THREE WERE RED IN COLOR. GE2 MADE CONTACT WITH ANTONIO BEREZ WHO IS A HYUNDAI OF GARDEN GROVE REPRESENTATIVE AND EXPLAINED THE SITUATION. MR. BEREZ HAD KEYS TO THE VEHICLES SO GE2 COULD MAKE SURE THAT THE FIRE WAS COMPLETELY OUT. THE CARS WERE RELEASED BACK TO MR. BEREZ ONSCENE. MR. BEREZ WAS EXPLAINED OF THE PROCESS TO OBTAIN A REPORT FROM THE FIRE DEPARTMENT AND THAT GE2 TALKED WITH THE FIRE INVESTIGATOR ABOUT THE SITUATION. GE2 WAS THEN COMPLETE.
