
The City of Garden Grove agrees to grant permission to APMS and its designated representatives to discharge a firearm within the City limits of Garden Grove under the following conditions and times:

1. APMS agrees to indemnify, defend, and hold harmless the City of Garden Grove and the County of Orange and their respective authorized officers, employees, agents, and volunteers from any and all claims, actions, losses, damages, and/or liability arising out of this agreement with the City of Garden Grove from any causes whatsoever, including the acts, errors or omissions of any person and for any costs or expenses incurred by the City of Garden Grove and the County of Orange on account of any claim therefore, except when such indemnification is prohibited by law.
2. This permit to discharge a firearm will be in effect August 15, 2016. Said permit is necessary in order for APMS to discharge its obligations to the City of Garden Grove and is granted in accordance with Garden Grove Municipal Code section 8.32.070.
3. The permit to discharge firearms will only be valid between the hours of 0001 to 0500 and is limited to the City of Garden Grove city limits.



RE: Trapping/Abatement Service Agreement between the City of Garden Grove and Animal Pest Management Services, Inc.

Dear Mr. Fox:

This letter agreement shall provide for trapper/abatement services regarding aggressive coyotes in Garden Grove neighborhoods. Animal Pest Management Services, Inc. ("APMS") shall provide coyote trapping/abatement services to the City of Garden Grove ("City") as set forth herein.

APMS shall initially work to identify coyote locations within and entry points to Garden Grove, particularly in the West Garden Grove area. APMS shall provide information learned to city staff along with any recommendations to eliminate entry points of coyotes to Garden Grove or to otherwise keep coyotes out of Garden Grove neighborhoods.

Thereafter, to the extent that APMS recommends trapping or abatement action, APMS shall, following consultation with and approval of city staff, proceed with such trapping and abatement activities. The services and compensation for this work are more specifically set forth in Attachment A hereto.

APMS shall conduct all actions and activities provided for in this agreement in accordance with all applicable federal, state and local laws.

APMS has requested that the City of Garden Grove and the Garden Grove Police Department authorize APMS to discharge firearms within the City for the sole purpose of eliminating a potential hazard (aggressive coyotes in suburban neighborhoods).

The City of Garden Grove agrees to grant permission to APMS and its designated representatives to discharge a firearm within the City limits of Garden Grove under the following conditions and times:

1. APMS agrees to indemnify, defend, and hold harmless the City of Garden Grove and the County of Orange and their respective authorized officers, employees, agents, and volunteers from any and all claims, actions, losses, damages, and/or liability arising out of this agreement with the City of Garden Grove from any causes whatsoever, including the acts, errors or omissions of any person and for any costs or expenses incurred by the City of Garden Grove and the County of Orange on account of any claim therefore, except when such indemnification is prohibited by law.
