STRUCTURE FIRE-HOUSE FIRE

INCIDENT #G1704243

GE2 RESPONDED TO 11192 RAINIER CT FOR A REPORT OF A STRUCTURE FIRE. AT6 AND AE6 WERE ONSCENE FIRST AND REPORTED A SINGLE STORY HOUSE THAT WAS FULLY INVOLVED. GE2 WAS ASSIGNED TO DIVISION ALPHA TO ASSIST AE6 WITH FIRE ATTACK. THE FIRE WAS KNOCKED DOWN WITH LARGE HOSELINES INPLACE AND GOOD VERTICLE VENTILATION. GE2 THEN PULLED HOSELINES INSIDE AND THEN WAS ABLE TO KNOCK DOWN THE REST OF THE FIRE INSIDE THE HOUSE. MULTIPLE UNITS FROM GARDEN GROVE FIRE, ANAHEIM FIRE, ORANGE CITY FIRE, AND OCFA WERE UTILIZED TO STABILIZE THE INCIDENT. ONCE THE FIRE WAS KNOCKED DOWN GE2 WAITED FOR INVESTIGATOR STROHM TO ARRIVE TO THE SCENE BEFORE OVERHAUL WAS STARTED. INVESTIGATOR STROHM FOUND IT TO BE UNDETERMINED AS THE CAUSE INITIALLY. MORE INFO WITH THE ARSON REPORT WILL BE AVAILABLE FROM INVESTIGATOR STROHM. ONCE THE INVESTIGATION WAS COMPLETED GE2 AND GT1 PERFORMED SALVAGE AND OVERHAUL OF THE ENTIRE HOUSE AS WELL AS THE BACK YARD. GE2 MADE CONTACT WITH THE PROPERTY OWNER AND HAD THEM SIGN THE RELEASE AND ASSUMPTION OF RISK OF REAL PROPERTY AFTER EMERGENCY RESPONSE FORM TO CLAIM THE PROPERTY. THE FIRE IS STILL UNDER INVESTIGATION PER INVESTIGATOR STROHM. PROPERTY DAMAGE WAS ESTIMATED AT \$500,000 AND CONTENT DAMAGE WAS ESTIMATED AT \$50,000.
