3:35 PM a?? I did not notice any unusual odors or the smell of paint as I walked towards this residence. I saw gentleman wearing an orange T-shirt and jeans was sitting on the front porch I identified myself and asked if he was Mr. Pineda he said no his name was John I asked if if I could speak with Mr. Pineda. The subject said hold on a minute let me go get him and he went inside the house. Shortly afterwards, an older gentleman came outside wearing a gray T-shirt and blue jeans he said he was Mr. Pineda I recalled having met him once before while I was out at the property for prior complaint back in September, I advised Mr. Pineda that I received an additional complaints of auto painting occurring inside his property. I asked if he would be willing to let me see the backyard and he refused. I asked several additional times simply stating I was there to either verify or nullify the complaint. Mr. Pineda said he has been documenting what has recently been going on with his neighbor. He went back inside the house and came back out holding several pieces of writing paper where he is documenting information regarding dispute with his neighbor at 10692 Paloma Ave. Mr. Pineda said this neighbor calls him vulgar names and 'hunchback', and motions to kill him as Mr. Pineda drew his index finger across the neck in a slicing motion. I said it was unfortunate that this appears to be a dispute between him and his neighbor but said I was only there to ensure that there were no violations of the City's municipal code and asked him again if he would be willing to allow me into the back yard. Mr. Pineda said no, and stated he knew this would never end and it would not end by me going into the back yard. Mr. Pineda and his friend, asked what happens now, I simply said I would continue to do follow up inspections for a reasonable period and either validate the complaint and send a notice or close the case if I could not find any evidence of a violation.
