There wasn't a police report filed for this day since he decided to work between 9:00am-12 with a two hour break so i could not make use of the court order which states he is not to make loud noise between 12 and 2. In the final picture where a tarp is missing, you can clearly see his personal vehicle which he moved into place after moving out the white car he was working on yesterday.
