Pursuant to Elections Code Section 9203, the following ballot title and summary has been prepared by this office in response to the request by the proponents of the above referenced initiative. The title and summary of the proposed initiative measure shall read as follows:

**INITIATIVE MEASURE TO BE SUBMITTED DIRECTLY
TO THE VOTERS OF THE CITY OF GARDEN GROVE**

The City Attorney of the City of Garden Grove has prepared the following title and summary of the chief purpose and points of the proposed measure:

TITLE: AN ORDINANCE OF THE PEOPLE OF THE CITY OF GARDEN GROVE, CALIFORNIA, PERMITTING AND REGULATING THE OPERATION OF MARIJUANA RETAIL, CULTIVATION, MANUFACTURING AND DISTRIBUTION BUSINESSES, AND PERMITTING PERSONAL CULTIVATION IN THE CITY.

SUMMARY:

The City of Garden Grove currently prohibits the operation of marijuana businesses and activities in the City except for limited personal cultivation pursuant to State law. The proposed initiative would lift the prohibition and would permit the operation of retail marijuana businesses in the Community Commercial (C-2) and Heavy Commercial (C-3) zones in the City. Such retail businesses

must maintain a 1,000-foot separation from other marijuana retailers, day care centers, playgrounds, or schools. Retailers may engage in offsite delivery of marijuana.

The proposed initiative would further permit commercial cultivation sites in the Limited Industrial (M-1) zones and would permit manufacturing sites in the Industrial Park (M-P) zones. Manufacturing sites are businesses that produce edible marijuana products. Marijuana distribution sites would be permitted in the Limited Industrial (M-1), Industrial Park (M-P) and Heavy Commercial (C-3) zones. Distribution sites are premises for wholesale marijuana product distribution and delivery.

Finally, in addition to the limited personal cultivation of marijuana permitted under State law, the proposed initiative would permit individuals with a doctor's recommendation to cultivate medical marijuana for personal use in up to 100 square feet of indoor space. Primary caregivers may cultivate up to 500 square feet of medical marijuana indoors for the medical use of up to five qualified patients (100 square feet per patient).
