Subject: Building Modification/Addition at 12632 Monarch St., Garden Grove

In response to your letter, dated January 17, 1973, there exists two separate water services for 12632 Monarch Street as follows:

1. An 8" fire service for the fire sprinkler system.
2. A 2" water meter for domestic water supply.

A 2" domestic water meter will supply approximately 160 gpm (21.39 cu. ft./min. = 924,800 cu. ft./month capability). You stated that you need 15,000 cu. ft./month. If you feel your needs may require a larger domestic water meter, we will be happy to inform you of the requirements.

Separately, the use of domestic water to cool hydraulic power packs and to process steam may require a back flow prevention device. Uses such as equipment cooling can represent a potential hazard to the water system via a "cross connection", therefore we will need to review a plan of your proposed plumbing modifications as well as inspect the premises. Plans and requests for inspection should be processed through this office with attention directed to a Mr. Johnson.

The Garden Grove Water Department and the Garden Grove Sanitary District are not a combined department. However, we have contacted them on your behalf and their comments are attached.
