GE2 responded to the originally given address on Aristocrat for a pole fire. While en route, the incident was upgraded to a structure fire. GE2 responded to the address, and reported smoke coming from one street over. GE5 responded to Josephine Street which was one street west of the original address.

GE5 arrived on scene, and reported smoke showing from a single story multiplex structure. GE5 updated an address of 12724 Josephine Street which was visible from the street. GE5 initiated fire attack with an apartment lay, and requested support with a second handline. GE5 found a resident attempting to extinguish with a garden hose, and ordered the resident and others to stay away. GE5 and GE7 affected fire attack, and GT1 performed vertical ventilation. GB1 upgraded the incident to a working structure fire, and later to a second alarm. Additional crews shut off utilities to the building, and Edison dropped the line to the structure. It took fire fighters approximately 30 minutes to get the fire under control. A search of the apartment did not find any people.

The fire was investigated by Captain Weiss. The cause of the fire was undetermined after investigation.

There was no reported injuries to fire fighters or residents except for one male resident who requested a bandaid for his toe. He did not ask for EMS assistance. The City building department was requested, and an inspector red-tagged the building due to power and all other utilities being shut off. A total of 11 residents out of three units were displaced, and the Red Cross was on scene to provide assistance.

The tenant of the unit involved in fire, Van Vo, signed the fire department Property Release form and instructed to follow instructions on the form and to contact her insurance company. A copy of the form was given to her, and she was advised on how to obtain a fire report.
