Garden Grove Fire Department Origin and Cause Report

Accidental Structure Fire

10622 Bolsa Ave., Apt. #3, Garden Grove

December 12, 2017, at 1801 hrs.

GGFD Incident #G1714124

At 1913 hrs. on December 12, 2017, I was dispatched to a reported structure fire located at 10622 Bolsa Avenue, Apt. #3 in the City of Garden Grove. I arrived at approximately 1930, after fire knock down. I was assisted by Fire Investigator Bill Strohm with the investigation.

The weather at the time of the fire was approximately 68 degrees with calm winds. Weather was sourced through www.wunderground.com on December 19, 2017. The weather had no effect on the fire.

The property involved was a two story apartment unit, located within a large apartment complex with extension to the attached adjacent unit to the west. The exterior is stucco with composition shingle roof. The interior is wood frame covered with drywall.

The electrical service is provided by Edison; delivered via underground. Two (2) main service meters were located on the east and west walls of the building involved. The main service meters sustained no damage due to the fire and appeared not to have been tampered with. No circuits, on the sub-panel within the unit involved, appeared to have been tripped according to first in engine companies.

The natural gas for the building and unit is supplied by Southern California Gas Company. It was unknown by the investigator whether it was turned off or not.

The domestic water service is provided by the City of Garden Grove. The water was on at the time of the fire.

Upon inspection of the apartment involved, there was one (1) smoke detector found which was located on the first floor wall. No CO detectors were found. There were no other fire extinguishing systems noted.

Heat from the fire damaged the south patio area, the southeast and southwest bedrooms located on the second floor, the dining room area, the living room area and the south section of the attic. Smoke damage was throughout the entire unit.

Four occupants of the involved unit were out of the area at the time of the fire.

There were no injuries reported at the time of the fire.

The fire was reported to dispatch by an unknown party with a T-Mobile number of



FIRE SCENE EXAMINATION

Exterior Examination

I began my exterior examination of the damaged property on the east side of the building at the main electrical service panel. I noted one (1) main service meter which sustained no damage during the course of the fire.

I made my way around to the south side of the building, which is the entrance into the involved unit, this is where I observed a majority of the exterior damage to the structure.

The west side of the building was intact with no fire or smoke damage. The address to the building (numericals only) is affixed to this side of the structure. I noted one (1) main service meter (electrical) located on the west side of the building as well. This service panel did not sustain any damage during the course of the fire and didn't appear to be tampered with.

The north side of the involved building, with attached apartment units north of involved unit, sustained no damage during the course of the fire.

The laundry facility, which is attached to the east side of the structure, sustained no damage during the course of the fire.

As I entered the involved unit I observed, as mentioned above, a majority of the exterior fire damage to the exterior south patio and the south side of the involved unit.

Interior Examination

Downstairs

Following the completion of the exterior examination, I began my interior examination starting at the front door. No unit number was visible at the front door as there is for the adjacent unit #5, east of the involved unit. The exterior security door was forced open by cutting around the lock. The front door showed signs of force as well with damage to the doorjam.

Heat and fire damage was found in the family room down to approximately waist high with melting of the sliding door frame, as well as calcification of the drywall to the wall above the sliding door and ceiling adjacent to (photo is looking south from family room towards south outdoor patio).

The dining area sustained fire damage to the top of the window frame, ceiling and smoke damage throughout the dining room.

The kitchen area sustained smoke damage.

The downstairs bathroom sustained smoke damage.

The downstairs smoke detector found on the north wall destroyed due to heat.

Per one of the occupants, Ariel Mejia, he used the south patio as storage for miscellaneous items non-operable washing machine, clothing, baby clothing, barbeque (Ariel stated BBQ just stored on patio, not allowed to use per association), satellite dish, etc. See Ariel's patio with location of items below. Ariel stated that he was out on the patio the morning prior to

the fire tidying up. Everything on the patio area was destroyed due to the fire. There was heavy damage to all wooden vertical fence posts and damage to the concrete type horizontal slats of the patio on the unit side only, with the exception of the location of the barbeque propane tank.

Upstairs

The stairs leading to the 2nd floor with smoke and water damage.

At the top of the stairs was the heater closet which had minor smoke damage to the inside. The heater appeared to have been functioning as normal prior to the fire.

The hallway linen closet with smoke and heat damage with blistering paint to the exterior of.

Water heater with smoke and slight heat damage to the inside of the closet. Water heater closet door with warping due to heat. The water heater appeared to have been functioning as normal prior to the fire.

2nd floor bathroom with smoke damage and heat damage to higher levels.

The west bedroom was found to have smoke damage throughout with heat down to shoulder level and calcification of drywall to the upper levels of the south and west walls. Attic involvement with 'alligatoring' to upper rafters. The exterior photo from the patio looking up towards the west bedroom reflects partial burning to plywood, which covers the eave area, with plywood left hanging.

The east bedroom was found to have smoke damage throughout with heat levels down to about the mattress level of the bed (about knee high). Calcification to the higher levels of the bedroom walls with extreme calcification to drywall in the attic area. Rafters with 'alligatoring' with some rafters completely burned through and missing. The exterior photo from the patio looking up towards the east bedroom reflects the plywood covering the eave area completely burned and missing. A dig-out of the southwest and southeast corners of the east bedroom found no cause of fire due to electrical issues.

Interviews

The involved unit had a total of four occupants:

his wife the process of the most occupied the west bedroom and their occupied the west bedroom and occupied the east bedroom.

An interview with determined that no one was home at the time of the fire. She stated that they left for the Bella Terra Mall in Huntington Beach around 1640 earlier that day. She stated that no one smokes in the household and that they have no 'riffs' with anyone further stating that she doesn't know of anyone that may have started the fire. She also stated that they do have renters insurance (USAA). Ariel adding that they just moved into this unit from another unit in the complex (10652 Bolsa Ave., Apt. #9) and forgot to transfer the insurance to the new unit. All

property within the residence is owned free and clear. She stated that there were no laptops or iPads plugged in charging. She did state that there was a glade plug-in deodorizer plugged in

downstairs to the left of the TV; not found during interior examination. Lizett stated that there were no candles burning in the household.

An interview with Ariel determined that earlier that day he was tidying up the patio area. When asked if he used the barbeque, he stated no. When asked if he started the barbeque to clean the grill he stated no. He did state that he believes that the propane tank was half full. The valve on the propane tank was found to be completely open. Ariel also stated that the west bedroom window was left open and that the AC unit in that room is always plugged in. Ariel was asked to draw a sketch of the patio area and to note where items were located (sketch located below).

An interview with Martha, whom is non-english speaking (Ariel used to translate), stated that her east bedroom window was left open. She also stated that she plugs all electrical items into a power strip in her bedroom. She stated that every time she leaves the residence she unplugs the power strip from the wall. When asked why she does that, she stated that it's due to the 1½ year old that lives in the household. Upon the dig-out of the east bedroom it was found that the power strip was plugged into the west wall of the east bedroom, although not a factor in the cause of the fire. Martha stated that the AC unit in the east bedroom was unplugged which after dig-out was undetermined whether it was or not. Martha, whom was with Ariel and Lizett at the Bella Terra Mall, stated that she was notified of the fire by Ana Zuluga whom lives at 10632 Bolsa Ave., Apt #8 (within the same apartment complex).

EXAMINATION OF POTENTIAL IGNITION SOURCES

Structures electrical system: Non-contributing to the fire.

Electronics: Non-contributing to the fire.

Smoking material: Non-contributing to the fire.

Candles (open flame devices): Occupants state that there were no candles or open flames. Nothing of the such was found near the area of origin.

Spontaneous combustion: The elements necessary for spontaneous combustion were not found in the area of origin.

Incendiary: Incendiary devices were not used as the cause of the fire.

Natural gas appliances and distribution system: The propane barbeque on the west wall of the south patio was within the area of origin and appeared to have been the possible source of ignition. Ariel stated that the propane tank valve was closed, when in fact it was found by the investigators to be completely open. The horizontal portion of the perimeter fencing around the patio is made of a concrete type of material which had scorching and degradation on the opposite side of the fence opposite of where the propane tank was located. No other exterior part of the perimeter fencing had smoke or fire damage to it. Metal items in the immediate area of the barbeque, such as the satellite dish and the metal rack shelving appeared to have high-

temperature oxidation (rusting). The first in engine company size-up did report (paraphrasing) 'fire in the patio area extending up into the second floor living area'.

Combustible materials near the heat source: Multiple combustible materials were stored in the vicinity of the barbeque, in particular the propane tank, on the south patio area.

Ignition Source/Material First Ignited/Fire Development: It was determined that the barbeque was turned on and left unattended contributing to the ignition of surrounding combustible materials. This causing a possible breach in the propane tank feeder line adding to the growth and development of the fire with a high fire load on the patio, ultimately extending to the second floor open windows.

Area of Origin: The fire appeared to have originated on the exterior south patio along the west perimeter wall where the barbeque/propane tank was stored.

CONCLUSION

Based on the examination of the fire scene, statements made by fire personnel and interviews taken from the involved unit occupants, it is the conclusion of this fire investigator (Breneman), as well as Investigator Strohm, that this fire is ruled *accidental*. This conclusion is based on the most probable cause which was an unspecified failure of an unattended barbeque.


















