GE2 ARRIVED AS 3RD IN ENGINE OF A RESIDENTIAL STRUCTURE FIRE. GE2 WAS ASSIGNED TO ASSIST VENT GROUP WITH AN ADDITIONAL LINE ALOFT. VENT GROUP WITH ADEQUATE MANPOWER. IC ADVISED. GE2 WAS REASSIGNED TO ASSIST INTERIOR WITH SALVAGE. INTERIOR ALSO WITH ADEQUATE RESOURCES. IC ADVISED. GE2 WAS RELEASED FROM THE SCENE. GE2 COMPLETED.

GE6 RESPONDED TO A SINGLE STORY HOUSE WITH REPORTS OF A POSSIBLE CHIMNEY FIRE. UPON ARRIVAL, LIGHT TO MODERATE SMOKE WAS SEEN FROM THE TOP OF THE CHIMNEY AND TO THE REAR OF THE RESIDENCE. GE6 INVESTIGATED AND SAW SMOKE AND SMALL FLAMES SEEN AT THE TOP OF THE CHIMNEY. GE6 INITIATED FIRE ATTACK WITH A PRE-CONNECT AND UTILIZED GT1 FOR VERTICAL VENTILATION AND TO CHECK TO SEE IF WE HAD EXTENSION TO THE VOID SPACE IN THE ROOF RAFTERS. AFTER GT1 OPENED UP THE ROOF, SOME FIRE WAS SEEN IN THE VOID SPACE AND IN THE SPACE SURROUNDING THE CHIMNEY FLUE. THE STUCCO AROUND THE CHIMNEY WAS OPENED UP USING A ROTARY SAW AND FIRE WAS VISIBLE IN THE VOID SPACE. FIRE ATTACK WAS INITIATED ON THE ROOF TO CONTAIN THE AND EXTINGUISH THE FIRE IN THE VOID SPACE SURROUNDING THE CHIMNEY FLUE. AFTER EXTINGUISHMENT WAS OBTAINED, THE ENTIRE WAS AREA WAS COOLED DOWN WITH WATER AND FOAM. CAPTAIN ACOSTA CONSULTED WITH THE HOMEOWNER AND RELEASE OF LIABILITY FORM WAS SIGNED. HOMEOWNER WAS INSTRUCTED TO NOT INHABIT THE HOUSE UNTIL BUILDING DEPT DEEMED IT SAFE TO RE-ENTER.
