Narrative:

GE4 GB1 CE65 GE5 CT64 RESPONDED TO STRUCTURE FIRE RESIDENTIAL. GE4 ARRIVED ON SCENE OF A 2 STORY APARTMENT COMPLEX WITH A WORKING FIRE SHOWING FROM A LOWER UNIT. GE4 WENT INTO ATTACK MODE, INITIATED A PRIMARY SEARCH, WAS ABLE TO SECURE ITS OWN WATER SUPPLY, ASSIGNED SECOND DUE TO TAKE COMMAND AND BALANCED THE RESPONSE TO A SECOND ALARM. WE USED A PRECONNECT LINE TO CONFINE AND EXTINGUISH THE FIRE. GE4 WAS ASSIGNED INTERIOR AND WAS ABLE TO REMOVE 2 CATS FROM THE PREMISE DURING THE PRIMARY SEARCH. SECONDARY SEARCH WAS ALL CLEAR. EXTERIOR AND INTERIOR WALLS WERE EXPOSED TO CHECK FOR EXTENSION WHICH WAS NEGATIVE. OVERHAUL AND INVESTIGATION WAS PERFORMED IN CONJUNCTION WITH GT1 AND WILL PROVIDE A REPORT ON FINDINGS. ELECTRICITY TO THE INVOLVED UNIT WAS ISOLATED AND SHUT OFF. THE INVOLVED UNITS OCCUPANTS WERE DISPLACED, 3 OTHER REMAINING UNITS WERE ALLOWED TO OCCUPY THEIR RESIDENCES AFTER THE INCIDENT. BUILDING OWNER WAS ON SCENE, WAS GIVEN AND SIGNED THE PROPERTY RELEASE. GE4 AWAITED RED CROSS ARRIVAL AND RELEASED THE BUILDING BACK TO THE PROPERTY OWNER AND OCCUPANTS. GE4 COMPLETE.

GB1 TRANSFERRED COMMAND FROM GE5 CAPT A.ACOSTA WHO HAD ASSIGNED 1ST ALARM UNITS. CAPT ACOSTA WAS ASSIGNED SAFETY, DID 360 OF SCENE AND REPORTED BACK. GT1 WAS ASSIGNED TO VENT GROUP (CT64) TO ASSIST W/HORIZONTAL VENT ON AFFECTED UNITS. FIRE WAS KNOCKED DOWN, PRIMARY AND SECONDARY WERE COMPLETED IN ALL UNITS.
