AMENDMENT NO. 5

Building and Planning Contractual Services

This Amendment No. 5 to furnish **Building and Planning Contractual Services** is made and entered into this 2 day of March, by and between the **CITY OF GARDEN GROVE**, hereinafter referred to as "CITY", and **CSG Consultants, Inc.**, hereinafter referred to as "CONTRACTOR".

WHEREAS, CONTRACTOR and CITY entered into Contract No.153048, dated **July 8, 2014** for Building and Planning Contractual Services (the "Existing Contract").

WHEREAS, the Existing Contract provides for annual extensions, one year at a time, not to exceed a total performance period of 4 years, through 2018, and not to exceed \$250,000 per year.

WHEREAS, CONTRACTOR and CITY desire to amend the Existing Contract as provided herein.

Now, therefore, it is mutually agreed, by and between the parties as follows:

Section 1.0, TERM AND TERMINATION of the Existing Contract, shall be amended as follows:

This Amendment No. 5 hereby extends the performance period to cover billing paid from January 1, 2018 through December 31, 2018.

Section 3.0., COMPENSATION - shall be amended as follows:

Contractor shall be compensated in accordance with the hourly rates as set forth in Exhibit C to Contract No. **153048**. The contract price is \$10,000.00 to cover plan Building and Planning Contractual Services for the term of this Amendment No. 5. In no event shall the total compensation for the extended performance period exceed the total amount of **\$10,000.00**.

Except as expressly amended hereby, all of the terms and conditions in the Existing Contract remain in full force and effect as originally executed.

IN WITNESS WHEREOF, the parties have caused this Amendment No. **5** to the Existing Contract to be executed by their respective officers duly authorized on the date first written above.
