GROVE ENGINE 7 WAS DISPATCHED ON A MEDICAL CALL FOR A REPORTED BURN INJURY. ON ARRIVAL GE7 FOUND 2 PATIENTS THAT WERE SUFFERING FROM BURN INJURIES CAUSED BY THE USE OF GASOLINE AND GOO GONE AS A CLEANING AGENT INSIDE A SMALL KITCHEN AREA. THE GASOLINE VAPORS REACHED THE PILOT LIGHT AND IGNITED. A MALE PATIENT IN HIS 50担 WAS FOUND LYING IN HIS LIVING ROOM WITH APPROXIMATELY 70% OF HIS BODY COVERED WITH 2ND AND 3RD DEGREE BURNS. THE MAIN AREAS OF BURN DAMAGE WAS FOUND ON HIS ARMS AND LEGS. THE PATIENT ALSO HAD REDNESS AND SINGED HAIR TO HIS NOSTRILS AND HAIR ON HIS HEAD. HE WAS IMMEDIATELY TREATED BY GE7 AND FVE31 PARAMEDICS WITH BURN DRESSING AND PAIN MANAGEMENT. THE PATIENT WAS TRANSPORTED WITH FV PARMEDICS TO UCI MEDICAL CENTER AS A TRAUMA BURN PATIENT. A SECOND FEMALE PATIENT WAS FOUND WITH FIRST AND POSSIBLY 2ND DEGREE BURNS TO HER FEET. SHE ALSO HAD REDNESS TO HER RIGHT ARM AND TO THE RIGHT SIDE OF HER FACE. THE PATIENT PRESENTED WITH SINGED NOSTRIL AND SINGED HAIR TO HER HEAD. DO TO THE POSSIBILITY OF RESPIRATORY DAMAGE SHE WAS TRANSPORTED WITH GM1 PARAMEDICS TO UCI MEDICAL CENTER AS A TRAUMA BURN PATIENT.
