Structure fire commercial

ge7 and first alarm units responded to single story commercial strip for structure fire. Upon arrival ge7 found pressurized smoke coming from roof vents. ge7 initiated fire attack with preconnect through front door. Fire located in kitchen area of business being held in check by sprinkler system. primary and secondary searches performed while 1st alarm units assisted with checking for extension, ventilation, salvage, and overhaul. After investigation fire appears to have started in or around oven area in kitchen with main body of fire initially found coming from that location. Fire cause is listed as undetermined and appears to be accidental in nature. Owner representative (Huy Trieu Manager telephone number 626 945 5739) on scene advised that sprinkler system shut down to property due to fused sprinkler heads in kitchen area with recommended 24 hour fire watch posted until sprinkler system evaluated by qualified technician. Additionally manager advised electrical shut down at panels servicing building. release and assumption of real property after emergency response signed by owner representative Huy Trieu. oc health dept on scene contact (laura albright 714 824 1686) and ocean blue contact( Daniel Gaeta (562 533 4986) for clean up. Area scanned via thermal imager prior to clear time with no evidence of any heat signatures
