AFTER INVESTIGATION, CAUSE OF FIRE WAS DETERMINED ACCIDENTAL/UNKNOWN WITHOUT BEING ABLE TO RULE OUT ELECTRICAL MALFUNCTION DUE TO UNPERMITTED ELECTRICAL WIRING AND APPLIANCE CONNECTIONS IN AND ON THE EXTERIOR OF THE STRUCTURE. FIRE APPEARED TO START ON EXTERIOR PORCH AREA OF BUILDING SPREADING TO INTERIOR KITCHEN . OWNER WAS NOTIFIED BY PHONE AND OCCUPANT SIGNED PROPERTY RELEASE PER GE22. S.C.E. AND GAS CO.
